# The Episcopate in East Tennessee

### William Evan Sanders, D.D.

Born December 25, 1919, Natchez, Mississippi. Ordained by Bishop Maxon: Deacon 1945, Priest 1946. Consecrated as Bishop Coadjutor of Tennessee, 586th in American Succession, in Memphis, April 4, 1962; chief consecrator, Presiding Bishop Arthur Carl Lichtenberger. Eighth Bishop of the Diocese of Tennessee, January 10, 1977. Chose to remain with the Diocese of East Tennessee as First Bishop, January 1, 1985. Retired December 31, 1991.

#### Robert Gould Tharp, D.D., D.C.L.

Born October 25, 1928, Orlando, Florida. Ordained Deacon 1956 by Bishop Louttit, Priest 1957 by Bishop Moses. Elected Bishop Coadjutor of East Tennessee, November 17, 1990. Consecrated as Bishop Coadjutor of East Tennessee, 867th in American Succession, in Knoxville, May 4, 1991. Installed as Second Bishop of East Tennessee on December 7, 1991, at St. John's Cathedral, Knoxville. Retired February 28, 1999. Deceased May 30, 2003.

#### Charles Glenn vonRosenberg, D.D.

Born July 11, 1947, in Fayetteville, North Carolina. Ordained by Bishop Elebash; Deacon in 1974 and Priest in 1975. Elected Bishop of East Tennessee, October 17, 1998. Consecrated and ordained as the Third Bishop of East Tennessee, 944th in American Succession, in Knoxville, February 27, 1999, and installed at St. John's Cathedral, Knoxville, February 28, 1999. Retired.

#### George Dibrell Young, III, D.D.

Born September 28, 1955, in Jacksonville, Florida. Ordained by Bishop Cerveny; Deacon in 1990 and Priest in 1990. Elected Bishop of East Tennessee, February 11, 2011. Consecrated and ordained as the Fourth Bishop of East Tennessee, 1,059th in American Succession, in Knoxville, June 26, 2011, and installed at St. John's Cathedral, Knoxville, June 27, 2011.

# Friday, February 8, 2013 Opening Session

## Call to Order

Gathering at the Marriott Hotel, Knoxville, Tennessee, on Friday, February 8, 2013, at 11:05 a.m., the Rev. Hendree Harrison gave directions for the opening worship of convention, representing the 1st Mark of Mission (*To proclaim the Good News of the Kingdom*). The Rev. Chris Harpster read from the Gospel, the Rev. Maggie Zeller led the singing of the opening hymn, and then representatives from the various parishes and ministries of the diocese processed in with banners and with a candle representing the 1st Mark of Mission – the first of five Mark of Mission candles placed in view of attendees during the convention. Then the Right Reverend George D. Young, III, bishop of the Diocese of East Tennessee, called the 29th annual convention of the Diocese of East Tennessee to order.

# **Report of the Committee on Credentials – Quorum**

Bishop Young called on the Chair of the Credentials Committee, Mr. Chris Cone, who reported those registered: 65 clergy, 120 lay delegates, 35 alternates, and 77 others for a total of 297 in attendance. In accordance with Article V of the Constitution, there was a quorum present for the transaction of business.

# **Election of Officers**

Bishop Young then placed into nomination names for the election of officers, asking that they be elected by acclamation: Secretary, the Rev. Canon Stephen Askew; Assistant Secretary, Laura Nichols; Treasurer, Bill Selden; Assistant Treasurer, Merry Keyser; Chancellor, Sarah Sheppeard, Esq.; Vice Chancellors, Chris Cone, Esq., Thomas Peters, Esq., the Hon. Neil Thomas and the Hon. Marie Williams; and Registrar, Ms. Mary Berl. No other nominations were made. The question was called.

#### All nominees were accepted by acclamation

## Appointment of Parliamentarians

Bishop Young then appointed Mr. Thomas Peters as Parliamentarian and Ms. Sarah Sheppeard as Assistant Parliamentarian.

# Adoption of Rules of Order and Order of Business

The Bishop called on Parliamentarian Peters, who moved that the Rules of Order and the Order of Business as found in the convention booklet be adopted by the 29th annual convention of the Diocese of East Tennessee. The motion was seconded and the question was called.

Motion carried Rules of Order adopted

## **Resolution of Invitation**

Bishop Young called on the Rev. Peter Keese, who moved for the adoption of the following Resolutions of Invitation:

**RESOLVED**, that all ordained ministers of this church who are not canonically resident in this diocese, but who officiate under license and who are in charge of congregations in the diocese, be given seat and voice in the deliberations of this 29th Convention of the Diocese of East Tennessee; and

**RESOLVED**, that all ordained ministers of this church present in this city of Knoxville during the sessions of the convention, all postulants and candidates for holy orders in the diocese, and all ordained ministers of other communions present in Knoxville, be cordially invited to seats upon the floor of convention.

The motions were seconded and the question was called.

Motions carried Resolutions was adopted

The Rev. Peter Keese also moved the adoption of the following resolution:

Resolved, that Worshiping Communities of this Diocese have voice and seat at the 29th annual convention of the Episcopal Diocese of East Tennessee in keeping with the historical precedent of recognizing their value and status while the Diocese continues to explore the optimum circumstances under which to afford them voice, seat and vote on the convention floor.

The motion was seconded and the question was called.

Motion carried Resolution was adopted

Before continuing with business, Bishop Young made a couple of announcements. First, there is wifi available for fifty people at a time. Also, those who are on the agenda to speak please report to Renee Haralson before speaking for direction to the microphone.

# **Bishop's Address**

Bishop George Young invited the Rev. Peter Keese, President of the Standing Committee, to take the chair of the convention while he gave his annual address to the convention. (The full address is included in Section 4 of this Journal.)

# The Rev. Eric Law

Eric Law addressed convention following Bishop Young's address. He began by inviting convention participants to sing. He shared that much of his ministry is about seeing what doesn't work and trying to find a solution. For example, there is a need for the church to be more missional and sustainable. We achieve this by making connections between what are our gifts and what are the needs in our communities. It is about building relationships in the communities in which we live. *Holy Currencies* is the title of Eric's book and the theme of what he will share during convention.

# Announcements and Recess for Lunch

The bishop called on Canon Stephen Askew to make announcements regarding the procedures for lunch. Canon Askew also encouraged delegates and visitors to spend time at the exhibits and photo competition. The bishop called convention into recess.

# Friday, February 8, 2013 Afternoon Session

Convention was reconvened by Bishop Young at 1:20 p.m., on Friday, February 8.

# **Report of the Committee on Credentials – Quorum**

Bishop Young called on Mr. Chris Cone, who reported on behalf of the Credentials Committee those registered: 71 clergy, 128 lay delegates, for a total of 199 delegates; 40 alternates and 88 others, for a grand total of 327 in attendance. In accordance with Article V of the Constitution, there was a quorum present for the transaction of business.

# 2<sup>nd</sup> Mark of Mission

A video on Southside Abbey was shown representing the 2nd Mark of Mission (*To teach, baptize, and nurture new believers*). Afterwards, the Rev. Bob Leopold, missioner of Southside Abbey, spoke describing the various ministries of Southside Abbey. He then lit the second candle for mission and closed with a prayer.

Bishop Young presented the Rev. Leopold with the first annual "Plunge Award" for *the* practice of intentional relationship development with diverse neighbors through relying on their hospitality (Dwight Zscheile).

# Treasurer's Report

The new treasurer of the diocese, Mr. Bill Selden, was called on by the bishop for the treasurer's report. Mr. Selden called attention to the packets in the convention booklets regarding finances. He pointed out the budget report for 2012 and the surplus of \$61,000 that will be placed in the emergency fund. He gave explanation of the other reports in the packets. Mr. Selden then moved the adoption of Resolution 1, which gives approval for modifications made by Bishop and Council in the budget during the course of the year. There being no discussion, the question was called to adopt Resolution 1.

## Text of Resolution #1

WHEREAS, by its action the Twenty-Eighth Annual Convention of The Diocese of East Tennessee convened in Knoxville on Friday, February 10, 2012 and approved a budget for The Diocese; and

WHEREAS, in the wisdom of the Bishop and Council, certain items of the Budget were exceeded but the total expenditures were less than the budgeted total; and

WHEREAS, by Canon 2, Sec. 2 (a), it is necessary for the Convention to approve budgets; and

WHEREAS, the budget as approved in its February 2012 Convention was \$1,679,615 and

WHEREAS, the actual disbursements were \$1,678,677; and

WHEREAS, additional funds and disbursements of \$30,753 were approved from the Mission Growth Fund; and

WHEREAS, the Treasurer's Financial Statements reflect all detailed records of disbursements over and under the budget recited herein by reference, reflect the best judgment and good offices of the Bishop and Council and Treasurer in performing under said budget;

NOW THEREFORE BE IT RESOLVED, that all of the acts and actions of the Bishop and Council in authorizing disbursements in excess of line items in the 2012 budget as approved by their various actions during 2012, be and are hereby ratified by this Convention as authorized and approved.

> Motion carried Resolution 1 adopted

Mr. Selden then pointed out the proposed budget for 2013. There being additional funds pledged to the diocese since the budget was drafted, decisions will need to be made as to how to disburse these funds. Mr. Selden invited those interested to attend the Budget Hearing to be held at 5:00 p.m. to give input on the proposed budget.

# Reports of the Officers, Boards, Commissions, Committees

## Registrar

Bishop Young began by stating that the Registrar, Ms. Mary Berl, has no report.

# **Standing Committee**

The President of the Standing Committee, the Rev. Peter Keese, was called on by the bishop. He related the work carried out by the Standing Committee. The three primary responsibilities of the Standing Committee are to approve candidates for ordination, to consent to the consecration of bishops, and approve the buying and selling of property. The Rev. Keese highlighted the approvals given in 2012. (The full report can be found in Section 6 of the Journal)

The Rev. Peter Keese then read out loud Resolution 2 and moved that it be adopted. No further discussion was offered. The bishop called for the question.

## **Text of Resolution 2**

<u>RESOLVED</u>, That all actions of the Standing Committee taken under the provisions of Title III, Canon 1 (Real and Personal Property) and reported to this convention affecting title to and property of the Diocese of East Tennessee or its constituent congregations be approved and ratified and made the action of this 29<sup>th</sup> Convention of the Diocese of East Tennessee.

**EXPLANATION OF RESOLUTION:** These property-related actions have been approved by the Standing Committee since the last convention and require the action of this convention for final ratification.

## Motion carried Resolution 2 adopted

The Rev. Keese stated that the one other responsibility of the Standing Committee is to meet with and advise the bishop. In the absence of a bishop, the Standing Committee serves as the ecclesiastical authority of the diocese. He then thanked and introduced the other members of the Standing Committee and invited them to stand.

# **Commission on Ministry**

Bishop Young called on the Rev. Hendree Harrison, Chair of the Commission on Ministry. He introduced the word "mystery," which means endlessly understandable, and went on to speak about discernment, the primary task of the Commission on Ministry. He concluded by introducing the members of the Commission. (The full report can be found in Section 6 of the Journal)

# **Constitution and Canons Committee**

Bishop Young called on the chair of the Constitution and Canons Committee, the Hon. Marie Williams. The Hon. Williams referred everyone to resolutions 3 & 4, which address the way parish leadership (the vestry) is selected. There have been issues in some parishes around getting candidates to agree to be nominated or getting new nominees. These resolutions offer amendments to our canons so that parishes may find a way to select, rather than simply elect, vestry members. They would also permit parishes, through their bylaws, to enable vestry members to serve consecutive terms of office. The Hon. Williams invited those who are interested to attend the hearing on Constitution and Canons at 5:00 p.m.

# Ministry and Congregational Development

Mr. Rick Govan was asked by the bishop to report. Mr. Govan corrected information on the date of the next Eucharistic Visitor Preparation Workshop, to be held on Saturday, February 23. He also noted that both the Shared Ministry Notebook and Licensed Ministry Notebook are revised and on the diocesan web site. He thanked Ms. Vikki Myers for her help. Mr. Govan shared that there is exciting work going on in parishes and worshiping communities in the areas of leadership development, lay ministry development, and congregational redevelopment. The goal is to focus on the discernment of gifts among parishioners that match the needs for ministry and provide training for such ministry. Some parishes now understand the need to ask what God is seeking them to become and be open to change. There is a growing need for parish revitalization. Mr. Govan stated that he is in his eleventh year of serving the diocese in developing lay ministry and congregational development and gave thanks for this opportunity. (The full report can be found in Section 6 of the Journal)

# Youth Ministry

Next, Bishop Young called on Mr. Alex Haralson to report on the area of diocesan youth ministry. The bishop gave thanks to Alex for the videos he has helped create, including the one for Southside Abbey that was shown earlier. Mr. Haralson invited members of the youth delegation to come forward and speak to the question of the one thing that diocesan youth ministry has done to develop,

inspire, to change or shape them in the church. Lora Doherty spoke about community. Tyler Kearly mentioned that youth ministry has given him a place to get away from stress. Rebecca Brewer said that youth ministry is all about friendships and the memories made with friends. Jack Wiggers shared that diocesan events are a way to make new friends which he always looks forward to seeing again. Alex Haralson concluded by saying that hospitality is a primary focus of youth ministry, and, the one goal in the youth programs is for the young people to be equipped to know without a doubt that what they have seen and experienced is no less than the face of Jesus. He thanked everyone for their support and involvement. He invited everyone to come be a part of the youth community. He ended with a prayer from the Iona Community.

Bishop Young encouraged parish priests to make sure their youth attend diocesan activities, Happening Program, and summer camp.

The bishop next apologized for omitting the introduction of the clergy who are new to the diocese. He then introduced the Rev. Brad Jones, executive director of Grace Point, the Rev. Chris Hackett, on staff at St. John's Cathedral, the Rev. Josh Hill, chaplain at the Episcopal School of Knoxville, and the Rev. Ron Morton, deacon at St. Thomas, Knoxville.

## Break

Bishop Young called for a break from 2:30 p.m. until 2:45.

## The Rev. Eric Law

The bishop called convention back into session. First leading everyone in song, the Rev. Eric Law began his talk for the afternoon, focusing on respectful relationships and dialogue, making ministry relationship driven, and truth telling requiring many perspectives. This led to several exercises and then small group discussions around the issue of same-sex blessings. The questions Eric Law posed were: 1) How does this decision affect you personally, 2) How does this ministry affect your ministry. After focusing on these silently, group discussions were encouraged. Afterwards, Eric Law ended by describing the importance of staying in community even though we have differences, which is what truth telling in respectful dialogue allows. Same-sex blessings is only one of many conversations that are needed in our communities.

# Report of the Committee on General Resolutions and Last Call for Resolutions

The bishop called on the Rev. Dr. Hal Hutchison for the report from the Committee on General Resolutions. The Rev. Dr. Hutchison reported that there has been one resolution presented for consideration. He asked if there were any others. None were offered. The one presented focuses on "The Family Visitation and Crime Reduction Act." A hearing on this resolution will be held at 5:00 p.m.

# **Report of the Elections Committee and Last Call for Nominations**

Bishop Young next called on Mr. Chris Cone to report and make a last call for nominations. Mr. Cone began by reading the names of those nominated thus far: Bishop and Council, Clergy, South East – Lou Parsons; Clergy, Middle East – Paige Buchholtz; Lay Middle East – Jan Lewis, David Thomas, Andrew Wilkinson; Disciplinary Board, Clergy – Brad Weeks, a nomination was made from the floor for Patricia Lynes-Tway; Standing Committee, Clergy – Joe Minarik; Lay – John Bellamy, David Kalwinsky, Christopher Robinson; Trustee, University of the South, Lay – Lee Phillips and David Sanders, a nomination was made from the floor for Glenn Graber. A motion was made and seconded that nominations be closed.

## **Motion carried**

Bishop Young reminded the convention that where there are positions to be filled and no nominees, the Bishop and Council will fill those positions for the remainder of the year. Also, there is a plan to have a nominations committee in place before next year's convention whose duty it will be to ensure there are nominees for each open position.

Mr. Cone then noted that for the position of Standing Committee, Clergy, Joe Minarik is unopposed. He moved that Joe Minarik be elected by acclamation. The motion was seconded and there was no discussion. The question was called.

Motion carried Elected by acclamation

# 3<sup>rd</sup> Mark of Mission

Ms. Rebecca Whelchel was called on to report on Metropolitan Ministry of Chattanooga, representing the 3<sup>rd</sup> Mark of Mission (*To respond to human need by loving service*). Ms. Whelchel began by sharing a video on Metropolitan Ministry. She then thanked everyone for their support of the ministry, their service, and their care for the guests of the ministry. She closed with a prayer and lit the third candle for mission.

# Announcements

Canon Stephen Askew was called on to give announcements. He reminded everyone of the hearings that begin at 5:00 p.m. and gave directions to them. A reminder and directions regarding the social hour and dinner were given. Checkout time is noon on Saturday. Information about breakfast was given. The COM and Standing Committee will meet with those in the process for ordination in the William Blount Room at 7:15 a.m.

As a teaser, the bishop mentioned that at dinner we will hear from the "Four Evangelists."

## Recess

Bishop Young called convention into recess until 8:30 a.m. on Saturday, February 9, 2013.

# Saturday, February 9, 2013 Morning Session

# **Convention Reconvened**

The convention reconvened on Saturday morning at 8:35 a.m.

# 4<sup>th</sup> Mark of Mission

The Rev. Eric Law and the Rev. Claire Keene led worship representing the 4th Mark of Mission (*To seek to transform unjust structures of society*). Eric Law led convention in singing and then reading a passage from Isaiah 55. He then spoke about leading like water. When resources are not flowing then things are not well - they stagnate. Money and resources, he said, can be used for blessing. He offered questions that need to be asked in order to have a missional and sustainable ministry. Eric Law then spoke to how we can change things and led convention in an exercise of sharing one's abundance. The fourth candle for mission was lit and the Rev. Claire Keene concluded with prayer.

# Report of the Committee on Credentials

Bishop Young recognized Mr. Chris Cone, who gave a report of the Credentials Committee. Mr. Cone reported as registered: 73 clergy delegates and 128 lay delegates, for a total of 201 delegates. Also reported were 41 alternates and 88 others for a grand total of 330 in attendance. In accordance with Article V of the Constitution, there was a quorum present for the transaction of business.

# **Elections**

Bishop Young invited Mr. Cone to continue with elections. He began by giving instructions on filling out ballots. Ballots were cast for Bishop and Council, Lay; Disciplinary Board, Clergy; Standing Committee, Lay; Trustee, University of the South, Lay. He then moved that the Rev. Lou Parsons be elected by acclamation for Bishop and Council, Clergy, South East. Motion was seconded.

Motion carried Elected by acclamation

Mr. Cone then moved the election of the Rev. Paige Buchholz by acclamation for Bishop and Council, Clergy, Middle East. Motion was seconded.

Motion carried Elected by acclamation

# Presentation and Adoption of 2013 Budget

Mr. Bill Selden was then called on for the presentation of the 2013 budget to be adopted. With changes being made during Friday's hearing, a motion was made by Mr. Selden to adopt the amended budget. The motion was seconded. There being no discussion, the question was called to adopt the 2013 budget.

Motion carried 2013 Budget adopted

# Report of the Committee on General Resolutions

Bishop Young next called on the Rev. Dr. Hal Hutchison to report for the Committee on General Resolutions. The Rev. Dr. Hutchison read the beginning and ending of the one resolution offered. This resolution, adopted by the Diocese of Tennessee, was recommended for adoption by the Dioceses of East and West Tennessee. On behalf of the committee, he then recommended the resolution for adoption. The motion was seconded. The bishop then called for discussion, reminding that each speaker is limited to five minutes. The Rev. Charles Fels spoke on behalf of the resolution. He then responded to a number of questions. The Rev. Peter Keese spoke on behalf of abstaining, expressing concern for those who work in prisons. The Rev. Maggie Zeller described what open visitation means and shared that her son, who is in prison, would rather not have a visit if it is only through a window. She urged the passage of the resolution, also noting the care she had seen from those who work in prisons. A question was asked about who would approach the legislature and governor once the resolution was adopted. The Rev. Charles Fels spoke to this. The bishop then called for the vote.

### **Text of Resolution 5**

WHEREAS, the Family Visitation and Crime Reduction Act was enacted by the Tennessee General Assembly in 2002, and said Act provides that "maintaining an inmate's family and community relationships is an important correctional resource that can improve an inmate's behavior in the correctional facility, and upon an inmate's release from a correctional facility, assist in reducing recidivism."; and

WHEREAS, the aforesaid Act provides that:

1. "Each state institution shall have an area designated for visitation."

2. "Correction officers assigned to visitation areas shall receive training on effective communication with family members and children of inmates, for the purpose of improving the quality of family visitation."

**3.** "The department of correction is encouraged to provide an area for child visitors."

4. "The department of correction shall report at least annually to the state and local government committee of the senate and the state and local government committee of the house of representatives concerning the department's progress on implementing procedures and services that enhance, improve and encourage visitation.", and

WHEREAS, the Tennessee Department of Corrections adopted regulations on January 1, 2011, that provide that, "Inmates may receive visits from outside clergy, volunteer chaplains, and religious volunteers"; and

WHEREAS, the Tennessee Department of Corrections adopted regulations providing for non-contact visits with inmates in Tennessee prisons on July 15, 2011, which regulations define Non-Contact Visitation as "The placement of an inmate and his/her visitor(s) in separate locations where no physical contact can be made but visual and auditory communications can occur"; and WHEREAS, said regulations of July 15, 2011 require that that inmates in maximum custody, segregation and protective custody have non-contact visitation; and

WHEREAS, on March 12, 2012, the Warden of the Morgan County Correction Complex published a Visitor's Handbook that requires that inmates classified as "close security" have only non-contact visits and that inmates classified as "maximum security" have only "video visitation"; and

WHEREAS, Jesus Christ stated in Chapter 25 of the Book of Matthew in the New Testament of the Bible, "I was in prison and you came to visit me." But, he was challenged, "When did we see you sick or in prison and go to visit you?" Jesus replied that "whatever you did for one of the least of these brothers and sisters of mine, you did for me." St. Paul wrote in his letter to the Hebrews, "Continue to remember those in prison as if you were together with them in prison", and the Psalmist reminds us in Psalm 69 that the Lord "despiseth not his prisoners." In the Old Testament of the Bible there are many references to God identifying with the captives and slaves. A distinctive quality of God is that He identifies with and defends the "orphans, widows, strangers and the powerless"; and

WHEREAS, an essential element of prison ministry is for clergy and laity to have contact visitation with inmates and to be in contact with the inmates during prayer, Communion, the Eucharist, and/or the Mass.

NOW, THEREFORE, it is hereby resolved by this the 29th Annual Diocesan Convention of the Diocese of East Tennessee of The Episcopal Church that the Governor and the General Assembly of the State of Tennessee are hereby requested to assure that contact visitation with prison inmates remains available for their family members, the clergy and lay visitors and that worshipping with inmates in the state prisons of Tennessee is conducted in accordance with the spirit of the Family Visitation and Crime Reduction Act of Tennessee in order to "enhance, improve and encourage visitation" and to have contact visitation in the spirit of Christian principles. This the 9<sup>th</sup> day of February, 2013.

Motion carried Resolution 5 adopted

# *Reports of the Officers, Boards, Commissions, and Committees (continued)*

# **Constitution and Canons Committee**

The Hon. Marie Williams was called on by Bishop Young to report. She commented that the hearing was one of the best she has attended over the years. The Hon. Williams then reported there are two amended resolutions recommended by the committee. She summarized the resolutions and their amendments. She then moved for the adoption of amended Resolution 3. After addressing a question for further clarity, the question was called.

### **Text of Resolution 3**

**RESOLVED**, That Title IV, Canon 1, Section 3 of the Canons of the Diocese of East Tennessee be amended as set out below:

#### **CANON 1: Parishes**

Sec 3. Each Parish in union with The Diocese shall, on the first convenient day in each calendar year, or within the quarter preceding that year, elect or select by a method set out in the Bylaws of the Parish a Vestry, consisting of not less than 6 nor more than 18 persons, having qualifications prescribed in Article X of the Constitution, to serve for that year and until their successors are elected or selected and have qualified; provided, however, that each Parish shall, by resolution adopted at any Parish meeting, upon prior notice, by a majority vote of the qualified voters present at the meeting, provide for a rotation in office of members of the Vestry by either of the following methods: (a) retaining a one-year term, but prohibiting a person from serving more than three consecutive onevear terms, or (b) making provision for a term in office of three years, one-third of the members of the vestry to be elected or selected each year to serve three-year terms. After expiration of three years consecutive service, a vestry member shall not be eligible for re-election or re-selection until at least one year shall have expired, nor shall a vestry member who has been elected or selected to serve a full term on the Vestry and who has subsequently resigned from that position be eligible for re-election or re-selection until at least one year shall have expired from the date of resignation. A Senior Warden and Junior Warden shall be elected or selected from the members of the Vestry, either by election by the Vestry or by some other selection procedure permitted by the Bylaws of the Parish.

> Motion carried Resolution 3 adopted

The Hon. Williams then moved for the adoption of amended Resolution 4, noting that with a two thirds majority, it would go into effect at the close of this convention. The Motion was seconded. The question was called.

#### **Text of Resolutions 4**

**RESOLVED**, That Article X, Section 1 of the Constitution of the Diocese of East Tennessee be amended to replace the word "elect" with the phrase "elect or select" and the word "election" with the phrase "election or selection." This resolution shall be effective at the close of this convention upon approval by a 2/3 majority of membership at convention.

Motion carried Resolution 4 adopted

## **Elections Report**

Mr. Chris Cone reported election results: for Bishop and Council, Lay, Middle East – Ms. Jan Lewis; Disciplinary Council, Clergy – the Rev. Brad Weeks; Standing Committee, Lay – Ms. Christopher Robinson; Trustee, University of the South, Lay – Ms. Lee Phillips. That completes the elections. The bishop expressed thanks for the work of the tellers and those willing to be nominated for the various positions.

## ECW Report

Ms. Elizabeth Stiefel was called on by Bishop Young. As the coordinator for the United Thank Offering in the diocese, she expressed that the goal of the United Thank Offering is not fund raising, but rather to develop a daily habit of gratitude, which leads to generosity. With the help of slides in her presentation, she reported that the UTO awarded a grant to the Volunteer Ministry Center in Knoxville to buy a minivan. This last year the UTO awarded 53 grants. A silver alms basin is available for collecting the ingathering in parishes. It was made from silver collected across the entire state when there was only one diocese. It is now shared by all three dioceses. The bishop asked for a show of hands of those who have used the blue boxes for collecting personal offerings.

# Grace Point Summer Camp

Bishop Young called on the Rev. Brad Jones, Executive Director of Grace Point. The Rev. Jones thanked the diocese for the opportunity to serve. He encouraged all to visit Grace Point and take advantage of its offerings. He reported that there is increased use by vestries and other groups, as well as increased attendance at summer camp. A video on Grace Point was shown to convention. In closing, the Rev. Jones asked that everyone send their kids to camp; it is life changing. He also volunteered to go to parishes and speak about Grace Point. Diocesan Day is May 4, a time when everyone is invited to go and spend the day at Grace Point. The bishop polled the convention for a show of hands of those who have not been to Grace Point. He encouraged them all to go. (The full report can be found in Section 6 of the Journal)

# Celebrate, Inspire, Equip

Bishop's address to the 29th Annual Convention of the Episcopal Diocese of East Tennessee

## Introduction

Good Afternoon! Welcome to the 29th Annual Convention of the Episcopal Church in East Tennessee. Thank you for being here. Thank you for sharing your valuable and precious time; please know that we do not take that lightly.

Our hope and expectation is that our time together will be valuable and precious as well.

Hopefully you know by now that our theme for this convention is "Send Us Out With Gladness and Singleness of Heart."

And also, as we spoke about a little bit last year, we have an ongoing vision for all of our conventions and that is that it is to "celebrate, inspire, and equip." So we hope all of those will happen in some form or fashion.

We have much to celebrate here in our life together as the Diocese of East Tennessee, and we plan to highlight as much of that as we can in these next two days.

I'd like to begin by saying a very special thank you to the wonderful, gifted, committed staff that I work with. They are: Stephen Askew, Mary Berl, Herb Berl, Rick Govan, Alex Haralson, Brad Jones, Lynn Lazlo, Vikki Myers, and Laura Nichols.

These are great, faithful people committed to you, to your congregations, to the work of the church. They're working hard to make me look good, and I'm thankful to them and for them.

Thank you also, especially – to each of you – the leaders, the people, the clergy in our parishes. This is where the rubber hits the road, where the true, every day, basic ministry happens, and none of us forgets that for a second.

You do it well, and you do it energetically and imaginatively.

You are an exceptionally healthy, vital, and Spirit-filled diocese, a gift to all of East Tennessee and the broader church and the world, and to me.

Thank you for being who you are. Thank you.

As I said, we have much to celebrate in the diocese, and we'll be seeing and hearing about many parts.

You'll hear about our vital Youth Ministries, about our incredible Campus Ministries, about Southside Abbey – one of our newest ventures, about our many Jubilee Centers – there are twelve of them!

You'll hear about Grace Point – which is one of our most valuable and exciting resources. We have a new Executive Director, the Rev. Brad Jones, who comes to us with a lifetime of powerful camp experience.

I'm grateful to several other special groups as well – to the Commission on Ministry, to the Committee on Inclusivity, to the Same-Sex Blessings Task Force, the newly organized Young Adult Task Force, the community of Youth Leaders, and the soon-to-be-meeting community of Senior Wardens.

There are many, many other groups and people I could express my gratitude for, but I have much to say and we don't want to be late for lunch, do we?

### Address

Our Eucharistic Liturgy is amazing, isn't it?

- We gather with a parade and song.
- We acclaim God as holy and trinity.
- We sing a hymn of praise.
- We hear stories from Scripture, and brilliant, inspiring reflections on Scripture (that's the sermon in case you didn't catch that part).
- We proclaim our faith in an ancient creed.
- We pray for the Church, for our country, for the welfare of the world, for the concerns of the local community, for those who suffer, and those who have died, along with thanksgivings for the blessings of this life.
- We confess our brokenness, and we hear of God's forgiveness for us.
- We share the Peace of God with one another.
- Then symbolically we offer ourselves in gifts of money, music, bread and wine.
- We hear the stories of God coming to us in the person of Jesus; of Jesus' life, death, and resurrection – of a holy meal he shared with his friends.
- We pray that God will bless the bread and wine and us, that all may become the Body and Blood of Christ.
- Then we receive that body and blood. And then what do we do?
- It's the end of liturgy, after communion there is a prayer. And it goes by one of most unimaginative titles of liturgy I've ever heard: The Post Communion Prayer.

In this prayer we pray for two distinct things – we say to God "Thank you for feeding us" and we pray that God will SEND US OUT – to love and serve God.

This isn't just a prayer that comes after communion; it's a Prayer of Thanksgiving and Mission! We've been fed and nourished and empowered and so we pray, Send us out! Send us out!

So - what are we being sent out to be and to do?

In his book called, *The Once and Future Church*, Loren Mead talked about the "mission field." He said that beginning with the earliest followers of Jesus in the first few centuries, it was illegal, and unacceptable and sometimes punishable by death to be a Christian. So if that's the case, where is the mission field? It's everywhere! It's everywhere they lived, and moved, and had their being.

And then – and here's a little history lesson for you – about the Fourth Century – along comes Constantine – and over a period of time, Christianity becomes the official language of the Roman Empire – so all of the western world is Christian. Sort-of. If that's the case, if everybody is Christian, then where is the mission field? It becomes places far away, doesn't it? People who are different from us. People of different colors and languages. People in far-away places like Africa and Asia, and other places where they haven't heard of Jesus. In that setting, the mission field is "Somewhere else."

That idea persists even today, doesn't it? If you think of a Missionary, don't you think of someone who goes to some faraway place?

Well, Mead's point was as much as we may think or wish that we live in a Christian world, we don't! So – the mission field – once again – is right outside our doors – out there, it's everywhere we live and move and have our being.

In a new book called, *People of the Way – Renewing Episcopal Identity*, (which is a wonderful book I encourage all of you to read) Dwight Zscheile describes how The Episcopal Church was once essentially the established church of the United States, but it no longer is. We were once the church of presidents, of most elected leaders, of captains of industry, of all kinds of powerful people – and what we thought and spoke and said was culturally important. It no longer is. No one outside of our group much cares what The Episcopal Church has to say about much of anything. And they certainly don't join our church because it's the "thing to do" for up and coming people.

So, simply – we can't assume that people are eager to join our great church; we can't sit by waiting for them to come to us. Which is exactly why we pray, "Send us out!"

There is much talk these days about the "Nones" (And I'm spelling that n-o-n-e-s, not n-u-n-s – though there's a lot of talk about those kind of nuns, too). But the Nones (n-o-n-e-s) are those who are "religiously unaffiliated." They don't attend religious services; they don't have any religious preference, though half of this group still says they believe in God or understand themselves to be spiritual.

The latest Pew Research says that twenty percent of the US population is Nones – twenty percent of the entire population! And of those under thirty, fully one-third are Nones. A third of the people in our country – that is a LOT of people.

In her newest book, Christianity After Religion, p. 86, Diana Butler Bass writes:

Whatever else may be said of this group, they are profoundly disappointed in religion, in religious ideologies, and in religious organizations as they currently exist. In a 2004 Barna survey, they found that young adults who are outside of the church hold intensely negative views of Christianity:

- 91% see Christianity is "anti-homosexual"
- 87% say Christians are "judgmental"
- 85% accuse churchgoers of being "hypocritical"
- 72% (almost three-quarters) say that Christianity is "out of touch with reality."
- Only 41% think that Christianity seems "genuine or real" or "makes sense."
- And only 30% (less than a third) think that Christianity is "relevant to your life." (p. 86)

Those are scary numbers. And that was almost ten years ago!

She's speaking particularly about young adults, but I'm sure this can just as easily describe most adults, Bass writes:

They have evidently heard that Christianity is supposed to be a religion about love, forgiveness, and practicing what Jesus preached and that faith should give meaning to real life. They are judging Christianity on its own teachings and believe that American churches come up short. Thus, their discontent may reflect a deeper longing for a better sort of Christianity, one that embodies Jesus's teaching and life in a way that makes a real difference in the world. (p. 87)

I don't know about you, but I would say that THAT is our mission: to be the "sort of Christianity that embodies Jesus' teaching and life in a way that makes a real difference in the world."

We have all the tools to be this kind of Christianity, every single one.

But we have a lot of work to do.

I recently heard an illustration that's been very helpful to me. I think the person was actually specifically talking about liturgy, but the illustration was that we are to be more like the crew on a cruise ship, than passengers on a luxury liner.

In terms of liturgy, the point is that we are active participants, working – not passive people being entertained. And God is the audience in the liturgy, not us.

The bishop stopped to place a boat on the lectern, a vessel named "The Church."

Here's our new identity - our mission - which is why you have freighter ships on your tables.

We are the crew on the freighter ship which is The Church. We're active participants – we're making this ship go, we're not passive people waiting to be entertained. I'm sure most of you have heard the image before of the "ship" – of the church as the "ship of salvation?" That's why many churches' ceilings are shaped like the hull of a boat, and the main part of the church is called the "nave."

And have you heard that saying about ships – that they were made – not for the safe and quiet of the harbor, but for the wild and sometimes treacherous open seas. That's our call, that's our mission.

So I want to share with you now an inspirational piece about leadership, called *First Follower: Leadership Lessons from Dancing Guy*, about starting a "movement:" http://www.youtube.com/watch?v=fW8amMCVAJQ. Hopefully you heard the narrator in the video say, "The best way to start a movement is to courageously follow and show other followers how to follow."

And he said, "When you find a lone nut doing something great, have the guts to be the first person to stand up and join in."

The key words here – not "nut" – though we have plenty of those, but COURAGE, FOLLOW, GREAT, GUTS, STAND UP, JOIN IN.

So – how do we know when we are on target? How do we know when we're hitting the mark?

Well, there's the Baptismal Covenant. We renew it several times each year. It's basically the "position description" for living a Christian life, and as we participate in that, we say after each petition, "we will with God's help."

Then there's another tool. It's called the "Five Marks of Mission."

The Mission of the Church Is the Mission of Christ

And they are:

- To proclaim the Good News of the Kingdom
- To teach, baptize and nurture new believers
- To respond to human need by loving service
- To seek to transform unjust structures of society
- To strive to safeguard the integrity of creation and sustain and renew the life of the earth

These are active words and concepts; they're about doing and about working in the world. They're about living an active Christian life – not just on Sunday mornings, not just on the church grounds, but always and everywhere. We're part of a movement, we're active, we have courage, we have guts. This is what mission is all about.

We've made posters for each parish and worshipping community with our convention logo and with the Five Marks of Mission. These posters are really nice. And though the gift of grace from God has no strings attached – these gifts actually have strings attached. We ask that these posters be displayed in an open and visible place in your parish, in your church, so that people can see them, and know what the Five Marks of Mission are. So, is it a deal? Open and visible place? Good.

The first Mark of Mission, as you'll see, is "to proclaim the Good News of the Kingdom."

That sounds like evangelism. Oh no!

We Episcopalians are uncomfortable with that word, aren't we? Kind-of makes the hair on the back of our necks stand up, doesn't it?

After all, we think, but would never say out loud, "that's what other, less sophisticated Christians do." We have the Book of Common Prayer!

Well – guess what? We do it too. It may look different than others, but we proclaim the Good News in lots of powerful ways.

We even evangelize!

It's about the messages we give, it's about the ways we live.

But it needs to be active, not passive.

Remember, we're the crew driving this ship!

And here's more good news. As Eric Law writes, it's about listening, and it's about story-telling. It's NOT about convincing or arguing or shouting or strong-arming. We don't do those things.

I read in Dwight Zscheile's book about a practice I hadn't heard of before. It's called "plunging."

Plunging, he said, and I quote, is *the practice of intentional relationship development with diverse neighbors through relying on their hospitality*. (p. 81)

This sounds like one of the many, many cool things that the folks at Southside Abbey in Chattanooga are doing and you'll hear more about that soon!

Zscheile writes,

This often begins informally, with Christians striking up conversations with neighbors at a bus stop or some other public place. Rather than invite the neighbors to come to some event or program at the church, they seek to be invited to accompany those neighbors to their gathering places. (Think coffee shops, the gym, places you have lunch.)

*The primary agenda is cultivating community, listening to people's stories and dreams, and beginning to share life together.* (p. 81)

This kind-of reminds me of how some church groups take "mission trips" where they, or we – the privileged people – go to help the poor people. And often, there's no attempt at building relationships. What if the core of our mission trips was to meet people, to listen to them, to understand what their life and their culture is about? That is mission!

He describes how members of the Dutch Reformed Church in South Africa came to plunging. These people, this church, were essentially the face of apartheid, and when apartheid was abolished – they sought reconciliation and relationship with other people. God bless them! They had to be the learners, the listeners, not the patrons who were taking care of everything and everybody.

Like them, we can no longer be a church that simply looks for people "like us." Our challenge is to go out and find out for ourselves what God is busy doing in our neighborhood.

Our mission isn't just to get "butts and bucks" in the church. It's much bigger than that!

So this idea of "plunging" challenges us to do one of our very favorite things: CHANGE!

To re-think some things.

To listen.

To be vulnerable, to risk.

Maybe even to dance with some shirtless guy – as long as we don't have to take off our shirts!

So here are some ideas for us to consider:

What if Bishop and Council was about visionary leadership? What if that was their main goal?

What about our vestries? What if they saw that as their main goal, not spending so much time talking about money?

What if we sat in different pews on Sunday? I know, gone from preaching to meddling now, right? "No, I can't do that!"

What if we sought out people different from us and invited each other to tell stories?

What if we went to neighbors and introduced ourselves, asked what we can do, what keeps them awake at night, ask them how we might pray for them?

What if we saw guests who come to our churches as people bringing God to us, and not as simply potential givers and hands to share in our chores?

What if we selected young people, new people, different people to our vestries, not simply those on their fourth, fifth or sixth time around? Meddling again, I know.

How about this? What if – when we hear challenging ideas like these – we think about the possibilities first, and not about the practical arguments against?

I wonder how many of your friends, classmates, children, parents, grandchildren, colleagues, neighbors are engaged in a religious communities? And I wonder if you know how many are not. So why aren't they?

What if we asked them about it – asked them about it and then listened without judging, without lecturing, without frightening them? What if we were really interested and curious about this? How might this make a difference?

What if we decided to do something really awesome?

Here's the "Kid President" in a video to help us think about that: <u>http://www.youtube.com/watch?v=l-gQLqv9f4o</u>

The "kid" talks about creating something, about getting the whole world to dance.

That's what I call gladness and singleness of heart!

The Gospel is not boring – even though so many people see us Christians acting like it is. It's Good News! It's Good News of hope, of new life, of forgiveness, of joy!

We can always use more gladness and singleness of heart, can't we?

So, those of you who have been around The Episcopal Church for a number of you years – you might remember when we introduced the "new" Prayer Book – which is now forty something years old. There were lots of changes in the liturgy. And one of those changes was the addition of the dismissal at the end of the service. Using the previous Prayer Book, the tradition in the parish where I was attending was after the procession ended and after the final hymn was sung, everyone sort-of fell to their knees for quiet prayers, stayed there for a moment, and then the postlude started and everyone got up and left.

When we introduced the dismissal, guess what happened? We heard those words, "Go in peace to love and serve the Lord" and people dropped to their knees! It's ridiculous!

When we hear those words, we should be rushing out the doors!

We've been dismissed – we've been literally "sent out!"

So – when we are sent out – to love and serve the Lord – let's go!

The mission field out there awaits us!

Let's get this ship plunging and dancing and rocking!

Let's make our mark – five marks – a thousand marks – on the world.

Let us pray.

Almighty and ever-living God, source of all wisdom and understanding, be present with us as we gather as the Episcopal Church in East Tennessee – for the renewal and mission of your Church. Teach us in all things to seek first your honor and glory. Guide us to perceive what is right, and grant us both the courage to pursue it and the grace to accomplish it; through Jesus Christ our Lord. Amen.

# **Reports to Convention**

## Anti-Racism Commission Report

The Anti-Racism Commission works to dismantle the institutionalized racism that continues to exist in the organizations, churches, systems, policies, practices and procedures in the Episcopal Diocese of East Tennessee.

We are committed to eradicating systemic racism by achieving full participation of people of color for equity in policy-making, decision making, programming and staffing on local, diocesan and national levels, to raise up a people unified in a transformed Church that is living ever more fully into our Baptismal Covenant as disciples of Jesus Christ.

Our mission is accomplished by: Establishing a common antiracism analysis to foster ongoing vigilance in identifying and dismantling systemic racist policies, practices and procedures. This common analysis and vocabulary is achieved through endorsed training and education in issues of racism, organizing Church entities and communities by partnering with them to develop policies, processes and plans to dismantle racist structures, raising up, promoting and advocating for people of color to have full access to leadership roles and participation at every level of diocesan life, serving as a resource for antiracism work; and with God's grace in so doing, to establish an antiracist identity in the Church for the life of the world.

During 2012, the commission worked to include new members, redefine its mission statement, work jointly with the Union of Black Episcopalians, and offer an anti-racism training as well as a training of trainers. In November, Lelanda Lee of Colorado and Pamela Kandt of Wyoming joined us to lead both of these trainings. They helped us gain an appreciation for the issues presented by our increasingly multi-cultural society. With such training now accomplished, we look forward to utilizing the newly acquired skills of diocesan trainers to make training more accessible to parishes throughout the diocese of East Tennessee.

Members of the commission in 2012 were: The Rev. Canon Stephen Askew, Mr. Alex Haralson, the Rev. Bob Leopold, Mr. David Johnson, Mr. Michael Moore, Ms. Nancy Mott, Ms. Patricia Pearsall, Mrs. Katie Piper, and Dr. Walter Williams. We give thanks for the work they have done.

# Bishop and Council Highlights for 2012

Each of these Bishop and Council meetings included reports from Bishop Young, the chancellor, treasurer, campus ministries, Grace Point, ministry development, youth ministry, communication, deployment and other officers, committees and staff. The status of the budget is submitted for approval and discussion at each meeting. The following actions were taken at Bishop and Council meetings during 2012.

### March 30-31, 2012

A motion was passed to elect the Rev. Kirk LaFon as the clergy representative from the middle east. He will serve in the Class of 2015.

A motion was passed that the bishop will appoint two task forces. One on becoming a missionary diocese and the other on the response to Blessings of Same Sex Unions. The bishop will report on the progress at the May 2012 Bishop and Council meeting.

A motion was passed provincially that A Covenant and Limited Access Agreement policy be adopted until the May 2012 meeting regarding the need for addressing sex-offenders in the parish.

### May 7, 2012

Motion was passed that Bishop and Council authorizes the establishment of a special Worshipping Community to be known as Southside Abbey located on the southside of Chattanooga. Under the supervision and leadership of a diocesan staff person, with oversight of the bishop and a local council.

Motion was passed that Bishop and Council approve the hiring of the Rev. Robert K. Leopold as a diocesan employee to lead the ministry of Southside Abbey for up to three years with his compensation and benefits to be funded from the Mission Growth Fund with an estimated cost of \$225,000.

On recommendation from the Opportunity Fund, a motion was passed that an expansion grant of \$15,000 be given to Southside Abbey, Chattanooga. Social Ministries grants: \$4,430 be given to the Bradley Initiative, Cleveland, \$2,500 to the Food for the Multitude, Elizabethton, \$3,070 to Interfaith Homeless, Chattanooga, \$5,000 to Steps House, Knoxville. Opportunity Fund Loans: \$37,500 to St. Barnabas, Jefferson City, \$30,000 to St. Paul, Kingsport, \$800,000 to St. Paul, Chattanooga.

On recommendation of the Budget and Finance Committee, a motion was passed to increase the Rev. Canon Stephen Askew's salary by \$4,000 and his pension would increase by \$748. The remaining \$10,593 of the voluntary commitment increase would go to Support for Congregations.

On recommendation of ICMF a motion was passed to allocate \$5,000 to Southside Abbey and the remaining \$5,000 to NEEMA for raised garden beds for refugees in the community.

#### November 15, 2012

On recommendation from the Opportunity Fund, a motion was passed that an expansion grant of \$15,000 be given to Southside Abbey, Chattanooga. Social Ministries grants: \$4,430 be given to the Bradley Initiative, Cleveland, \$2,500 to the Food for the Multitude, Elizabethton, \$3,070 to Interfaith Homeless, Chattanooga, \$5,000 to Steps House, Knoxville. Opportunity Fund Loans: \$37,500 to St. Barnabas, Jefferson City, \$30,000 to St. Paul, Kingsport, \$800,000 to St. Paul, Chattanooga. (Details submitted with the minutes)

On recommendation of ICMF a motion was passed to allocate \$3,000 to St. Paul, Athens for support of the intern for innovative community outreach.

#### December 13, 2012

A Housing Allowance Resolution was passed for the Rev. Canon Stephen Askew and the Rt. Rev. George D. Young, III. Resolution submitted with minutes.

A motion was passed to adopt the 2013 proposed budget. Budget submitted with the minutes.

### Commission on Ministry Report

The Commission on Ministry (COM) consists of 15 people, lay ministers, priests, and deacons, who assist the bishop with "the determination of present and future opportunities and needs for the ministry of all baptized persons" in the Diocese of East Tennessee. A primary function of the COM is to facilitate the discernment process for East Tennessee Episcopalians who are discerning a call to ordained ministry.

The Commission on Ministry meets every 4-6 weeks including an annual autumn Discernment Retreat. The 2012 discernment season found us with a large number of aspirants and thus a need for two discernment retreats. Our first Discernment Retreat took place over 2 days in Loudon, Tennessee, and the second took place at St. Mary's Retreat and Conference Center in Sewanee, Tennessee. After the retreat, the bishop named five aspirants as postulants for ordination to the priesthood and two aspirants as postulants for the diaconate. The COM seeks to continually encourage all Christ-followers to enter into discernment activity around call to ministry as all the baptized are indeed ministers! The COM always delights in registering our hearty support of Deputy Rick Govan who is a Christ-light in our midst and a great voice of encouragement and wisdom for all the baptized ministers of our diocese, especially the laity. The COM encourages all the Christ-followers of the diocese to participate in the rich offerings that Deputy Govan presents for our benefit throughout the year.

The COM also wants to encourage the clergy of our diocese to entertain discernment conversation, prayer, and activity with potential aspirants on an ongoing basis. The COM has just completed a rigorous effort to revise our priesthood discernment process and discernment documents – you can find them on the diocesan website soon. We hope to soon undertake a similar revision process for our deacon discernment program.

The COM has developed a new discernment calendar (on the web now) to help guide the formal discernment conversation and activities with the COM. As you know, the bishop gives the "go-ahead" for aspirants to begin COM supported local discernment work beyond Rector/Aspirant conversations. The window of time for clergy and aspirants to communicate with the bishop about potential aspirants to ordination is September 1 - December 1.

At present, the Diocese of East Tennessee has 14 people on the journey to ordination. We have 4 candidates for the priesthood, 7 priest postulants, and 3 deacon postulants.

The COM invites your prayers for these folks as they journey on to ordination and ministry in our church.

### **Constitution and Canons Report**

The Constitution and Canons Committee has addressed issues brought to it by parishes and committees of the diocese. The resolutions contained below are presented to solicit full consideration of these issues by the diocese.

**<u>RESOLVED</u>**, That Title IV, Canon 1, Section 3 of the Canons of the Diocese of East Tennessee be amended as set out below:

### **CANON 1: Parishes**

**Sec 3.** Each Parish in union with The Diocese shall, on the first convenient day in each calendar year, or within the quarter preceding that year, select by a method set out in the Bylaws of the Parish a Vestry, consisting of not less than 6 nor more than 18 persons, having qualifications prescribed in Article X of the Constitution, to serve for that year and until their successors are selected and have qualified; provided, however, that each Parish shall, by resolution adopted at any Parish meeting, upon prior notice, by a majority vote of the qualified voters present at the meeting, provide for a rotation in office of members of the Vestry by either of the following methods: (a) retaining a one-year term, but prohibiting a person from serving more than three consecutive one-year terms, or (b) making provision for a term in office of three years, one-third of the members of the vestry to be selected each year to serve three-year terms. After expiration of three years consecutive service, a vestry member shall not be eligible for re-selection until at least one year shall have expired, unless the Parish Bylaws permit consecutive terms, nor shall a vestry

member who has been selected to serve a full term on the Vestry and who has subsequently resigned from that position be eligible for re-selection until at least one year shall have expired from the date of resignation. A Senior Warden and Junior Warden shall be selected from the members of the Vestry, either by election by the Vestry or by some other selection procedure permitted by the Bylaws of the Parish.

**<u>RESOLVED</u>**, That Article X, Section 1 of the Constitution of the Diocese of East Tennessee be amended to replace the word "elect" with the word "select" and the word "election" with the word "selection."

# **Dubose Conference Center**

DuBose Conference Center is jointly owned by the three Episcopal Dioceses of Tennessee and is operated independently of any financial subsidy. A twenty one member Board of Directors presently governs the Center, which meets quarterly. It consists of the three bishops of Tennessee (serving as ex-officio members) who appoint one member each, except Middle Tennessee who appoints two members. The board may also elect 17 additional at-large members. The mission of the center is to provide hospitality for the religious and secular communities. DuBose strives to accomplish this mission by offering a place for people to gather in a community of faith.


The Director is Kim Agee. The administrative staff include Lorrie Coutu, Accounting; and Kathryn Jasper and Cameron Swallow, Camp; Rena Terry, Food Service; Justin Kilgore, Maintenance. Officers in 2012 were as follows: Vena Champion, President; Brad Almquist, Vice President; Susie Ries, Secretary; and Jim Beaty, Treasurer.

The end of 2012 found the Center in good financial condition. The conference center operated within a 475,531 budget generated from gifts and user nights. The center was occupied over 202 days of the year, during which time it hosted over 80 conferences, welcomed over 3964 people, generated 8532 user nights and served 25,744 meals.

Camp Gailor-Maxon continues to be a positive, spiritual and fun camping experience for the Episcopal youth from across Tennessee. The staff welcomed 162 campers during pre-camp and three camp sessions in the month of June.

# Jubilee Ministry Report

<u>History</u>

General Convention Resolution Number: 1982-A080 Title: Implement "The Jubilee Ministry"" to Meet Basic Human Needs *Resolved*, the House of Deputies concurring, That the 67th General Convention affirms that a ministry of joint discipleship in Christ with poor and oppressed people, wherever they are found, to meet basic human needs and to build a just society, is at the heart of the mission of the Church; and be it further *Resolved*. That the Evecutive Council is directed to implement and an ordinate with other programme

*Resolved*, That the Executive Council is directed to implement and co-ordinate with other programs of the Church the following functions of a priority ministry commitment by this Church to be called

"The Jubilee Ministry".....

Ministries are recognized by the National office in New York as centers who fulfill the resolution's mandate to be a "ministry of joint discipleship in Christ with poor and oppressed people, wherever they are found, to meet basic human needs and to build a just society."

Even though the General Convention established the Jubilee Ministries in 1982, there were no recognized Jubilee Centers in the Diocese of East Tennessee when Bishop vonRosenberg was elected in 1999. Bishop vonRosenberg asked the Rev. Wade Fry to serve as the new Diocesan Jubilee Officer (DJO) and to find some ministries to recognize. In 2002, five ministries were designated as Jubilee Centers. Then more followed until today we have 12 centers. Along the way, there have been a few who were designated and unfortunately for one reason or another, didn't continue in their ministries. The newest center was designated in 2009. Since the diocese is fairly large and spread out, in 2004, Ann Holt was asked to assist Rev. Fry in the Southeast area as Assistant DJO. After Rev. Fry's retirement from Jubilee in 2006, Ann was asked to become the DJO, and continues in that role today.

- 12. St. Elmo Neighborhood Reading Center, Chattanooga, TN, Executive Director, Linda Cooper

Periodically, the centers are to be re-certified and re-commissioned. This process is a visit from the DJO, an updated application approved by the DJO and Bishop, plus affirmation by the New York office. The current statuses can be found on the directory available at the Jubilee table.

#### <u>Future</u>

The Rev. Hendree Harrison and his congregation at St. Paul, Athens, provide some wonderful ministries to the poor and homeless. They have a Jubilee application and are considering applying. The Woodland Community Land Trust in Clairfield offers housing to low-income and elderly people, plus gardens, teachings in sustainable forestry and a living learning center. A visit and review was conducted in November. An application is being prepared.

#### Grants

The National office offers grants to support the services of the centers. These grants vary from offering to offering. The grants vary their focus e.g. volunteers, environment, working with neighborhood governments, literacy, etc. Over the years, several of our centers have benefited from applying and being awarded grants. For example, the Mountain Women's Exchange in Jellico and the Food for the Multitudes in Elizabethton were recipients of \$500 each for volunteers in 2009. In 2010, three centers, the Cumberland Adult Reading Center received \$2,500 for literacy programs; the Hosanna Community and Metropolitan Ministries, Inc. each received \$750 for a garden for fresh produce to help feed the residents and clients. In 2011, Cumberland Adult Reading Center and Hosanna Community each received \$750 for Health & Nutrition Programs. In 2012, Hosanna Community received \$750 for Health & Nutrition Programs. In 2012, Hosanna Community received \$750 for a summer camp program. While these grant dollars are not large, they are intended to be "seed" monies for the centers.

We are awaiting feedback from The Episcopal Church regarding two grant applications for 2012.

#### <u>Training</u>

Ann and her husband, Ben, joined 39 others at the National Conference for Diocesan Jubilee Officers in Americus, Georgia, Nov. 14-16. It was held at the Habitat for Humanity headquarters with a visit to Koinonia Farm. While the majority of attendees were DJOs from the states, Dominican Republic and Colombia, the Executive Council and church center staff were also well represented. Bishop Alan Scarfe, Diocese of Iowa joined us for a special session and Clive Rainey, a 30 year volunteer with Habitat gave the keynote address. It was a very uplifting, informative and prayerful few days learning and sharing with so many Christians.

#### Summary

Each center tells a unique, but wonderful story of fulfilling God's call to help those less fortunate. The directors, volunteers, and donors are committed to seeing these ministries survive to serve many, many needy people. All welcome visitors. Once you visit, you'll be inspired by their work.

# Office of Ministry and Congregational Development

Exciting work continues with a number of parishes throughout the diocese as they focus their priorities in the areas of lay ministry and leadership development, and also congregational re-development. Parish leaders – clergy and lay – increasingly understand that sustained and effective lay ministry occurs when an individual's gifts and passions are connected with ministry opportunities. These opportunities occur both within the parish and in the local community and beyond.

This past year your diocese has provided a significant amount of resources for the education and formation of those who are called by their congregations to become canonically licensed as preachers, pastoral care ministers, catechists, Eucharistic visitors, and worship leaders. Faithful parishioners from all size congregations – large and small – are participating in Saturday classes and workshops offered simultaneously in two areas of the diocese. Our hope and intent is to also offer these canonical licensed ministries courses in the Upper East region of the diocese as well.

Several congregations are engaged in the serious work of congregational redevelopment. Clergy and lay leaders are partnered in reimaging what God might have in mind for their church today, exploring the possibilities of a new identity. They understand and embrace the necessity for change. They are committed to the here and now; not stuck in the status quo of a bygone era. Coast mode is no longer a viable option for the church today. Indeed, congregational vitality and growth and relevance occur when we look through the windshield and no through the rearview mirror!

I am beginning my eleventh year serving as a resource for you in the areas of lay ministry development and congregational development. These responsibilities continue to evolve, primarily because our parishes are evolving in response to a fast changing society, evolving with new visions, new dreams, following new paths and experimenting with exciting new possibilities.

This is not easy work for any of us. But, it is important work for all of us. And, it can be exciting work. With God's help, we can have some fun as we go about it, too!

# Report of the Standing Committee of the Diocese of East Tennessee – 2012

Your Standing Committee schedules a monthly meeting, but actually meets only when business requires it; we also occasionally are able to conduct our business electronically. In 2012, we met in person at the Diocesan House six times and electronically twice.

The Standing Committee has several responsibilities assigned to it by Canon; they may be divided roughly into three areas:

I

Matters having to do with Ordained Ministry: (Canons require that we have a personal interview with each person before s/he may become a Candidate for Holy Orders. We also usually meet with persons before they are ordained Deacon and Priest. These meetings are for us not merely a requirement, but also an enriching experience.)

In that regard, in February we recommended that Mr. Steve White, Mr. Robert Hartman, and Mr. Fred (Mac) Brown be made Candidates for Holy Orders; and in November we recommended that Mr. Christian Nicholas Hawley be made a Candidate for Holy Orders.

In March, we recommended that the Rev. Dr. Richard Carter be ordained Priest; and that Mr. Christopher James Hackett be ordained Deacon.

In September, we recommended that the Rev. Chris Hackett be ordained Priest.

Also, during this year, we consented to the Consecration of the Rev. Canon Oge Beauvoir to be the Bishop of Haiti; we approved the request of the Diocese of North Carolina to elect a Bishop Suffragan; and we consented to the Consecration of the Very Rev. William Douglas Hahn to be the Bishop of the Diocese of Lexington. These consents require only a 'paper review' and are generally *pro forma*.

(I might note here that in future years, the Standing Committee may have more requests to consent to Bishops' Consecrations, since that will no longer be the function of General Convention whenever an election is held within 90 days prior to said Convention.)

II

Matters having to do with Church property – acquisition, sale ("alienation"), and encumbrance (loans).

The interest of the diocese when there is an acquisition is to see that the property is properly titled as "held in trust for the diocese" (Title III, Canon 1, Section 2).

When there is a sale, we are to see that the proceeds of the sale are appropriately used in service of the mission of the Church or Agency selling the property.

When a loan is sought, the Standing Committee has the responsibility to see that the Church's finances are in order and capable of repaying the loan and that the plans for which the loan is sought serve the mission of that Church (or Agency).

**NOTE:** that the Standing Committee has established a clear set of policies and guides (available on line) for Churches wishing to buy, sell, or borrow against property. We stand ready to consult with any who request it, and we will always act as expeditiously as possible in response to any request to buy, sell or borrow. But our consent and approval must be obtained before the Church may undertake the proposed action.

In this regard, in March we approved the request of St. Paul, Chattanooga, to borrow money from the Diocesan Opportunity Fund. This loan was, in part, to accomplish the purchase of part of the property (a parking lot) owned by St. Barnabas (see below).

It is worth noting that at that same meeting, we adopted the following statement:

Recognizing the historic ties between the Episcopal Church and St. Barnabas, Chattanooga, and affirming the good ministry of St. Barnabas during its lifetime, the Standing Committee of East Tennessee, with the knowledge that the Diocese no longer has legal ties with St. Barnabas, acknowledges the sale of St. Barnabas' Pine Street Property and understands that the proceeds from the sale will be used to pay down its current debt. In May, we approved the request from St. Paul, Kingsport, to borrow money from the Diocesan Opportunity Fund to accomplish some building remodeling.

In July we approved the request of the Diocese to sell the property of St. Matthew, Dayton, with the proceeds being used to retire their Opportunity Fund loan; and any remaining funds to be held by the Diocese for future use in Dayton, if it is decided to pursue a ministry in that area.

In August, we approved the transfer of the ownership of the Church property of St. Barnabas, Jefferson City, to the Diocese; and we further approved their request for a loan from the Opportunity Fund of the Diocese in order to pay the remaining mortgage on the property.

In October we approved the request of St. John, Johnson City, to encumber their property in the amount necessary to accomplish needed major repairs.

In November we approved the request of St. Martin of Tours, Chattanooga, to refinance their bank loan at a much more favorable rate.

Addendum – January 26, 2013: By electronic meeting on this date, we approved the request of St. Francis of Assisi, Ooltewah, to sell a property which had been donated to them.

Since our Canons require that all actions taken by the Standing Committee for the Diocese concerning real property be approved and ratified by the Diocese, I will, at the appropriate time, make the following motion:

Resolved that all actions of the Standing Committee taken under the provisions of Title III, Canon 1 (Real and Personal Property) and reported to this Convention affecting title to and property of the Diocese of East Tennessee or its constituent congregations be approved and ratified and made the actions of this, the 29th Convention of the Diocese of East Tennessee.

#### III

The Standing Committee serves as a Council of Advice to the Bishop, either at his initiative or ours. It is a right and good thing that there is an "independent body," standing beside and "outside" the bishop; and in East Tennessee the bishop and the Standing Committee have always functioned collaboratively and collegially, and not as adversaries. For this we are particularly grateful to our current bishop who continues this good tradition.

When he is able to join us (which was, this year, at every meeting but one), he has lunch with us, at which time we consult with one another. Among the matters we discussed are the following:

Early in the year, our recently retired President (the Rev. Lou Parsons) came back to meet with us to help lead us through the first of what is to be an annual "ministry review" – a review the bishop had asked for and committed himself to from the outset. It was a good beginning and sets a pattern for the years to come. We forwarded the report of that review to the Bishop and Council.

Over the course of the year, the bishop has facilitated closer collaboration between the Commission on Ministry and the Standing Committee, helping us toward clarity about our mutual and separate responsibilities regarding ordained ministry. In the fall, the bishop sought our advice (along with the good advice of an appointed task force and the B&C) about how best to introduce the diocesan plan for allowing blessings of same gender unions. We were very affirmative of his initiative.

I have been privileged this year to have had the opportunity to work with such a collegial Bishop and such thoughtful, independent minded, and dedicated colleagues, lay and clerical, members of this Standing Committee.

The Rev. Scherry Fouke will retire from the committee this year; Ms. Christopher Robinson has graciously agreed to stand for election to another term. Ms. Andrea Odle (who did yeoman's work as the clerk), Mr. Jim Shearouse, and the Rev. Taylor Dinsmore, and I are continuing members. I am grateful to all of my colleagues.

# Stewardship Commission

The Stewardship Commission is composed of both lay and clergy members. It normally meets six times a year. Several members have been trained as consultants and are available to work with any parish upon request. Requests for assistance can be made by contacting the diocesan stewardship officer, Herb Berl at 865-803-5434 or stewardship@dioet.org.

The commission also annually provides a diocesan training event. In August, 2012, Charlene Fabian, Director of Development for Oklahoma Methodist Manor in Tulsa, Oklahoma, and Kristine Miller, a prolific writer and top rated speaker at many events, were the presenters for *Grounded in Gratitude*, *Revealed in Prayer & Lived in Faith\_*conference held at the Church of the Good Samaritan in Knoxville. Thanks Cal! Both speakers received rave reviews. Each of the 73 people from 20 Parishes who attended the event received a flash drive which contained the training information that was presented. Planning for the 2013 conference was well underway by the end of the year. Nathan Dungan, founder and President of Share, Save, Spend as well as author of *Prodigal Sons and Material Girls – How Not to be Your Child's ATM* and *Money Sanity Solutions – Linking Money + Meaning*, will be our featured speaker.

Members of the commission are afforded opportunities to receive further training which they share within our diocese. In March 2012, Mr. Herb Berl, Mr. Dexter Cantelou, and Bishop George Young attended the Consortium of Endowed Episcopal Parishes Conference in Charlotte, North Carolina. The conference covered not only endowments, but 7 aspects of Parish life as well.

Resource material is provided to every parish electronically throughout the year. The TENS publication *Networking* and The Episcopal Network publication *The Steward's Well* may be forwarded to every parishioner's home. The Episcopal Church Foundation hosts webinars. To participate in the webinars, please contact Herb Berl.

In 2012, we continued efforts to organize and make available the library resources received from TENS in 2011. We have over 300 books, videos, and program materials available for parish use. To check out these materials, please contact Mr. Herb Berl.

Mr. Ben Holt and Ms. Ann Holt became co-chairs of the commission for 2012, and have agreed to continue to serve in that capacity in 2013.

• **Rule 2.03:** Such Committees as are instructed by the bishop shall convene in advance of the opening of Convention to consider matters referred to them.

• **Rule 2.04:** Reports of all Committees shall be in writing. All reports recommending action by the Convention shall be accompanied by resolutions for such action.

### **III. RESOLUTIONS**

• Rule 3.01: Resolutions are submitted as the Canons may prescribe.

• **Rule 3.02:** All Resolutions and amendments proposed thereto shall be in writing and shall contain the name, parish, and city of the proponent. Failing to meet the deadline as set forth in Title I, Canon 3, Sec. 10 the delegate or organization presenting a Resolution may introduce such Resolutions at the Convention no later than 4:00 p.m. on Friday. Except for Resolutions contained in the reports of Committees, no Resolution offered after this time shall be considered except upon the affirmative vote of three-fourths (3/4) of the delegates present and voting. The delegate or organization presenting a late Resolution is responsible for having 300 copies of the Resolution reproduced on blue paper for distribution to the Convention.

• **Rule 3.03:** The Bishop shall refer all Resolutions to appropriate Convention Committees for consideration, recommendation and report to the Convention provided, however, upon a vote of two-thirds (2/3) of the delegates present, a Resolution may be considered immediately.

• **Rule 3.04:** Where two or more Resolutions deal basically with the same subject, they shall be referred to the same General Resolutions Committee. The Committee shall make every effort to consolidate them or otherwise assure their compatibility and should also make every effort to obtain the concurrence of the proponents concerned.

• **Rule 3.05:** Each Convention Committee to which a Resolution has been referred, after providing for a public hearing thereon, shall consider the form and substance of the Resolution and in making its report shall recommend (a) for adoption, (b) for adoption with amendment, (c) for adoption of a substitute drafted by the Committee, (d) for rejection, or (e) for discharge from further consideration because the subject matter has been included in another Resolution. The Committee's recommendation to the Convention shall be in the form of a motion to adopt the Committee's recommendation. The Committee Chair or other representative shall state the reasons for the Committee's recommendation. Thereafter, the proponent of the original Resolution, which is the subject of the Committee's recommendation, shall be recognized first if the proponent so desires. Amendments may be offered, including an amendment to substitute the proponent's original Resolution for that recommended by the Committee.

## **IV. MOTIONS IN ORDER OF PRECEDENCE**

• **Rule 4.01:** The following motions shall have priority in the order listed. The mover cannot interrupt a member who has the floor, must be recognized, and the motion must be seconded.

They are subject to the following further rules:

- (a) To Adjourn or to Recess
  - (1) Not debatable, if unqualified
  - (2) Not amendable
  - (3) Cannot be laid on Table
  - (4) Majority vote

(5) The motion to adjourn shall always be in order except that it shall not be offered when another member has the floor

- (b) To Adjourn to Time Certain
  - (1) Debatable, as to the time
  - (2) Amendable, as to the time
  - (3) Cannot be laid on table

- (c) To Lay on Table or To Table
  - (1) Not debatable
  - (2) Not amendable
  - (3) Cannot be laid on Table
  - (4) Majority vote
- (d) To Vote Immediately or at Time Certain or to Extend Debate
  - (1) Not debatable
  - (2) Amendable, as to time, if a time specified
  - (3) Cannot be laid on table
  - (4) Two-thirds majority vote
- (e) To Postpone to Time Certain
  - (1) Debatable
  - (2) Amendable as to time
  - (3) May be laid on Table
  - (4) Majority vote
- (f) To Commit or recommit to any Committee
  - (1) Debatable, except as to a Convention Committee
  - (2) Amendable as to the Committee to which to be sent
  - (3) May be laid on Table
  - (4) Majority vote
- (g) To Amend or To Substitute
  - (1) Amendments and Substitutes are debatable only when Main Question is debatable

(2) One Amendment may be made to each independent or separable portion of a Resolution; and the right to amend extends only to one Amendment of that Amendment and to a Substitute and one Amendment thereto

(3) A Substitute and its Amendment may be laid on table, but cannot be otherwise voted on until original matter if perfected

(4) Majority vote

(5) Neither the Substitute nor its Amendment shall be voted on (except to lay on the table) until the original matter is perfected.

# **V. MOTIONS WITHOUT ORDER OF PRECEDENCE**

• Rule 5.01: The following motions have no order or priority but are subject to the following rules:

- (a) Appeal from Decision of Chair
  - (1) Debatable
  - (2) Not amendable
  - (3) May be laid on table
  - (4) Majority vote. A tie vote sustains Chair
  - (5) Must be made immediately after decision
- (b) To Take from Table
  - (1) Not debatable
  - (2) Not amendable
  - (3) Cannot be laid on table
  - (4) Majority vote
- (c) To Recall from Committee
  - (1) Debatable
  - (2) Amendable

- (3) May be laid on table
- (4) Two-thirds majority vote
- (d) To Create Special Order of Day for a Particular Time
  - (1) Debatable
  - (2) Amendable as to time
  - (3) Cannot be laid on the table
  - (4) Two-thirds majority vote
- (e) Call for the order of the Day

(1) Mover may interrupt a member who has the floor and is not required to be recognized or to have a second

- (2) Not debatable
- (3) Not amendable
- (4) Cannot be laid on table
- (5) No vote required, but two-thirds majority vote is necessary to suspend general or special order
- (f) To Suspend the Rules or Take Up Business Out of Order
  - (1) Debatable
  - (2) Not amendable
  - (3) Cannot be laid on the table
  - (4) Two-thirds majority vote
- (g) To Divide the Question
  - (1) Not debatable
  - (2) Can be amended
  - (3) Cannot be laid on the table
  - (4) Majority vote, if vote required
  - (5) May be made without being recognized and even though another member has the floor

(6) If the Question under debate contains several distinct propositions, which are independent of each other, at the request of any members the same shall be divided and a separate vote shall be taken but the motion to strike out and to insert shall be indivisible.

(7) The propositions relate to the same subject, and yet each part can stand alone, they may be divided only a regular motion and vote.

## **VI. RECONSIDERATION**

• **Rule 6.01:** Neither a Question once determined, nor one of like import, shall again be brought before the Convention, except on motion to reconsider made by one who voted in the majority and seconded by another who voted in the majority.

• Rule 6.02: Motions to reconsider are subject to the following further rules:

- (1) Debatable when motion to be reconsidered is debatable
- (2) Not amendable
- (3) May be tabled
- (4) Two-thirds majority vote
- (5) No question can be twice considered unless it was materially amended after its first reconsideration

# VII. DECORUM AND DEBATE

• **Rule 7.01:** No member shall be absent from the Convention unless leave has been given by the Chair, or because of inability to attend.

• **Rule 7.02:** No member shall address the Convention or make any motion until after recognition by the Bishop except to make a parliamentary inquiry, a point of order or a motion not requiring recognition.

• **Rule 7.03:** When any Delegate is about to speak, the Chair shall be addressed, the name, parish of the Delegate stated; such address shall be confined strictly to the point of debate.

• Rule 7.04: Except by leave of the Convention, no Delegate shall speak more than twice in the same debate nor longer than five minutes at one time.

## VIII. VOTING

• **Rule 8.01:** Nominations for Standing Committee, members of the Bishop and Council, Trustees of the University of the South, members of the Disciplinary Board and General Convention Deputies and Alternates, which are in writing and contain the nominee's name, parish, and city and not more than one hundred words of biographical information including past and present service of the nominee to the Church at all levels and received in the office of the Secretary thirty days prior to the opening of the Convention shall be included in the Convention brochure. Additional written nominations for these offices may be made by the nominator or nominee filing 300 white copies of the nominee's biographical information with the Secretary by 4:00 p.m. Friday for distribution to the Convention provided, however, that additional nominations for clergy members of the Bishop and Council may be made from the floor at any time after the election of lay members and prior to voting on clergy members. Such nominations for clergy members of the Bishop and Council shall be posted at the Convention. All such nominations shall contain the name, parish, and the city of the nominator who shall obtain the nominee's consent and willingness to serve prior to submitting nomination. Nominations may be made only by the Bishops of this Diocese, Clerical and Lay Delegates, Vestries, and any other person authorized by Canon.

• **Rule 8.02:** Balloting for the offices set forth in 8.01 shall commence not earlier than by 11:30 a.m. on Friday.

• **Rule 8.03:** In elections of Deputies to the General Convention and of Members of the Bishop and Council, a majority of the votes cast shall be necessary to election. In all other elections, including that of Alternate Deputies to the General Convention, a plurality shall suffice. If the Convention shall take up other business while ballots are being counted such business may be interrupted for the report of tellers and additional ballots. If all the Deputies to the General Convention are not elected on the first ballot, the remainder is to be elected from the remaining nominees by majority on the second ballot, and if all not elected on the second ballot, the remainder is to be elected from the remainder is to be elected from the remainder is to be elected from remaining nominees by majority on the shallot, taken.

• **Rule 8.04:** Unless otherwise expressly provided any rules requiring a two-thirds majority shall be construed to mean the affirmative vote to two-thirds of the Delegates present and voting.

• Rule 8.05: Ballots with more or less votes than there are positions to be filled shall be declared invalid.

## IX. COMMITTEE OF THE WHOLE

• **Rule 9.01:** Whenever so ordered by a vote of a majority of the members present, the Convention may go into Committee of the Whole for the consideration of any matter.

# X. UNANIMOUS CONSENT

• **Rule 10.01:** By unanimous consent, any action may be taken that is not in contravention of any provision of the Constitution or the Canons.

## **XI. GENERAL REGULATIONS**

• **Rule 11.01:** Except with the express permission of the Bishop or when otherwise ordered by majority vote of the Convention, no books, pamphlets or other printed matter may be distributed on the floor of Convention, or be placed on the seats or desks of the Delegates; but this prohibition shall not apply to Resolutions, reports, and other documents prepared or distributed by the Secretary or to ballots for elections.

## XII. ROBERT'S RULES OF ORDER

• **Rule 12.01:** Except when in conflict with the Constitution or Canons, or any Rules herein contained, the latest edition of Robert's Rules of Order shall govern the interpretation of Rules and procedures to be followed.

# XIII. AMENDMENTS

• **Rule 13.01:** These Rules may be amended at any time by a two-thirds majority vote of the members present.
