Friday, February 7, 2015 Opening Session

Call to Order

Right Reverend George Dibrell Young, III called the 31st Convention of the Diocese of East Tennessee to order at 10:00 AM on Friday, February 7, 2015.

Opening Hymn and Prayer

He invited all to stand and sing "The Great Commission" accompanied by Brother Christopher Buckley.

Bishop George invited RJ Powell, postulant for holy orders, to come forward to lead us in prayer: Almighty and ever living God, source of all wisdom and understanding, be present with those who take counsel her today in the Diocese of East Tennessee for the renewal and mission of your Church. Teach us in all things to seek first your honor and glory. Guide us to perceive what is right, and grant us both the courage to pursue it and the grace to accomplish it; through Jesus Christ our Lord. Amen.

Opening Remarks

Bishop George reminded the Convention that all had access to wifi in the convention hall and that they might "tweet" about the events happening here at #ETCONV2015. He pointed out that the most current schedule was on "goldenrod" colored paper.

Convention Theme

Bishop George spoke about the Convention theme, *Mission: Possible!* He stated that our focus would be on mission projects and activities around the Diocese. We would be viewing several examples in videos shot by Alex Haralson. Descriptions of these projects are on page 40 of the Convention booklet.

Mission:Possible Ministry Moment (video): "Snowy Art Day"

Bishop George introduced the first of several videos focusing on mission activities around the Diocese. The first video is entitled: "Snowy Art Day" which features an outreach activity for kids sponsored by St. Joseph the Carpenter in Sevierville.

Introduction of Convention Keynote Speaker

Bishop George introduced The Rev. Dr. Dwight Zscheile, the Convention speaker. He is the author of two books, <u>People of the Way</u> and <u>The Agile Church</u>. He is a priest, a professor of congregational development at Luther Seminary in Minneapolis, MN and also serves at St. Matthew's parish with his wife, The Rev. Blair Pogue, who is the rector there. Bishop George noted that we have been reading his first book in preparation for this convention and his presentations here. His second book is available in the Exhibit Hall at the Cathedral Bookstore table.

Welcome – Host Parish

Bishop George called upon The Rev. Canon Chris Hackett to offer a welcome to the Convention from the Cathedral of St. John's, our Convention host parish.

Report of the Committee on Credentials - Quorum

Bishop George called on Vice Chancellor Chris Cone, chair of the Committee on Credentials, to report on the numbers in attendance, to assure that a quorum was present. Vice Chancellor Cone requested a round of applause for the registration volunteers. He then reported the following:

A quorum was present.

Vice Chancellor Cone reviewed the offices for which we would be electing this year. He noted the offices that nominations from the floor could still be accepted. He reminded clergy and delegates that nominations for these positions could be made from the floor until 4:45 PM this evening. Nominators should insure that the candidates are in agreement with the nomination, are communicants in good standing in their parishes and need to provide 300 copies of their photo and bio.

Elections

Bishop George asked the Convention to approve the Convention officers, as follows: Secretary: The Rev. Canon Patricia Grace; Assistant Secretary: Ms. Laura Nichols; Treasurer, Assistant Treasurer: Mr. Ron Moore, Ms. Merry Keyser; Chancellor: Ms. Sarah Sheppeard; Vice Chancellors: Mr. Chris Cone, Mr. Tom Peters, The Hon. Neil Thomas, The Hon. Marie Williams, Mr. George Arrants, Jr.; Registrar: The Rev. Canon Patricia Grace.

Bishop George noted that Mr. George Arrants was a new chancellor appointed this year.

Motion carried. Convention officers approved.

Appointment of parliamentarians

Bishop George appointed Mr. Tom Peters as Parliamentarian and Ms. Sarah Sheppeard as Assistant Parliamentarian.

Adoption of Rules of Order and Order of Business

The Bishop called on Parliamentarian Peters, who moved that the Rules of Order and the Order of Business (see Section 8) be adopted by the 31st Annual Convention of the Diocese of East Tennessee. The motion was seconded.

Motion carried. Rules of Order and Order of Business adopted.

Bishop George called on the Rev. Taylor Dinsmore, president of the Standing Committee, who presented and moved two Resolutions of Invitation, 2015-01 and 2015-02. (See Section 8). The motion was seconded.

Bishop George introduced Mary Brennan, Officer, Mission Communication, and our Diocesan Partner from The Episcopal Church Center, noting that the Convention would hear from her later on in the agenda.

Elections to Board and Commissions

Bishop George reviewed the list of committees, offices and appointees to be made in 2015. He asked the Convention to elect these as listed in the Convention Delegate booklet. (See Appendix I in this Journal).

Motion carried. Nominees approved.

Reports of Officers, Boards, Commissions and Committees

Bishop George invited the following to come forward and make reports as noted below. The text of these reports can be found in Section 5 of this journal.

Standing Committee: The Rev. Taylor Dinsmore Commission on Ministry: The Rev. Hendree Harrison

Lay Ministry and Congregational Development: Mr. Rick Govan

Mary Brennan, TEC, Officer for Mission Communication/Diocesan Partner was introduced and greeted the Convention in the name of Presiding Bishop Schori. She is part of a new program of diocesan partners, whose goal is to link staff at the Episcopal Church Center with Dioceses in order to determine who to mutually support each others' work. She encouraged the Convention to review the 2015 Report to the Church to learn more about resources and ideas from around the Episcopal Church, which includes 16 countries, 109 Dioceses and 3 regional areas. She has provided materials which list many resources which will be distributed to the tables. She invited the Convention to contact her for any need at mbrennan@episcopalchurch.org

Mission: Possible Ministry Moment (video): "Burrito Party"

Bishop George introduced a second "Mission: Possible Ministry Moment" video. This video centers around Project Canterbury and its new ministry which involves making friends in the neighborhood and sharing a meal and friendship.

The Bishop's Address

Bishop George took to the podium to make his report to the Convention. (See Section 3 for the complete content of Bishop George's address). The Bishop's comments were received with a standing ovation by all the participants in the Convention Hall.

The Rev. Dr. Dwight Zscheile: "Where are we? Life in a New Apostolic Age" Dr. Zscheile offered the first of his three presentations on mission. These presentations were recorded on DVD's and made available to all parishes in the Diocese.

Announcements and Recess for Lunch

The Convention adjourned for a brief lunch as postulant, Freddie Brabson, led the Convention in a sung grace before meals.

Friday, February 6, 2015 Afternoon Session

Convention Reconvened

Bishop George called the convention back to order at 1:15 PM. He invited the gathered body to stand and sing "Won't you let me be your Servant?"

Bishop George explained that there were raffle tickets on each table and door prizes of the East Tennessee Diocesan Youth Council coffee cups and Mission Possible T-shirts would be given away throughout the Convention meetings.

Report of the Committee on Credentials – Quorum

Bishop George called again on Vice Chancellor Chris Cone, chair of the Committee on Credentials, to report on the numbers in attendance, to assure that a quorum was present. Vice Chancellor Cone reported the following:

A quorum was present.

Vice Chancellor Cone reminded the Convention again of the rules for nominations from the floor. He noted that only those with yellow name tags would be given a ballot to vote and suggested that if anyone was a delegate and did not have the proper color nametag, to immediately visit the registration area to correct that issue.

Treasurer's Report

Ron Moore, Treasurer, reviewed the final numbers from fiscal year 2014, which have yet to be audited. We ended the year with a small surplus. He presented and moved Resolution 2015-03 (see Section 8), to approve the financial actions of Bishop and Council in 2015.

Motion carried. Resolution 2015-03 approved.

Mr. Moore reviewed the proposed 2015 budget, as distributed in the pre-convention meetings. He highlighted several accomplishments including the calling of new clergy through the Commission on Ministry and Transition processes, excellent communications information and materials on our website and other social media, and strong support for Grace Point. He noted that in the area of Voluntary Commitments from the parishes, which provides 90% of the Diocesan budget, we are expecting a shortfall of \$65,000. We are committed to living within our means and so we will, unless we can capture more of those dollars, be forced to cut programs, and eliminate the cost of living increase for the Diocesan staff. The Bishop reviewed the formula that is used to develop the amount each parish is asked to provide. He asked parishes that have not pledged to meet that amount to reconsider their amounts in light of the shortfall. Mr. Moore indicated that more extensive discussion would be undertaken in the hearing later on this afternoon and asked interested parties to attend and provide input as desired. The Bishop asked for a vote of acclamation to accept Mr. Moore's report.

Treasurer's Report was approved by acclamation.

Reports of Officers, Boards, Commissions and Committees

Bishop George invited the following to come forward and make reports as noted below. The text of these reports can be found in Section 5 of this journal.

Southside Abbey: The Rev. Bob Leopold Youth Ministry: DCYM, Mr. Alex Haralson Grace Point: The Rev. Brad Jones

Bishop George requested that parishes consider increasing support for scholarships for campers at Grace Point. He is especially looking for sponsors for the Outreach Camp, which enables kids who would not have the opportunity to attend an outdoor residential camp, to do so. A good model is one in which 1/3rd of the costs are paid, in turn, by parish, family and the remainder in a scholarship from the camp. He asked that clergy be advocates for Grace Point and its programs. Bishop George noted that he was deeply spiritually formed by his experiences at his Diocesan Camp, as a young person and that many people have had this same experience. Investing in scholarships is one of the best ways we have to form future faithful Christians and disciples.

Break

Bishop George called for a break until 2:15 PM.

Convention reconvened at 2:15 PM.

The Rev. Dr. Dwight Zscheile:

"Who Are We? Renewing Episcopal Identity"

The Rev. Dr. Zscheile offered the second of his three presentations on mission beginning with comments and questions from the Convention.

Break

Bishop George called for a break from 3:30 - 3:45 PM.

Convention reconvened at 3:45 PM.

Report of the Committee on General Resolutions and Last Call for Resolutions

Bishop George called on The Rev. Kim Hobby, Chair of the General Resolutions Committee, to report. Rev. Hobby noted that the general resolutions being considered at this Convention could be found on pp. 35-36 in the Convention booklet. 2015- 04 was proposed by the Rev. Lou Parsons and concerns showing gratitude for the service we receive at this hotel. Resolution 2015-05 was sponsored by The Rit. Rev. George D. Young, III in honor of Herb Berl. She noted that Bishop George will be presenting that resolution later in the agenda. Rev. Hobby noted that resolutions could be submitted by clergy, delegates and others as specified in the canons by 4:45 PM on that afternoon. She stated that these resolutions and any amendments would be discussed in the hearings this afternoon at 5:00 PM. She reminded clergy and delegates that there would not be the opportunity for that kind of discussion on the Convention floor when the resolutions came up for a vote.

Report of the Elections Committee and Last Call for Nominations

Bishop George called Vice Chancellor George Arrants, Jr., to report on Elections. He reported that nominations will close this afternoon at 4:45 PM including nominations from the floor. Nominees from the floor need to submit 300 copies of their biographies and photos. There are other requirements. Mr. Arrants invited those who are interested to consult him.

Reports from Diocesan Groups

Bishop George invited representatives of the following groups to come forward to present reports, given that we had some additional time this afternoon on the schedule.

Pilgrimage to the Holy Land (October 2015): Lynn Lantz and the Rev. Canon Pat Grace reported on the upcoming Diocesan pilgrimage to the Holy Land. Lynn is a Trustee of the American Friends of the Episcopal Church of Jerusalem. She is available in the exhibit area with detailed information on this first ever Diocesan trip. This will not be a tourist trip, but rather a spiritual adventure and journey. All who are interested should contact her or the Rev. Canon Grace for information. There will be walking involved in the pilgrimage, but there are ways for folks who have access issues to participate.

The Children's Nutrition Program of Haiti: The Rev. John Talbird showed a brief video and provided information on the Children's Nutrition Program of Haiti. He

described our long term commitment (since 1998) to children and their families in Haiti with excellent results in regard to malnutrition in children and the larger population. They do so by fighting malnutrition, empowering women, micro-enterprises, and develop communities by water, sanitation and hygiene. They listen to and work with the local people in making their own community stronger. They wish to hire an Executive Direction in 2015 and begin to work in the urban areas in addition to their work in the mountain region where they are now. John and other volunteers are available for further information in the exhibit area. Bishop George recommended that the Convention read the book, *Toxic Charity*, to learn more about the approach that is used by our brothers and sisters there.

St. Mary's – Sewanee: The Rev. John Runkle, Executive Director, brought the Convention up to date on new offerings and programs at St. Mary's Retreat Center in Sewanee.

Bridge Refugee Services: Simone Walton and Katie Weber provided a brief video about the Bridge program and information about the refugee ministry operated in East Tennessee in conjunction with Episcopal Migration Ministries. This is a ministry of welcome and of presence which is an excellent opportunity for multi-generational groups. Bishop George noted that it is important to support this ministry with dollars, but also with people to build relationships with people who have come as refugees to our country.

Announcements

Bishop George asked that Convention participants take their convention booklets and belongings with them so that tables may be set for dinner. He reminded folks to bring their meal tickets to the banquet and place them in front of them on the tables. Dinner is open seating. He encouraged parishes to break up and get to know new people by sitting with folks they don't know. Bishop George asked that all plan to check out of hotel rooms and place bags in the car before beginning tomorrow's events, if possible. The hotel's check-out time is at 12 noon. He noted where the hearings will be held. He reminded all of the reception at 6:00PM in the Tennessee Ballroom and dinner at 6:45 pm. He also announced a brief meeting of General Convention Deputies to be held at 5:30 PM in Parlour 4.

Closing Prayer and Recess

Bishop George invited Mr. Jon Hermes, a postulant for Holy Orders in the non-traditional preparation program, to come forward to close this session of the Convention business to a close: O God, you have made of one blood all the peoples of the earth, and sent your blessed Son to preach peace to those who are far off and to those who are near: Grant that people everywhere may seek after you and find you; bring the nations into your fold; pour out your Spirit upon all flesh; and hasten the coming of your kingdom; through Jesus Christ our Lord. Amen.

The Convention was in recess until 8:45 AM on Saturday, February 8, 2015.

Dinner

Ms. Sarai Wender, candidate for the diaconate, offered prayers over the meal: O God bless this food we are about to receive. May we share it in peace and love. Give daily bread, O Lord, to those who hunger, and give a hunger for justice to those of us who have such an abundance of daily bread. Through Jesus Christ, our Lord. Amen.

The Rev. Taylor Dinsmore introduced journalist, humorist, storyteller and faithful Episcopalian, Sam Venable, who entertained the gathered community in true East Tennessee style!

The Diocesan Youth Ministry Team led the gathered body in Night Prayer and singing.

Saturday, February 8, 2015 Morning Session

Convention Reconvened

Bishop George called the convention back to order at 8:45 AM on Saturday, February 8, 2015. He invited the gathered body to stand and sing "I want Jesus to walk with me."

He called on Mr. Boyd Evans, candidate for the priesthood, to open us with prayer: O God, by your grace you have called us in this Diocese to a goodly fellowship of faith. Bless George, our Bishop; John Rouser, who is to be ordained a deacon today; all other clergy, and all our people. Grant that your Word may be truly preached and truly heard, your Sacraments faithfully administered and faithfully received. By your Spirit, fashion our lives according to the example of your Son, and grant that we may show the power of your love to all among whom we live; through Jesus Christ our Lord. Amen.

Mission:Possible! Ministry Moment – "Battle Academy – St. Nicholas Day" This video illustrates a collaborative holiday event which included folks from Southside Abbey, Trinity Lutheran, St. Francis - Ooltewah, and Battle Academy; with help from the Bethlehem Center, Burks United Methodist, Resurrection Lutheran and Ascension Lutheran. This was a day of food, gifts, and fellowship with people who live in a nearby hotel with whom these churches work – and live and have developed friendships.

Bishop George shared the following announcements:

- The Rev. Steve White will be moving to Kingsport, TN, to become Priest-in-Charge at St. Paul's.
- The Rev. Canon Pat Grace will be the preacher for the Convention Eucharist.

The Rev. Dr. Dwight Zscheile:

"Where do we go from here? Embracing Agility"

The Rev. Dr. Zscheile offered the last of his three presentations on mission.

Following The Rev. Dr. Zschiele's presentation, the Rev. Kim Hobby asked to be recognized in order to present a special resolution of appreciation for Dwight's work among us and the inspiration for action that he has instilled in us. Bishop George noted that this called for a suspension of the Order of Business, and asked for a vote to approve that option. The motion carried. Bishop Young called Rev. Hobby forward. She presented Resolution 2015-06 which was approved unanimously by acclamation. (See Section 8)

Convention reconvened at 10:15 AM.

Mr. Arrants moved that The Rev. Jay Mills, the Clergy nominee for Standing Committee be elected by acclamation as he is running unopposed.

Motion carried. Rev. Mills elected by acclamation.

Mr. Arrants directed the Convention to cast their votes for the lay candidate for Standing Committee.

Mr. Arrants moved that that Mr. Chris Cone, the nominee for Trustee, University of the South, be elected by acclamation as he is running unopposed.

Motion carried. Mr. Cone elected by acclamation.

Mission: Possible Ministry Moment (video): "A seed is planted"

Bishop George introduced the last of the "Mission:Possible" videos. The video, entitled, "Marching for CASA" features members of St. Luke's in Cleveland participating in a midnight march fundraiser for the Court Appointed Special Advocates program.

Presentation and adoption of 2015 Budget

Mr. Ron Moore was called forward to present the finalized 2015 Diocesan budget. There had been no changes made in the budget hearing. A lengthy discussion ensued concerning the cost of living increase for Diocesan staff, which had been cut from the budget this year. Mr. Daniel Beeler, St. Alban's Hixson, spoke about his disappointment with that decision. He made a motion to refrain from cutting the increase at this point, giving the Bishop and Council the ability to reduce it further along in the year, if needed. The motion was seconded. After a verbal vote was inconclusive, the Bishop asked for a show of hands. The motion did not carry.

The Rev. Bo Lewis, retired, made a new motion, to take the cost of living increase from the emergency fund (which is funded by excess revenues in prior years). The motion was seconded. Again, a lengthy discussion ensued. Mr. Kirby Purjet, Diocesan Administrator, expressed a concern about taking ongoing expense items from excess revenues, which over time, will prove to be a poor strategy. The Bishop called for a show of hands vote. The motion did not carry.

Hearing no other discussion, Mr. Moore He asked for a motion to approve the 2015 Budget as presented (and placed on the tables) this morning.

Motion carried. 2015 Budget approved.

Report of the Committee on General Resolutions

The Rev. Kim Hobby was called forward to present the finalized general resolutions.

She presented Resolution 2016-09 as amended in the hearing on 2/5/16. The amended text of the resolution can be found in Section 5.

Rev. Canon Robert Hartmans requested a point of order, asking if a ballot could be provided for the delegate from Project Canterbury. The ballot was provided.

Motion carried. Resolution 2016-09 adopted.

Bishop George asked Mr. Herb Berl, who had recently retired after many years as Deputy for Stewardship (which was a volunteer position) to come forward. He read Resolution 2015 -05 in its entirety and asked the Convention to show it appreciation for Herb and his work with a standing ovation. The Convention enthusiastically agreed! to the Thirty-first Annual Diocesan Convention

The Rt. Rev. George Dibrell Young, III Fourth Bishop of the Diocese of East Tennessee

BISHOP'S ADDRESS – 31ST ANNUAL CONVENTION: Feb. 6, 2015

Good morning!

Welcome to the 31st Annual Convention of the Episcopal Church in East Tennessee! It is good that we are here.

Thank you for making the time, effort, and expense to be here; I know it is significant, and I am very grateful.

We created a short mission statement a few years ago for all of our conventions, and it is: "celebrating, inspiring, and equipping".

All that we do over these next two days should connect with those.

CELEBRATING, INSPIRING, EQUIPPING – doesn't that sounds like a good way to spend this time together?

And – a good way to be the Church?

I want to take a moment to say "thank you" to the incredible staff colleagues I work with. Every Sunday when I visit your parishes, I say:

"I bring you greetings from the Diocesan Staff. Sometimes when people think of "the diocese" they think of those of us who work at Diocesan House. But "we" are not the diocese - YOU and the 50 or so other parishes and worshipping communities in this part of the state – YOU are the Episcopal Church in ETN."

Some holidays and special time with my family

I share all of this not to whine or gloat – but to let you know what I'm up to, and to say that all of these "meetings" are not boring wastes of time, but are time spent with incredible, passionate, committed leaders of the diocese. Wow!

So – is all this activity "missional"?

In terms of Dwight Zscheile themes – am I stuck in "establishment" mode? I'm trying not to be. I need your help – and I'm grateful I can depend on it!

I **always** tell people who ask about the diocese – we are unburdened by the layers of heavy tradition that burden many dioceses.

We are much more flexible and agile than most – in some ways because we're young – 30 years young – and also because of the great spirit and freedom of you who are the church.

2 years ago – Our theme was "Send Us Out With Gladness and Singleness of Heart" – about mission – being "sent out" 5MM

Last year – "Proclaim the Good News of the Kingdom"

This convention: "Mission: Possible!" Maybe a clue as to our priorities!

2 years ago, I quoted several times from Dwight Zscheile's book, <u>People of the Way</u>; (I mispronounced his name then – badly; I apologize!)

I heard him give a presentation at Kanuga a few years ago, and he was very inspiring (and equipping and celebrating) in presenting about our history of TEC, where/who we are now, and what our opportunities are for the future.

We have given each of you a copy of this book, you have read it, and now we get to hear from the source – Dwight Zscheile himself.

Dwight will make 3 presentations with us this convention, and he will provide the heavy lifting as far as our theme.

And so - I am feeling free to make my address a bit different.

I want to share with you about what matters to me.

What really matters: as a follower of Jesus; as a member of my family; and as a minister of the Gospel.

I've been using that phrase more often lately – a "follower of Jesus" to describe myself. A couple of years ago I read of a priest who no longer uses the label of "Christian" for himself.

His point is that this label carries a great deal of assumption and projection – most notably for people outside of the church – that he does not want to claim.

So, he describes himself as "a Monday through Saturday follower of Jesus who worships on Sunday".

I like claiming the identity as a FOJ – which is essentially what we mean by "Christian" isn't it?

It implies less about what we think and hold dear – or what positions we hold - and more about who we are, what we do, and how we live. I like that.

I heard some recorded music at a Happening weekend recently that I instantly adored. It was an album called "For the Living of these Days", by Kate Campbell, and I immediately bought the album.

One song I love is "Would they love him down in Shreveport?"

If they saw Him riding in, long hair flying in the wind, Would they love Him down in Shreveport today? If they heard He was a Jew and a Palestinian too, Would they love Him down in Nashville today?

If they saw Him talk with ease
To the junkies, whores, and thieves,
Would they love Him out in Wichita today?
Would the rich men think it funny
If He said give up your money?
Would they love Him up on Wall Street today?

If He made the wine from water, Gave it to their sons and daughters, What would the folks in Salt Lake City say? If He talked of brotherhood As He walked their neighborhoods, Would they love Him up in Boston today?

Oh, If He said love those who use you,
And forgive those who abuse you,
If He turned the other cheek, what would you say?
Would you laugh and call Him crazy,
And just send Him on his way,
If He walked right into your town today?

Would you laugh and call Him crazy, And just send Him on his way, If He walked right into your town today?

And then - as I listened to the whole album, I heard a hymn that I've probably sung 1000 times – "God of Grace and God of Glory"

And the first line of the third verse just jumped off the speaker at me, and hit me like a 2x4:

"Save us from meek resignation to the evils we deplore."

To be honest, in that moment - it took my breath away and brought an ache to my heart and tears to my eyes.

Sitting there, I asked myself:

How often is my response to the challenges in my life, to the struggles around me, to the evils I deplore – **meek resignation?**Dear God!

Every year on MLK Day, while many people focus on his "I Have a Dream" speech, I look at the "Letter From a Birmingham Jail" (1963) - especially because it is directed at religious leaders – specifically while clergy.

The contemporary church is so often a weak, ineffectual voice with an uncertain sound. It is so often the arch supporter of the status quo. Far from being disturbed by the presence of the church, the power structure of the average community is consoled by the church's often vocal sanction of things as they are. But the judgment of God is upon the church as never before. If the church of today does not recapture the sacrificial spirit of the early church, it will lose its authentic ring, forfeit the loyalty of millions, and be dismissed as an irrelevant social club with no meaning for the twentieth century. I meet young people every day whose disappointment with the church has risen to outright disgust. (MLK, B'ham Jail - 1963)

Wow – strong stuff!

Last June, Kammy and I had the great privilege of going to a national Episcopal Clergy Couples' conference. She has a colleague/friend whose doctoral work is about clergy couples, and has a subgroup about clergy couples where one is a bishop.

I believe there are 7 of us now.

We have several clergy couples in the diocese, and there are many more in the church today than most of us would guess. Our guest, Dwight Zscheile's spouse is a priest as well – so we're all over!

There are issues and dynamics with clergy couples that are distinctive and significant, and there are issues and dynamics that can come up when one becomes a bishop - that are especially distinctive and significant.

This conference gave me a unique opportunity to share some of my story. I told them about our years in seminary – sharing equally in all aspects of our life together; and about our 20+ years of priesthood – being equal partners in our home life, parish life, community life, and diocesan life.

Then – the issues of equality took a turn.

I told them how I felt intrigued and excited – even called - as I originally looked at the profile for ETN.

I told them how swept up I got in the excitement of it all, and didn't carefully consider the costs for me and my family.

I told them how I didn't pay attention to lots of dynamics, assuming that since we were different – we could live into this differently.

I told them how I wanted Kammy to preach at my ordination, but we were told that if a spouse of a bishop loves her/his spouse they should keep a very low profile, and not serve a parish in the diocese, and that preaching at the ordination was a bad idea.

I told them how people made assumptions/projections about the two of us;

I told them how one day we were equals, and the next day I was placed on a pedestal and Kammy was often treated as invisible.

Listening to the stories of these good and faithful people, and examining my own life, I became even more aware both of my own privilege – as a white, straight, middle class, educated man, and – of the inequality in our church and world.

Almost every Sunday, I lead congregations in the renewal of the Baptismal Covenant. The last question I ask is, "Will you strive for justice and peace among all people, and respect the dignity of every human being?"

What does it look like to "strive"?

And - what is "justice"?

Last summer, I attended a 5 day training session for an organization called DART, which is a justice ministry organization.

Kammy had been a key leader with the Jacksonville, FL DART affiliate, and had seen great strides in the broad religious community coming together to work for justice in their community.

In fact we are now doing preliminary work to discern about creating a justice ministry in Knoxville.

One of the things they teach you in justice ministry is that there are 2 kinds of power to change our communities: the power of money and the power of people. The church doesn't have lots of money, but we sure have lots of people. And we have power.

Martin Luther King, Jr's 1967 speech - "Where Do We Go From Here?"

"One of the great problems of history is that the concepts of love and power have usually been contrasted as opposites, polar opposites, so that love is identified with a resignation of power, and power with a denial of love.

But power without love is reckless and abusive, and love without power is sentimental and anemic.

Power at its best is love implementing the demands of justice, and justice at its best is love correcting everything that stands against love."

We have power, we have people, and we have love. Lots of love. Tons of love. So – what will we do? Face the world with meek resignation? I hope not. I pray not.

How about: striving for justice and peace, respecting the dignity of all people, seeking and serving Christ, loving our neighbors as ourselves, proclaiming the Good News of the Kingdom, persevering in resisting evil, repenting and returning to the Lord, continuing in the apostles' teaching and fellowship, in the breaking of the bread, and in the prayers?

Verna Dozier, great lay preacher and author said, "Don't tell me what you believe; tell me what difference it makes that you believe"

What difference does it make that you and I believe?

Does it make a difference – in the ways we live in our neighborhoods and in the world?

Sister Joan Chittister – in a reflection about prayer, writes, "The main problem with our prayer is that we pray as if God were absent."

Think about that for a moment – we do, don't we?

As if God were somewhere far away – up in the clouds, the heavens.

My friends - The Word has become flesh – and moved into the neighborhood. God is close – right here.

What difference will that make to us?

These days, many people in struggling congregations ask the question, "can we, will we survive?"

That's the wrong question!

We mustn't worry about surviving – we must concern ourselves with thriving. LIVING!

God has a mission, and God has a church for that mission – and that's you and me. Is that mission possible?

Will we accept it?

(hum M:I theme)

Bishop Barbara Harris said it pretty well - "The challenge ahead of you does not compare with the grace and power behind you."

O God ---

Save us from meek resignation:

to the evils

to the challenges

to the disappointment

to the injustice

to the inequality and prejudice

to the ambiguity;

to all the evils – we deplore.



Grant us wisdom, grant us courage – for the living of these days. For the living of these days. Amen.

Report of the Standing Committee of the Diocese of East Tennessee to The Thirty-First Annual Convention of the Diocese

Each year it is the duty and the privilege of the Standing Committee to report to the Diocese. The Standing Committee serves as a council of advice to the Bishop – advice which he may solicit or advice which we may offer on our own initiative. We are grateful for the open and honest relationship we have with Bishop Young.

The Standing Committee has several canonical duties, among which are:

- We must consider whether to consent to the ordination and consecration of any person elected Bishop anywhere in the Episcopal Church.
- We must meet with any postulant for Holy Orders in the Diocese and vote to affirm that each has met all requirements before the Bishop may declare that person is a Candidate for Holy Orders.
- We also must act to approve the ordination to the Diaconate and again to the Priesthood of any person seeking such ordination.
- Any proposed acquisition, sale or encumbrance of Church property in the Diocese has to have the approval of the Standing Before it may occur.

All real property of any Church or Church agency in the Diocese is held in trust for the Diocese. To any who are contemplating the acquisition, alienation or encumbrance of any Church property in the year 2015, please acquaint yourselves with the relevant Standing Committee Policies (available on the Diocesan Website) so that you and we may act expeditiously and timely. This year the Standing Committee facilitated the sale of a vacant lot adjacent to the former church property of St. Mark's in Dayton.

The Standing Committee schedules a monthly meeting, but we actually meet only in those months when there is business which requires our attention and action. There is also a formal procedure (now posted on the Diocesan Website) for meeting electronically when urgency requires it. Consult the Diocesan Website for the monthly meeting day.

Another duty of the Standing Committee is to devise and accomplish a process by which the Diocese of East Tennessee may conduct a review of the ministry of the Diocese over the past year. The task is to *review our ministry as Diocese*; it is *not* a job performance review of the Bishop.

This was our first year to implement this process and we hope that in the future we can make our process it available for use in other dioceses as well. The results of the Mutual Ministry Review were then shared with Bishop and Council for review.

Let me here acknowledge the good work this year of the six members (three lay and three clerical) of the Standing Committee, and my admiration for and appreciation of them. They are Ms. Andrea Odle (who serves admirably as Clerk), Ms. Christopher Robinson, and Mr. Jim Shearouse – all from Chattanooga; and the Rev. Peter Keese (Knoxville) and the Rev. Joseph Minarik (Norris). I have been privileged to work with them and glean from their expertise to serve as President this past year.

Report of the Commission on Ministry to the 2015 Convention of the Diocese of East Tennessee

The Commission on Ministry (COM) consists of 15 people, lay ministers, priests, and deacons, who assist the bishop with "the determination of present and future opportunities and needs for the ministry of all baptized persons" in the Diocese of East Tennessee. A primary function of the COM is to facilitate the discernment process for East Tennessee Episcopalians who are discerning a call to ordained ministry.

The Commission on Ministry met 7 times in 2015, facilitated a discernment retreat for postulants in November in Loudon, Tennessee at the Episcopal Church of the Resurrection, and participated in a provincial meeting in Birmingham in May.

The COM seeks to continually encourage all Christ-followers to enter into discernment activity around call to ministry as all the baptized are indeed ministers! The COM is thrilled to support the ministry of Deputy Rick "DJ Ringo" Govan whose work is to spread the empowering message that all baptized people are ministers in the church. Rick's efforts and leadership in discernment and training for ministry bear fruit year after year, and we are all so grateful.

The COM encourages the clergy and lay leaders of our diocese to entertain discernment conversation, prayer, and activity with all the baptized all the time.

The COM has developed a discernment calendar (on the web now) to help guide formal discernment conversation and activities with the COM. As you know, the bishop gives the "go-ahead" for aspirants to ordained ministry to begin COM-supported local discernment work beyond Clergy/Aspirant conversations. The window of time for clergy and aspirants to communicate with the bishop about potential aspirants to ordination is September 1st - December 1st.

At present the Episcopal Diocese of East Tennessee has 19 people on the journey to ordination. We have 1 candidate for the priesthood, 12 priest postulants, 5 deacon postulants, and one deacon candidate to be ordained at this convention! In addition, we have 10 aspirants working on discernment at the parish level.

The COM invites your prayers for these folks as they make their way.

Report to the 31st Annual Convention of the Diocese of East Tennessee February 2015

DuBose Conference Center is the historic retreat and gathering-place of the Episcopal Church in Tennessee, and serves numerous other educational, religious, and arts groups through its hospitality and programming. Our programs include **Camp Gailor-Maxon**, a Tennessee summer camp for Episcopal youth, and **Winterfest**, the annual retreat between Christmas and New Years, for high school age youth. DuBose is also the home of the **Episcopal Churchmen of Tennessee** Annual Conference, the **ECW**, and the **Sewanee Church Music Conference**.

DuBose is a 501(c)(3) non-profit governed by an independent 19-member board of directors, and its property and assets are jointly owned by the three Episcopal dioceses of Tennessee. The three Tennessee bishops each serve as ex-officio members of the Board; the Diocese of Tennessee appoints two other board members while the Dioceses of East and West Tennessee each appoint one board member. BOD Officers in 2015 are Bob Sarratt, President; Connally Penley, Vice President; Elise Dugger, Secretary; and JP Hickey, Treasurer. East TN's bishopappointed representative on the board is Greg Champion of St. Martin's Chattanooga.

The DuBose staff is led by East Tennessee native David Ramsey, Executive Director, a communicant of St. Paul's Chattanooga. He and his wife Sarah have moved to the Mountain and live in Walker House. The leadership team includes Christy Mitchell, Associate Director for Guest Services; Lorrie Coutu, Office Manager; Angela Lanier, Kitchen Manager; Justin Kilgore, Maintenance; and Kim Ware, Housekeeping. In 2015 Lara Wiggins will serve as Director of Camp Gailor-Maxon.

The DuBose Board is in the process of creating a strategic plan for the organization which will help it double revenue by the end of 2020. This plan will give way to a site plan for the buildings and grounds, underwritten by a grant from St. George's Nashville, to make the center sustainable into the future.

DuBose continues to improve its facilities and operations through the generous support of donors, friends, and volunteers. This year, DuBose launched a small capital campaign called *Regeneration* to begin to address some of the most critical physical plan and capital needs. Some recent improvements include: additional counselor rooms on the year-round cabins, new furnishings in Bishop's Hall as well as the cabins, and a new more efficient hot water system in Claiborne Hall. DuBose has become more eco-friendly with campus-wide recycling.

Episcopal Appalachian Ministries

Since the leadership of the Episcopal Church called on the Appalachian bishops to develop a program in response to Appalachian poverty over 45 years ago, Episcopal Appalachian Ministries has been responding. The resulting network of Episcopal ministries has existed under three different names: Appalachia South, Appalachian Peoples Service Organization and now Episcopal Appalachian Ministries. EAM's office is now located in Kingsport, TN in the Diocese of East Tennessee.

EAM continues to fulfill the response to domestic poverty by the Episcopal Church in Appalachia. Through our broad programs of education, advocacy and mission, we are ministering to the needs of Appalachia at a grass-roots level. We do this through our mission programs of sponsoring summer work camps in various parts of Appalachia. In addition to this EAM has the Small Grants Initiative in which money is granted to ministries to help them with start-up costs. EAM also is active in helping sponsor conferences and training programs that help individuals and parishes ministering to the needs of Appalachian people. EAM is missional in its focus.

In 2014, there were 13 Small Grants awarded to grass-roots ministries providing services to Appalachians. Three of these grants awarded in 2014 went to ministries within the Diocese of East Tennessee. We continue to have an abundance of applicants. Over-all, there were 15 different organizations that applied for grants in 2014. The EAM board is exploring ways to enhance this vital program and look for ways to add additional funding to the Small Grants Program.

Episcopal Appalachian Ministries continues to minister to the needs of this unique region called Appalachia. The focus of EAM continues to be supporting grass-roots ministry efforts within the region through the Small Grants Initiative, Workcamps, The Mountain Grace Conference and the various other networking efforts. Besides the programs mentioned above, EAM continues to promote and assist in helping people network and find opportunities to serve within the Appalachian Region; for example, helping to promote the Reading Camps program started in the Diocese of East Tennessee by referring volunteers and leaders from other dioceses to that program.

Financially EAM continues to strive toward good stewardship of its operating funds and the gifts it receives. EAM has significantly reduced the administrative expenses and is continuing to proportionately increase its resources into ministry. EAM continues to be financially "in the black". The Diocese of East Tennessee supports EAM with its commitment of \$2500.00 a year for administrative support.

This "Symposium" grew out of multiple requests for more about this topic following our Fall Ingathering at Grace Point, which was very successful with over 60 women in attendance! The Rev. Michelle W. Bolt was the speaker for the program. After her presentation, there were requests for more information relating to the history of these pioneering women in our church.

One of our Mission projects, The Next Door, is a transitional, step down program for women who have been incarcerated in the State Women's Penitentiary in Nashville. On Sunday evening of January 11th, the ECW Board prepared, served, and enjoyed dinner with the women of this program and we intend to go again soon. This women have made huge strides in turning their lives around and their work to improve is inspiring to us all. Our other Mission Project is supporting our companion Diocese of South Dakota by providing Paschal candles, which are in great demand for the Burial rituals in Episcopal Native American communities.

In April, we look forward to participating in the ECW Tri-Diocesan Conference at DuBose Conference Center April 24th, 25th, and 26th. We are in charge of the Bishops' Reception on Friday evening, for which we are excited! It is always an inspiring program and is a great way to get to know other women in the Church. We share ideas and grow with each other. Flyers for this event are available at the ECW Booth also. We would love to have a large turnout from our East Tennessee Diocese there!

In May, we are planning a Mollie Tucker Tea to support and help grow the scholarship of the same name. Jubilee Ministries Report December, 2014

There were many achievements for the Jubilee ministries as noted below beginning with the Southside Abbey's recognition by the National Church in February.

- 1. <u>Southside Abbey</u> Congratulations!! Approved in Feb, 2014. Celebration delayed due to Bob's sabbatical this summer. We have discussed scheduling the dedication to coincide with a future Bishop's visit.
- 2. <u>Food for the Multitude</u> Visited with Ben Buck, Executive Director November 15, 2014 to see new facilities and to obtain update. An Opportunity grant was put to good use to acquire a new stove and cover expenses for moving other appliances. In addition to many volunteers and seven churches, this ministry has an 8th church to start participating. It serves from 100- 325 meals each Saturday depending on the season. It also conducts 2 yard sales and Christmas giving each year. Kudos to Ben who has been active since 1982.
- 3. <u>Hosanna Community</u> Have visited a few times during year and also attended their annual fundraiser in October, and Christmas party in December. Keeping full occupancy is an ongoing problem as some residents' health challenges worsen over time and beyond the care Hosanna staff can provide. Since Ben is on the board, he keeps me updated regularly, and I speak with Susan DiStefano often. They have received Jubilee grants the past three years for the gardens. Many local churches support this ministry and most recently, the St. Alban's men's group has started volunteering to complete many building and grounds projects.
- 4. <u>Chattanooga Community Kitchen</u> Visited with new Executive Director, Jens Christensen on December 1st to hear update on activities, also toured new Family Shelter under construction to open December 15th. This shelter is located in the old medical offices which have been renovated. It has 13 rooms, a common area, laundry, and will be open 24/7. The respite center will become a sleep area for 3rd shift workers. Many local churches and parishioners support this ministry.
- 5. <u>Met-Min</u> Visited with Rebecca Whelchel, Executive Director on December 10th. She advised they lost a large donor this year, but has been able to recoup approximately 60%. Their student program at Brainerd High will be moved to Dalewood Middle next year which is a "feeder" school to Brainerd. A new program for seniors is going extremely well on Wednesdays. Other programs are going well especially with the increased need. (See more details in Rebecca's report.)
- 6. <u>Bradley Initiative for Church and Community</u> has recently "rebranded" themselves. They are now known as "Family Cornerstones" which they feel better defines what they are doing. The vision and mission as well as the programs remain the same. The process for a change of certificate to show the new name is being investigated.

Lay Ministry & Congregational Development Diocesan Convention Report February 6-7, 2015



For many parish families, 2014 was an important year. Several congregations within the diocese are taking significant steps to discern and re-imagine what is now needed to remain or become more vital and relevant in today's culture. Changing values and priorities of the various generations within and beyond the congregation, constantly evolving technological advances, local demographic changes and community needs, and an aging large population with emerging pastoral care needs are some of the challenges and opportunities that parishes are exploring. They are asking, "What might our parish look like five years from now?" "What should it look like?" "What might God have in mind for us within and beyond the walls of the church?" "How do we make that happen?"

Likewise, in partnership with their clergy, more and more laity are experiencing life as actively engaged ministry participants, in contrast to a life as consumers of ministry from the ordained. An increasing number of Episcopalians in this diocese, after having received the recommendation of their priest-in-charge and the endorsement of their vestry, are participating in regional course offerings to become canonically licensed as a pastoral care minister, preacher or catechist. These particular lay ministries – although no more significant than any lay ministry – are especially helpful to the heartbeat of any parish, regardless of its size. Indeed, the more engaged parishioners are as ministry participants, the more vital and fruitful the parish becomes!

This past fall, the diocesan staff hosted a Small Membership Church Gathering at Grace Point Camp and Retreat Center. Small Membership Churches – those with average weekly attendance of 70 or less – represent fifty percent of our diocese's total number of congregations. (This is the national norm.) Throughout the day, an overview of various available diocesan resources were explored including: parish administration procedures and best practices, mutual ministry review techniques, youth ministry resources and strategies, up-to-date communication platforms and techniques for telling our stories, Licensed Ministries opportunities and process, and familiarization with Grace Point facilities and opportunities.

These resources and others, of course, are available to all congregations within this diocese – regardless of size – and parishes are encouraged to contact the diocesan staff whenever we may be of assistance.

THE UNION OF BLACK EPISCOPALIANS 2015 Diocese of East Tennessee Convention Report

Even though our chapter has less than 20 members, 2014 turned out to be a very productive year of ministry for the Union of Black Episcopalians (UBE) in the Diocese of East Tennessee.

We began the year by participating with over 100 members of the Diocese at a breakfast at St. Luke's Church on the M. L. King holiday, and joined with the Knoxville community in the annual M. L. King Parade.

In February for the second year in a row we sponsored a Festival Eucharist for the Absalom Jones Day observance at the Church of the Ascension with the Reverend Dennis Patterson, Jr., from St. Luke's Church in Atlanta, GA as our preacher. Substantial support was provided by the Bishop's Office and from the Church of the Ascension.

On the Feast of Thurgood Marshall, May 20, St. Luke's held its confirmation service, and UBE sponsored a film night the week before. We invited the community to a showing of the movie The Thurgood Marshall Story. Both events were excellent means of inviting the neighborhood to a joyful and meaningful expression of the Episcopal Church.

The Scholastic Chess Camp sponsored by the Union of Black Episcopalians held at St. Luke's this past summer was a roaring success! Twenty-two chess campers, ages 6-16, were taught chess and life skills by four dedicated chess instructors.

The Chess Camp also led to *Chess in the Park* event held on Saturday, September 6 at Krutch Park in downtown Knoxville. The result of this ministry has been the establishment of chess in one of the public schools, Sarah Moore Green, in East Knoxville.

With the Ebola virus outbreak in West Africa, we were able to join with the Liberian Association of East Knoxville to raise funds and medical supplies for Liberia. We hosted the Liberian Association at St. Luke's on UBE Sunday, Sept 7, the Feast Day of Alexander Crummell, Missionary to Liberia, and second black priest of the Episcopal Church, and presented them with our offerings.

We are very pleased that several of our events have received extended coverage by both the print and TV media outlets in Knoxville.

Believing that greater opportunity for ministry awaits us in 2015, this chapter of the UBE will continue to be enthusiastic and vocal in our desire to be "leaven" in and among the people of the Diocese of East Tennessee. We ask for your prayers, affirmation and financial support that God will give us the strength and wisdom to promote solidarity among those of "Ebony Grace" in this Diocese, and that we may be true witnesses of the goodness of the Lord.

DIOCESAN YOUTH MINISTRY Report to Convention 2015

2015 was a big year for youth ministry in The Episcopal Church, headlined by the triennial Episcopal Youth Event, or EYE. This event brings together over 1000 youth and adults from across The Episcopal Church for a week of fellowship and learning, always taking place on a college campus.

EYE 2015 was hosted by the Diocese of Pennsylvania, taking place at Villanova University in Philadelphia. 8 youth and two adults attended EYE, which focused on the 5 Marks of Mission and how to put them into action in the world. EYE was followed immediately by 3 Days of Mission, open to any diocese as a followup to EYE. Province IV dioceses joined together for this event, based at University of Pennsylvania, to take on mission work for the historic Church of the Advocate in downtown Philadelphia. This work included junk removal and repainting projects, help with a community soup kitchen, and work with the neighborhood VBS program. In the midst of the work projects, participants interacted with parishioners and community members to learn about the history of the Civil Rights movement in Philadelphia, of which Church of the Advocate was a central piece (site of the ordination of the Philadelphia 11), as well has the transition of the parish and the neighborhood, which is now seeing some gentrification.

Two youth and two adults also attended the annual Province IV Youth Network meeting, held at Solomon Episcopal Center near New Orleans, LA. This annual gathering allows dioceses from across the province to share ideas and learn from each other. On Saturday of the event, participants took a tour of the Lower and Upper 9th Ward and surrounding areas, through local Episcopal parish, to hear testimonials on the continuing rebuilding efforts years after Hurricane Katrina.

One notable product of conversation at the 2014 provincial gathering is the invitation to send a small team to the Diocese of East Carolina to experience New Beginnings, a spiritual exploration retreat for middle school youth, with the goal of starting the program here in East Tennessee. A team of four, two youth and two adults, will be attending in March of this year in hopes of offering New Beginnings in the 2015-2016 school year.

The Diocesan Council on Youth Ministry is looking forward to a productive 2015, and extends its invitation to ALL parishes in the Diocese of East TN to be part of the good things that are in the works!

INDEPENDENT AUDITOR'S REPORT

To the Bishop and Council of the Diocese of East Tennessee Knoxville, Tennessee

Report on the Financial Statements

We have audited the accompanying financial statements of the Diocese of East Tennessee (a non-profit organization) which comprise the statement of financial position as of December 31, 2014, and the related statements of activities, functional expenses, changes in net assets, and cash flows for the year then ended, and the related notes to the financial statements.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditor's Responsibility

Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In our opinion, the financial statements referred to above present fairly, in all material respects, the financial position of the Diocese of East Tennessee, as of December 31, 2014, and the changes in its net assets and its cash flows for the year then ended in accordance with accounting principles generally accepted in the United States of America.

Our audit was conducted for the purpose of forming an opinion on the financial statements as a whole. The supplementary information, as listed in the Table of Contents, is presented for purposes of additional analysis and is not a required part of the financial statements. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. In our opinion, the information is fairly stated in all material respects in relation to the financial statements as a whole.

NOTES TO FINANCIAL STATEMENT

Year Ended December 31, 2014

NOTE 1 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Organization

The Diocese of East Tennessee (Diocese) is a not-for-profit corporation, chartered by the State of Tennessee. Its purpose is to promote the cause of religion and to establish order and advancement for the Church in the East Tennessee geographical region.

B. Method of Accounting

The Diocese's books and records are maintained on the accrual basis of accounting. Under this method, revenues are recognized when earned regardless of when received, and expenses are recognized when incurred, regardless of when paid.

C. Property and Equipment

Property and equipment are carried at cost. Depreciation is computed using the straight-line method over the estimated useful lives of the assets. When assets are retired or otherwise disposed of, the cost and related gain or loss is reflected in income for the period. The cost of maintenance and repairs is charged to expense as incurred; significant renewals and betterments are capitalized. Deduction is made for retirements resulting from renewals and betterments.

D. Financial Statement Presentation

The Diocese uses Statement of Financial Accounting Standards (SFAS) No. 117, *Financial Statements of Not-For-Profit Organizations*. Under SFAS No. 117, the Diocese reports information regarding its financial position and activities according to three classes of net assets: unrestricted net assets, temporarily restricted net assets, and permanently restricted net assets.

E. <u>Estimates</u>

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

F. Contributions

The Diocese uses SFAS No. 116, Accounting for Contributions Received and Contributions Made. In accordance with SFAS No. 116, such contributions are reported as temporarily restricted support and are then reclassified to unrestricted net assets upon expiration of the time restriction. Contributions whose restrictions expire in the period donated are considered unrestricted support.

G. Restrictions on Cash

Cash received from members and other donors for a specified purpose is designated as temporarily restricted or permanently restricted until it is used for the specified purpose.

NOTES TO FINANCIAL STATEMENT (Continued) Year Ended December 31, 2014

NOTE 1 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

H. <u>Cash Equivalents</u>

The Diocese considers all highly-liquid investments with an original maturity of three months or less when purchased to be cash equivalents.

I. Compensated Absences

The Diocese's policy is to pay for compensated absences when they are taken.

J. Donated Services

The Diocese receives donated services from a variety of unpaid volunteers. No amounts have been recognized in the accompanying statement of activities because the criteria for recognition of such volunteer effort under SFAS No. 116 have not been satisfied.

K. Concentrations of Credit Risk Arising from Cash Deposits in Excess of Insured Limits

The Diocese maintains several bank accounts with three financial institutions. These accounts are insured by the Federal Deposit Insurance Corporation up to \$250,000 at each institution. During the year and at year end, cash balances exceeded the \$250,000 FDIC coverage.

NOTE 2 – RETIREMENT PLANS

A) DEFINED BENEFIT PLAN

The Diocese participates in a defined benefit plan established and administered by the Church Pension Fund of the Protestant Episcopal Church of the United States of America. This fund is available nationally to all eligible clergy and full-time lay employees. The Church Pension Fund, a corporation chartered under the laws of the State of New York, has a board of twenty-five Trustees to oversee its operations. Twelve Trustees are elected at each General Convention to serve six-year terms. The Church Pension Fund maintains records, collects assessments, establishes investment policies, provides benefit estimates, advises clergy on their participation and benefit rights, controls expenses and provides for the payment of benefits. The Church Pension Fund has voluntarily placed itself under the supervision of the New York State Insurance Department which makes periodic reviews. Contributions are essentially eighteen (18) percent for clergy and nine (9) percent for lay staff of eligible salaries, and pension expense charged against income for the year ended December 31, 2014, was \$22,031.

B) DEFINED CONTRIBUTION PLAN

The Diocese participates in a defined contribution plan established and administered by the Church Pension Fund. The assets of the Plan are held by the trustee, Fidelity Management Trust Company. Funding requirements are 5% for the employer, and an additional match up to 4% of the employee contributions. Pension expense charged against income for the year ended December 31, 2014 amounted to \$30,483.

NOTE 3 – CONTINGENT LIABILITIES

In previous years, the Diocese has, to a limited extent, provided land on which congregations have constructed churches. Title to such land remains with the Diocese. On some occasions, third party financing is secured with the land included as collateral. Should the congregation become unable to make the mortgage payments, the Diocese could be held responsible. The extent of these third party loans is not known.

Depreciation expense charged against income for the year ended December 31, 2014, was \$91,577.

NOTE 5 – FAIR VALUE MEASUREMENTS:

The Emergency Fund is a broad base of investments administered and monitored by SunTrust Bank. During 1999, the Diocese's management decided to set up an operating contingency fund and invest excess monies. A separate account has been established to which monies are being deposited and withdrawn periodically as needed to fund operations.

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

NOTE 5 – FAIR VALUE MEASUREMENTS (Continued)

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 1 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The Diocese's investments are held by The Episcopal Endowment Corporation (EEC). The following table presents the fair value of investments which separately represent 31 percent or more of the Diocese's net assets.

Securities with EEC \$ 4,227,313

No Level 2 and Level 3 inputs were applicable to the Diocese.

NOTE 6 – ENDOWMENT FUNDS

The Diocese participates in several endowment funds, none of which have been included in the Diocese's financial statements. Income is recognized when distributions are made from these funds to the Diocese and contributions/transfers are recorded as expense when paid.

The Episcopal Endowment Corporation was established to handle trust funds of the Diocese, its parishes, missions, organizations, and institutions. It is shared by the Diocese of Tennessee and the Diocese of East Tennessee. The investments are directed by a board appointed by the two bishops. These funds are administered by SunTrust Bank of Chattanooga. In August 2014, SunTrust bank notified the Diocese that it would no longer administer the Opportunity and Mission Growth Funds. The funds were turned over to the Diocese and are now administered under the direction of the Diocese and are held at Pinnacle Bank.

The Opportunity Fund and The Mission Growth Fund were established by the Bishop and Council to provide for low interest loans to parishes and missions for expansion and improvements to property. The corpus is used for loans and the income is used to make grants for social ministry and church expansion. Loans and grants are recommended to the Bishop and Council by the Opportunity Fund Committee approximately twice annually. The Funds are administered by SunTrust Bank and a summary of the Funds are as follows:

NOTE 8 – PRIOR PERIOD ADJUSTMENTS

In prior years, the Emergency Fund was the only Fund held by the EEC that the Diocese reported on their financials. The Diocese has chosen to report the full endowments at market value. The investment account has been increased to market value by \$4,218,286.

In prior years, SunTrust Bank held the Opportunity and Mission Growth Funds. As of August 2014, SunTrust transferred the funds to the Diocese. The investment account has been increased by \$4,420,548.

In prior years the Emergency Fund was shown under the Operating Fund. As it is managed through the Transit Fund, the Operating fund has been decreased by \$406,921.

Rules of Order and Order of Business of the Thirty-first Annual Convention of the Diocese of East Tennessee

RULES OF ORDER CONTINUED.....

III. RESOLUTIONS

- Rule 3.01: Resolutions are submitted as the Canons may prescribe.
- Rule 3.02: All Resolutions and amendments proposed thereto shall be in writing and shall contain the name, parish, and city of the proponent. Failing to meet the deadline as set forth in Title I, Canon 3, Sec. 10 the delegate or organization presenting a Resolution may introduce such Resolutions at the Convention no later than 4:00 p.m. on Friday. Except for Resolutions contained in the reports of Committees, no Resolution offered after this time shall be considered except upon the affirmative vote of three-fourths (3/4) of the delegates present and voting. The delegate or organization presenting a late Resolution is responsible for having 300 copies of the Resolution reproduced on blue paper for distribution to the Convention.
- Rule 3.03: The Bishop shall refer all Resolutions to appropriate Convention Committees for consideration, recommendation and report to the Convention provided, however, upon a vote of two-thirds (2/3) of the delegates present, a Resolution may be considered immediately.
- Rule 3.04: Where two or more Resolutions deal basically with the same subject, they shall be referred to the same General Resolutions Committee. The Committee shall make every effort to consolidate them or otherwise assure their compatibility and should also make every effort to obtain the concurrence of the proponents concerned.
- Rule 3.05: Each Convention Committee to which a Resolution has been referred, after providing for a public hearing thereon, shall consider the form and substance of the Resolution and in making its report shall recommend (a) for adoption, (b) for adoption with amendment, (c) for adoption of a substitute drafted by the Committee, (d) for rejection, or (e) for discharge from further consideration because the subject matter has been included in another Resolution. The Committee's recommendation to the Convention shall be in the form of a motion to adopt the Committee's recommendation. The Committee Chair or other representative shall state the reasons for the Committee's recommendation. Thereafter, the proponent of the original Resolution, which is the subject of the Committee's recommendation, shall be recognized first if the proponent so desires. Amendments may be offered, including an amendment to substitute the proponent's original Resolution for that recommended by the Committee.

IV. MOTIONS IN ORDER OF PRECEDENCE

• Rule 4.01: The following motions shall have priority in the order listed. The mover cannot interrupt a member who has the floor, must be recognized, and the motion must be seconded.

They are subject to the following further rules:

- (a) To Adjourn or to Recess
 - (1) Not debatable, if unqualified
 - (2) Not amendable
 - (3) Cannot be laid on Table

- (4) Majority vote
- (5) The motion to adjourn shall always be in order except that it shall not be offered when another member has the floor
- (b) To Adjourn to Time Certain
 - (1) Debatable, as to the time
 - (2) Amendable, as to the time
 - (3) Cannot be laid on table
- (c) To Lay on Table or To Table
 - (1) Not debatable
 - (2) Not amendable
 - (3) Cannot be laid on Table
 - (4) Majority vote
- (d) To Vote Immediately or at Time Certain or to Extend Debate
 - (1) Not debatable
 - (2) Amendable, as to time, if a time specified
 - (3) Cannot be laid on table
 - (4) Two-thirds majority vote
- (e) To Postpone to Time Certain
 - (1) Debatable
 - (2) Amendable as to time
 - (3) May be laid on Table
 - (4) Majority vot3
- (f) To Commit or recommit to any Committee
 - (1) Debatable, except as to a Convention Committee
 - (2) Amendable as to the Committee to which to be sent
 - (3) May be laid on Table
 - (4) Majority vote
- (g) To Amend or To Substitute
 - (1) Amendments and Substitutes are debatable only when Main Question is debatable
 - (2) One Amendment may be made to each independent or separable portion of a Resolution; and the right to amend extends only to one Amendment of that Amendment and to a Substitute and one Amendment thereto
 - (3) A Substitute and its Amendment may be laid on table, but cannot be otherwise voted on until original matter if perfected
 - (4) Majority vote
 - (5) Neither the Substitute nor its Amendment shall be voted on (except to lay on the table) until the original matter is perfected.

V. MOTIONS WITHOUT ORDER OF PRECEDENCE

- Rule 5.01: The following motions have no order or priority but are subject to the following rules:
- (a) Appeal from Decision of Chair
 - (1) Debatable
 - (2) Not amendable
 - (3) May be laid on table

- (4) Majority vote. A tie vote sustains Chair
- (5) Must be made immediately after decision
- (b) To Take from Table
 - (1) Not debatable
 - (2) Not amendable
 - (3) Cannot be laid on table
 - (4) Majority vote
- (c) To Recall from Committee
 - (1) Debatable
 - (2) Amendable
 - (3) May be laid on table
 - (4) Two-thirds majority vote
- (d) To Create Special Order of Day for a Particular Time
 - (1) Debatable
 - (2) Amendable as to time
 - (3) Cannot be laid on the table
 - (4) Two-thirds majority vote
- (e) Call for the order of the Day
 - (1) Mover may interrupt a member who has the floor and is not required to be recognized or to have a second
 - (2) Not debatable
 - (3) Not amendable
 - (4) Cannot be laid on table
 - (5) No vote required, but two-thirds majority vote is necessary to suspend general or special order
- (f) To Suspend the Rules or Take Up Business Out of Order
 - (1) Debatable
 - (2) Not amendable
 - (3) Cannot be laid on the table
 - (4) Two-thirds majority vote
- (g) To Divide the Question
 - (1) Not debatable
 - (2) Can be amended
 - (3) Cannot be laid on the table
 - (4) Majority vote, if vote required
 - (5) May be made without being recognized and even though another member has the floor
 - (6) If the Question under debate contains several distinct propositions, which are independent of each other, at the request of any members the same shall be divided and a separate vote shall be taken but the motion to strike out and to insert shall be indivisible.
 - (7) The propositions relate to the same subject, and yet each part can stand alone, they may be divided only a regular motion and vote.

VI. RECONSIDERATION

• Rule 6.01: Neither a Question once determined, nor one of like import, shall again be brought before the Convention, except on motion to reconsider made by one who voted in the majority and seconded by another who voted in the majority.

- Rule 6.02: Motions to reconsider are subject to the following further rules:
 - (1) Debatable when motion to be reconsidered is debatable
 - (2) Not amendable
 - (3) May be tabled
 - (4) Two-thirds majority vote
 - (5) No question can be twice considered unless it was materially amended after its first reconsideration

VII. DECORUM AND DEBATE

- Rule 7.01: No member shall be absent from the Convention unless leave has been given by the Chair, or because of inability to attend.
- Rule 7.02: No member shall address the Convention or make any motion until after recognition by the Bishop except to make a parliamentary inquiry, a point of order or a motion not requiring recognition.
- Rule 7.03: When any Delegate is about to speak, the Chair shall be addressed, the name, parish of the Delegate stated; such address shall be confined strictly to the point of debate.
- Rule 7.04: Except by leave of the Convention, no Delegate shall speak more than twice in the same debate nor longer than five minutes at one time.

VIII. VOTING

- Rule 8.01: Nominations for Standing Committee, members of the Bishop and Council, Trustees of the University of the South, members of the Disciplinary Board and General Convention Deputies and Alternates, which are in writing and contain the nominee's name, parish, and city and not more than one hundred words of biographical information including past and present service of the nominee to the Church at all levels and received in the office of the Secretary thirty days prior to the opening of the Convention shall be included in the Convention brochure. Additional written nominations for these offices may be made by the nominator or nominee filing 300 white copies of the nominee's biographical information with the Secretary by 4:00 p.m. Friday for distribution to the Convention provided, however, that additional nominations for clergy members of the Bishop and Council may be made from the floor at any time after the election of lay members and prior to voting on clergy members. Such nominations from the floor shall include the information required for written nominations with the exception of nominations for clergy members of the Bishop and Council. All written nominations shall be posted at the Convention. All such nominations shall contain the name, parish, and the city of the nominator who shall obtain the nominee's consent and willingness to serve prior to submitting nomination. Nominations may be made only by the Bishops of this Diocese, Clerical and Lay Delegates, Vestries, and any other person authorized by Canon.
- Rule 8.02: Balloting for the offices set forth in 8.01 shall commence not earlier than by 11:30 a.m. on Friday.

- Rule 8.03: In elections of Deputies to the General Convention and of Members of the Bishop and Council, a majority of the votes cast shall be necessary to election. In all other elections, including that of Alternate Deputies to the General Convention, a plurality shall suffice. If the Convention shall take up other business while ballots are being counted such business may be interrupted for the report of tellers and additional ballots. If all the Deputies to the general Convention are not elected on the first ballot, the remainder is to be elected from the remaining nominees by majority on the second ballot, and if all are not elected on the second ballot, the remainder is to be elected from the remaining nominees by plurality on the third ballot. The sequence of alternates is determined on the final ballot taken.
- Rule 8.04: Unless otherwise expressly provided any rules requiring a two-thirds majority shall be construed to mean the affirmative vote to two-thirds of the Delegates present and voting.
- Rule 8.05: Ballots with more or less votes than there are positions to be filled shall be declared invalid.

IX. COMMITTEE OF THE WHOLE

• Rule 9.01: Whenever so ordered by a vote of a majority of the members present, the Convention may go into Committee of the Whole for the consideration of any matter.

X. UNANIMOUS CONSENT

• Rule 10.01: By unanimous consent, any action may be taken that is not in contravention of any provision of the Constitution or the Canons.

XI. GENERAL REGULATIONS

• Rule 11.01: Except with the express permission of the Bishop or when otherwise ordered by majority vote of the Convention, no books, pamphlets or other printed matter may be distributed on the floor of Convention, or be placed on the seats or desks of the Delegates; but this prohibition shall not apply to Resolutions, reports, and other documents prepared or distributed by the Secretary or to ballots for elections.

XII. ROBERT'S RULES OF ORDER

• Rule 12.01: Except when in conflict with the Constitution or Canons, or any Rules herein contained, the latest edition of Robert's Rules of Order shall govern the interpretation of Rules and procedures to be followed.

XIII. AMENDMENTS

• Rule 13.01: These Rules may be amended at any time by a two-thirds majority vote of the members present.

DWIGHT ZSCHEILE

ASSOCIATE PROFESSOR OF CONGREGATIONAL MISSION AND LEADERSHIP



Dwight Zscheile joined the Luther Seminary faculty in 2008 as assistant professor of Congregational Mission and Leadership, after serving as an adjunct instructor in church leadership at Luther Seminary in 2007 and 2008. Zscheile received a Bachelor of Arts degree with distinction from Stanford University, Calif., in 1995, having also attended Oxford University, and a Master of Divinity degree from Yale Divinity School, New Haven, Conn., in 1998. He completed the Doctor of Philosophy degree at Luther Seminary with a focus on congregational mission and leadership in 2008.

Zscheile's thesis, "Reframing Mission," focused on a large-scale action-research intervention into a mainline denominational judicatory that mobilized grassroots members to address challenges of decline, crisis, and renewal. Zscheile was ordained in The Episcopal Church in 2005 and has served on mission and leadership task forces in the Dioceses of Minnesota and Virginia. He currently serves on the Task Force for Reimagining the Episcopal Church.

Before coming to Luther, Zscheile served as executive pastor at St. David's Episcopal Church, Ashburn, Va. He currently serves part-time as associate priest at St. Matthew's Episcopal Church in St. Paul, alongside his wife, Blair Pogue, the rector. Zscheile has been involved in leadership roles in congregations in Connecticut, Virginia, and Minnesota.

Zscheile is the author of *The Agile Church: Spirit-Led Innovation in an Uncertain Age* (Morehouse Publishing, 2014), *People of the Way: Renewing Episcopal Identity* (Morehouse Publishing, 2012) and *The Missional Church in Perspective* (with Craig Van Gelder; Baker Academic, 2011). He is the editor of *Cultivating Sent Communities: Missional Spiritual Formation* (Eerdmans 2012). His essays and articles include "From Establishment to Innovation: Rethinking Structure in a New Apostolic Age" in *What Shall We Become: The Future and Structure of the Episcopal Church* (Church Publishing,

2013), "Christian Biblical Understandings of Leadership" in *The Sage Handbook of Religious Leadership* (Sage, 2013), "A More True 'Domestic and Foreign Missionary Society': Toward a Missional Polity for the Episcopal Church" in *The Missional Church and Denominations* (Eerdmans 2008), "The Trinity, Leadership, and Power" (*Journal of Religious Leadership* 6, no. 2 (Fall 2007)), "Beyond Benevolence: Toward a Reframing of Mission in the Episcopal Church" (*Journal of Anglican Studies* 8, no. 1, 2010), and "Social Networking and Church Systems," *Word and World* Summer 2010. He has also contributed to WorkingPreacher.org and Leading Ideas, an online publication of Wesley Theological Seminary.

Zscheile currently serves as co-editor of the *Journal of Religious Leadership* and is a board member of the American Society of Missiology.

He was named a Marquand Scholar at Yale Divinity School (1995-8), a Lewis Fellow at Wesley Theological Seminary (2005-6) and was awarded the David and Martha Tiede Fellowship from Luther Seminary (2006-7).

Juror's comments: The juxtaposition is what Jamie liked about this photo – taking things considered to be sacred/reverent and recognizing that for mission we have to tailor our message for the current time – balancing between being reverent and meeting people where they are. We can't share God's message if we aren't in the places where they are. So something as simple and commercial as coffee becomes an outlet to share our message.
