#### The Episcopate in East Tennessee

#### William Evan Sanders, D.D.

Born December 25, 1919, Natchez, Mississippi. Ordained by Bishop Maxon: Deacon 1945, Priest 1946. Consecrated as Bishop Coadjutor of Tennessee, 586th in American Succession, in Memphis, April 4, 1962; chief consecrator, Presiding Bishop Arthur Carl Lichtenberger. Eighth Bishop of the Diocese of Tennessee, January 10, 1977. Chose to remain with the Diocese of East Tennessee as First Bishop, January 1, 1985. Retired December 31, 1991.

#### Robert Gould Tharp, D.D., D.C.L.

Born October 25, 1928, Orlando, Florida. Ordained Deacon 1956 by Bishop Louttit, Priest 1957 by Bishop Moses. Elected Bishop Coadjutor of East Tennessee, November 17, 1990. Consecrated as Bishop Coadjutor of East Tennessee, 867th in American Succession, in Knoxville, May 4, 1991. Installed as Second Bishop of East Tennessee on December 7, 1991, at St. John's Cathedral, Knoxville. Retired February 28, 1999. Deceased May 30, 2003.

#### Charles Glenn vonRosenberg, D.D.

Born July 11, 1947, in Fayetteville, North Carolina. Ordained by Bishop Elebash; Deacon in 1974 and Priest in 1975. Elected Bishop of East Tennessee, October 17, 1998. Consecrated and ordained as the Third Bishop of East Tennessee, 944th in American Succession, in Knoxville, February 27, 1999, and installed at St. John's Cathedral, Knoxville, February 28, 1999. Retired.

#### George Dibrell Young, III, D.D.

Born September 28, 1955, in Jacksonville, Florida. Ordained by Bishop Cerveny; Deacon in 1990 and Priest in 1990. Elected Bishop of East Tennessee, February 11, 2011. Consecrated and ordained as the Fourth Bishop of East Tennessee, 1,059th in American Succession, in Knoxville, June 26, 2011, and installed at St. John's Cathedral, Knoxville, June 27, 2011.

# Consent Agenda

#### CONSENT AGENDA INFORMATION AND SUPPORTING DOCUMENTS

A consent agenda is a meeting practice by which routine reports or non-controversial items not requiring discussion or independent action are presented as one agenda item. The clergy and delegates approve this "package" of items in one motion. This practice is used to save on precious meeting time.

If any clergy or delegate wishes to remove any item from the Consent Agenda for discussion, he or she may do so with a motion during the discussion period after the Consent Agenda is moved and seconded. The motion to remove any item requires a second and a simple majority vote.

Consent agenda items can only be removed for discussion and not clarification. If any clergy or delegate member needs clarification of an item, this needs to be accomplished prior to the Business Meeting by contacting the Canon to the Ordinary.

#### DIOCESE OF EAST TENNESSEE ANNUAL CONVENTION RULES OF ORDER

#### I. ORDER OF BUSINESS

- Rule 1.01: The Order of Business shall be specified and approved by the Convention
- Rule 1.02: During balloting, the Convention may take up business, which may be interrupted for the reports of tellers and additional ballots.

#### II. CONVENTION COMMITTEES

- Rule 2.01: The Bishop shall appoint the following Convention Committees: On Credentials, On Elections (Ballots/Tellers), On General Resolutions
- Rule 2.02: The Bishop shall appoint the following committees as prescribed by the Canons or as otherwise required: On Constitution and Canons, The Church Pension Fund Committee (appointed annually)
- Rule 2.03: Such Committees as are instructed by the bishop shall convene in advance of the opening of Convention to consider matters referred to them.
- Rule 2.04: Reports of all Committees shall be in writing. All reports recommending action by the Convention shall be accompanied by Resolutions for such action.

#### III. RESOLUTIONS

- Rule 3.01: Resolutions are submitted as the Canons may prescribe.
- Rule 3.02: All Resolutions and amendments proposed thereto shall be in writing and shall contain the name, parish, and city of the proponent. Failing to meet the deadline as set forth in Title I, Canon 3, Sec. 10 the delegate or organization presenting a Resolution may introduce such Resolutions at the Convention no later than 4:00 p.m. on Friday. Except for Resolutions contained in the reports of Committees, no Resolution offered after this time shall be considered except upon the affirmative vote of three-fourths (3/4) of the delegates present and voting. The delegate or organization presenting a late Resolution is responsible for having 300 copies of the Resolution reproduced on blue paper for distribution to the Convention.
- Rule 3.03: The Bishop shall refer all Resolutions to appropriate Convention Committees for consideration, recommendation and report to the Convention provided, however, upon a vote of two-thirds (2/3) of the delegates present, a Resolution may be considered immediately.
- Rule 3.04: Where two or more Resolutions deal basically with the same subject, they shall be referred to the same General Resolutions Committee. The Committee shall make every effort to consolidate them or otherwise assure their compatibility and should also make every effort to obtain the concurrence of the proponents concerned.

• Rule 3.05: Each Convention Committee to which a Resolution has been referred, after providing for a public hearing thereon, shall consider the form and substance of the Resolution and in making its report shall recommend (a) for adoption, (b) for adoption with amendment, (c) for adoption of a substitute drafted by the Committee, (d) for rejection, or (e) for discharge from further consideration because the subject matter has been included in another Resolution. The Committee's recommendation to the Convention shall be in the form of a motion to adopt the Committee's recommendation. The Committee Chair or other representative shall state the reasons for the Committee's recommendation. Thereafter, the proponent of the original Resolution, which is the subject of the Committee's recommendation, shall be recognized first if the proponent so desires. Amendments may be offered, including an amendment to substitute the proponent's original Resolution for that recommended by the Committee.

#### IV. MOTIONS IN ORDER OF PRECEDENCE

• Rule 4.01: The following motions shall have priority in the order listed. The mover cannot interrupt a member who has the floor, must be recognized, and the motion must be seconded.

They are subject to the following further rules:

- (a) To Adjourn or to Recess
  - (1) Not debatable, if unqualified
  - (2) Not amendable
  - (3) Cannot be laid on Table
  - (4) Majority vote
- (5) The motion to adjourn shall always be in order except that it shall not be offered when another member has the floor
- (b) To Adjourn to Time Certain
  - (1) Debatable, as to the time
  - (2) Amendable, as to the time
  - (3) Cannot be laid on table
- (c) To Lay on Table or To Table
  - (1) Not debatable
  - (2) Not amendable
  - (3) Cannot be laid on Table
  - (4) Majority vote
- (d) To Vote Immediately or at Time Certain or to Extend Debate
  - (1) Not debatable
  - (2) Amendable, as to time, if a time specified
  - (3) Cannot be laid on table
  - (4) Two-thirds majority vote
- (e) To Postpone to Time Certain
  - (1) Debatable
  - (2) Amendable as to time
  - (3) May be laid on Table
  - (4) Majority vot3
- (f) To Commit or recommit to any Committee
  - (1) Debatable, except as to a Convention Committee

- (2) Amendable as to the Committee to which to be sent
- (3) May be laid on Table
- (4) Majority vote
- (g) To Amend or To Substitute
  - (1) Amendments and Substitutes are debatable only when Main Question is debatable
- (2) One Amendment may be made to each independent or separable portion of a Resolution; and the right to amend extends only to one Amendment of that Amendment and to a Substitute and one Amendment thereto
- (3) A Substitute and its Amendment may be laid on table, but cannot be otherwise voted on until original matter if perfected
  - (4) Majority vote
- (5) Neither the Substitute nor its Amendment shall be voted on (except to lay on the table) until the original matter is perfected.

#### V. MOTIONS WITHOUT ORDER OF PRECEDENCE

- Rule 5.01: The following motions have no order or priority but are subject to the following rules:
- (a) Appeal from Decision of Chair
  - (1) Debatable
  - (2) Not amendable
  - (3) May be laid on table
  - (4) Majority vote. A tie vote sustains Chair
  - (5) Must be made immediately after decision
- (b) To Take from Table
  - (1) Not debatable
  - (2) Not amendable
  - (3) Cannot be laid on table
  - (4) Majority vote
- (c) To Recall from Committee
  - (1) Debatable
  - (2) Amendable
  - (3) May be laid on table
  - (4) Two-thirds majority vote
- (d) To Create Special Order of Day for a Particular Time
  - (1) Debatable
  - (2) Amendable as to time
  - (3) Cannot be laid on the table
  - (4) Two-thirds majority vote
- (e) Call for the order of the Day
- (1) Mover may interrupt a member who has the floor and is not required to be recognized or to have a second
  - (2) Not debatable
  - (3) Not amendable
  - (4) Cannot be laid on table
  - (5) No vote required, but two-thirds majority vote is necessary to suspend general or

special order

- (f) To Suspend the Rules or Take Up Business Out of Order
  - (1) Debatable
  - (2) Not amendable
  - (3) Cannot be laid on the table
  - (4) Two-thirds majority vote
- (g) To Divide the Question
  - (1) Not debatable
  - (2) Can be amended
  - (3) Cannot be laid on the table
  - (4) Majority vote, if vote required
- (5) May be made without being recognized and even though another member has the floor
- (6) If the Question under debate contains several distinct propositions, which are independent of each other, at the request of any members the same shall be divided and a separate vote shall be taken but the motion to strike out and to insert shall be indivisible.
- (7) The propositions relate to the same subject, and yet each part can stand alone, they may be divided only a regular motion and vote.

#### VI. RECONSIDERATION

- Rule 6.01: Neither a Question once determined, nor one of like import, shall again be brought before the Convention, except on motion to reconsider made by one who voted in the majority and seconded by another who voted in the majority.
- Rule 6.02: Motions to reconsider are subject to the following further rules:
  - (1) Debatable when motion to be reconsidered is debatable
  - (2) Not amendable
  - (3) May be tabled
  - (4) Two-thirds majority vote
- (5) No question can be twice considered unless it was materially amended after its first reconsideration

#### VII. DECORUM AND DEBATE

- Rule 7.01: No member shall be absent from the Convention unless leave has been given by the Chair, or because of inability to attend.
- Rule 7.02: No member shall address the Convention or make any motion until after recognition by the Bishop except to make a parliamentary inquiry, a point of order or a motion not requiring recognition.
- Rule 7.03: When any Delegate is about to speak, the Chair shall be addressed, the name, parish of the Delegate stated; such address shall be confined strictly to the point of debate
- Rule 7.04: Except by leave of the Convention, no Delegate shall speak more than twice in the same debate nor longer than five minutes at one time.

#### VIII. VOTING

- Rule 8.01: Nominations for Standing Committee, members of the Bishop and Council, Trustees of the University of the South, members of the Disciplinary Board and General Convention Deputies and Alternates, which are in writing and contain the nominee's name, parish, and city and not more than one hundred words of biographical information including past and present service of the nominee to the Church at all levels and received in the office of the Secretary thirty days prior to the opening of the Convention shall be included in the Convention brochure. Additional written nominations for these offices may be made by the nominator or nominee filing 300 white copies of the nominee's biographical information with the Secretary by 4:00 p.m. Friday for distribution to the Convention provided, however, that additional nominations for clergy members of the Bishop and Council may be made from the floor at any time after the election of lay members and prior to voting on clergy members. Such nominations from the floor shall include the information required for written nominations with the exception of nominations for clergy members of the Bishop and Council. All written nominations shall be posted at the Convention. All such nominations shall contain the name, parish, and the city of the nominator who shall obtain the nominee's consent and willingness to serve prior to submitting nomination. Nominations may be made only by the Bishops of this Diocese, Clerical and Lay Delegates, Vestries, and any other person authorized by Canon.
- Rule 8.02: Balloting for the offices set forth in 8.01 shall commence not earlier than by 11:30 a.m. on Friday.
- Rule 8.03: In elections of Deputies to the General Convention and of Members of the Bishop and Council, a majority of the votes cast shall be necessary to election. In all other elections, including that of Alternate Deputies to the General Convention, a plurality shall suffice. If the Convention shall take up other business while ballots are being counted such business may be interrupted for the report of tellers and additional ballots. If all the Deputies to the general Convention are not elected on the first ballot, the remainder is to be elected from the remaining nominees by majority on the second ballot, and if all are not elected on the second ballot, the remainder is to be elected from the remaining nominees by plurality on the third ballot. The sequence of alternates is determined on the final ballot taken.
- Rule 8.04: Unless otherwise expressly provided any rules requiring a two-thirds majority shall be construed to mean the affirmative vote to two-thirds of the Delegates present and voting.
- Rule 8.05: Ballots with more or less votes than there are positions to be filled shall be declared invalid.

#### IX. COMMITTEE OF THE WHOLE

• Rule 9.01: Whenever so ordered by a vote of a majority of the members present, the Convention may go into Committee of the Whole for the consideration of any matter.

#### X. UNANIMOUS CONSENT

• Rule 10.01: By unanimous consent, any action may be taken that is not in contravention of any provision of the Constitution or the Canons.

#### XI. GENERAL REGULATIONS

• Rule 11.01: Except with the express permission of the Bishop or when otherwise ordered by majority vote of the Convention, no books, pamphlets or other printed matter may be distributed on the floor of Convention, or be placed on the seats or desks of the Delegates; but this prohibition shall not apply to Resolutions, reports, and other documents prepared or distributed by the Secretary or to ballots for elections.

#### XII. ROBERT'S RULES OF ORDER

• Rule 12.01: Except when in conflict with the Constitution or Canons, or any Rules herein contained, the latest edition of Robert's Rules of Order shall govern the interpretation of Rules and procedures to be followed.

#### XIII. AMENDMENTS

• Rule 13.01: These Rules may be amended at any time by a two-thirds majority vote of the members present.

To provide seat and voice to ordained clergy, not canonically resident, but licensed to officiate, or to lead congregations; invitation to be seated at convention to ordained ministers present during Convention as well as to postulants and candidates for holy orders.

Resolved, that all ordained ministers of this church present in this city of Knoxville during the sessions of this convention, all postulants and candidates for holy orders in the diocese, and all ordained ministers of other communions present in Knoxville be cordially invited to seats upon the floor of convention.

To ratify Bishop and Council actions regarding the 2016 Budget

WHEREAS, by its action, the Thirty-second first Annual Convention of The Diocese of East Tennessee convened in Knoxville on Friday, February 5, 2016, and approved a budget for The Diocese; and

WHEREAS, in the wisdom of the Bishop and Council, certain items of the Budget were exceeded but the total expenditures were less than the budgeted total; and

WHEREAS, by Canon 2, Sec. 2 (a), it is necessary for the Convention to approve budgets; and

WHEREAS, the budget as approved in its February 2016 Convention was \$1,838,716 and

WHEREAS, the actual budgeted disbursements were \$1,790,715; and

WHEREAS, the Treasurer's Financial Statements reflect all detailed records of disbursements over and under the budget recited herein by reference, reflect the best judgment and good offices of the Bishop and Council and Treasurer in performing under said budget;

**NOW THEREFORE BE IT RESOLVED**, that all of the acts and actions of the Bishop and Council in authorizing disbursements in excess of line items in the 2015 budget as approved by their various actions during 2016, be and are hereby ratified by this Convention as authorized and approved.

To delete the reference to Area Commissions in the Table of Contents of the Constitution and Canons of the Diocese of East Tennessee and adjust the page numbers accordingly

**PROPOSED BY:** The Committee on Constitutions and Canons

**REPRESENTATIVE AT CONVENTION:** L. Marie Williams, Chair, Committee on Constitutions and Canons, St. Paul's, Chattanooga, TN

**RESOLVED,** That the Table of Contents of the Constitution and Canons of the Diocese of East Tennessee be amended to eliminate Title IV, Canon 4, and to renumber the Canons and Table of Contents and adjust the page numbers accordingly.

The following language shall be eliminated from the Constitution and Canons:

#### TITLE IV PLACES OF WORSHIP

#### **CANON 4: Area Commissions**

- **Sec. 1.** With consent of the Bishop, the Bishop and Council may create an Area Commission in any part of the Diocese. The resolution creating a Commission shall, at a minimum, prescribe:
  - (a). The geographical area to be included;
  - **(b).** The organizational structure of the Commission;
- **(c).** Planning for and acquisition of sites for future church expansion, in cooperation with the Bishop and the Department of Mission.
- **(d).** Operation and planning of programs and acquisition of sites for work in any other field of Christian concern, in cooperation with the Bishop and the appropriate Department of the Diocese.
- **(e).** In the creation of Area Commissions, due regard shall be taken of the existing Organizations formerly known as Area Planning Commissions, and insofar as practicable, their identity shall be preserved.
- **Sec. 2.** When a Commission has been duly formed, the program and activities of all Institutions and Organizations of the Diocese, and of all Departments within the geographical area served by the Commission, shall be coordinated by and with the

Commission, insofar as the same have been committed to the Commission by virtue of Section 1, (c) and (d) of this Canon. Standard operating procedures to carry this Section 2 into effect shall be adopted by the Bishop and Council.

- **Sec. 3.** Unless otherwise directed by the Bishop and Council, an Area Commission may apply for a corporate Charter, provided the same has first received approval of the Chancellor. All real property acquired by a Commission shall be held in trust for the Diocese, although legal title may be vested in the Commission, but alienation or hypothecation of such property shall be governed by provisions of Title III, Canon 1.
- **Sec. 4.** An Area Commission may adopt Bylaws, provided that before they become effective, they must be submitted to and approved by the Bishop.
- **Sec. 5.** All Parishes in the geographical area of a Commission shall be constituent members thereof, and are expected and encouraged to contribute to its financial support according to their means. Other Institutions and Organizations, or individuals, may also become members, as may be set out in the Bylaws.
- **Sec. 6**. An Area Commission shall be deemed an administrative agency of the Diocese, under control of and responsible to the Bishop, but it shall have no power to enter into contracts or to incur obligations of any description on behalf of, or as agent for, in the name of the Diocese.
- **Sec. 7.** The Bishop and Council may, by resolution, amend or revoke the resolution adopted pursuant to Section 1 of this Canon. In the event the Bishop and Council terminates any Area Commission, title to all its property and assets, real and personal, shall vest in the Convention to be used for such purposes as the Convention shall direct.
- **Sec. 8.** It shall be the duty of each Commission to make such reports to the Convention, or to the Bishop and Council, or to the Bishop, as may be from time to time required by them or by any of them.
- **Sec. 9.** The Bishop shall be an ex-officio member of each Commission, and when present at a meeting of any Board, Committee, or membership meeting, the Bishop or the duly authorized representative of the Bishop shall have voice and vote.

#### **RATIONALE:**

Area Commissions are a vestige of the time when the Diocese of Tennessee encompassed the entire State of Tennessee. When the Diocese was split, the need for Area Commissions diminished and none are in existence currently. Therefore, all language pertaining to Area Commissions is superfluous.

To amend Title I, Canon 3, Secs. 7 & 10

## TITLE I ORGANIZATION

#### **CANON 3: Meetings of the Convention**

**Sec. 7.** The Secretary, Treasurer, Chancellor, the Vice Chancellors, the Chair of the Committee on Constitution and Canons, the Registrar, the Lay Members of the Bishop and Council and the Standing Committee, three youth representatives of the Youth Action Council, the President of the Episcopal Endowment Corporation, the Vice Chancellor, the Dean of the School of Theology, and the Chaplain of the University of the South, and the Headmaster of St. Andrew's-Sewanee School, if not members of the Convention by virtue of being either a member of the Clergy canonically resident or a Lay Delegate representing a Parish of the Diocese, shall be ex-officio, admitted to seats upon the floor of the Convention, with all privileges except the right to vote.

**Sec. 10.** Any Delegate, Vestry, the Bishop and Council, the Chancellor, the Chair of the Committee on Constitution and Canons, and the Registrar of the Diocese may submit resolutions for consideration by the Convention by delivering them to the Secretary of the Convention at least thirty days prior to the date set for the Convention. They may also introduce resolutions at the Convention in accordance with the Rules of Order.

#### **RATIONALE:**

This Resolution is an edit of Title I, Canon 3, to eliminate language regarding Area Commissions.

To delete reference to Area Commissions in Title IV, Canon 2, Sec. 1

TITLE IV PLACES OF WORSHIP

**CANON 2: New Parishes** 

**Sec. 1.** A group of at least 50 Adult Confirmed Communicants canonically entitled to vote may submit to the Bishop an application to form a Parish. Upon receipt of such application, the Bishop shall forward copies thereof for written comment to any existing Parish within a 10-mile radius of the proposed location of the new Parish. Such written comments shall be sent to the Bishop within sixty (60) days of receipt of the application. After the expiration of such sixty (60) day period, the Bishop shall send the application, together with the Bishop's comments and any written comments received from the existing Parishes, to the Standing Committee for its consideration and consent. If the Standing Committee consents and the Bishop concurs, Articles of Association, as set forth in Section 2 below, shall be signed and forwarded to the Convention and, upon the affirmative vote of the Convention, the Parish shall be established. For good cause, so stated, the Bishop may shorten the sixty (60) day period to no less than twenty (20) days.

This Resolution is an edit of Title IV, Canon 2, to eliminate language regarding Area Commissions.

## DIOCESE OF EAST TENNESSEE SPECIAL RULES OF ORDER FOR THE ELECTION OF A BISHOP

WHEREAS, The Right Reverend George Dibrell Young, III, Bishop of the Diocese of East Tennessee, has announced his intention to resign and has called for the election of a Bishop, said election to be held beginning July 28, 2017, the third day of the Thirty-third Annual Convention of the Diocese of East Tennessee, said third day referred to herein as the "Electing Convention;" and

WHEREAS, Article XI of the Constitution of the Diocese of East Tennessee provides that the election of a Bishop of this Diocese shall be by concurrent vote of the clergy and laity in Convention assembled. The vote shall be taken by orders and a two-thirds vote on the same ballot in each order shall be necessary for the election of a Bishop; and

WHEREAS, the election of a person to be a Bishop in a Diocese shall be held in accordance with the Rules prescribed by the Convention of the Diocese and pursuant to the provisions of the Constitution & Canons of this Church (Canon III.11.1(a)) and of this Diocese (Canon VIII.4).

NOW, THEREFORE, be it resolved by the Thirty-third Annual Convention of the Diocese of East Tennessee, that the following Special Rules of Order for the Election of a Bishop shall be adopted for the guidance of the Electing Convention:

- **Rule I**. Only properly registered clergy members of the Convention and duly elected lay delegates to Convention, all of whom are defined in Diocesan Canon I.3, may cast a ballot, make any motion, or raise any point of order at the Electing Convention. All delegates must register on the day of the Election at the Electing Convention, even if registered on the prior day of Convention. No proxy voting or voting by absentee ballot is permitted. All delegates shall be seated in their assigned pews in order to vote.
- **Rule II.** The person shall be elected from among the Nominees and the Nominees-by-Petition. Nominations shall not be allowed from the floor. A Nominee or Nominee-by-Petition may withdraw from the election at any time by telephone, fax, email or other electronic communication, or by designated representative or other authorized representative.
- **Rule III**. Persons other than those specified in Rule I may be authorized privileges of the Convention, except vote, as set forth in Diocesan Canon I.3. In addition, non-clergy and non-delegate members of the Diocesan Search and Transition Committees are entitled to seat and voice.
- **Rule IV**. The President of the Convention is the Diocesan Bishop. In the event the Bishop is unable to preside, the Standing Committee shall select a clergy member of the Convention to preside until Convention elects a President *pro tempore*.
- **Rule V.** The President shall call the Convention to order.

**Rule VI.** The President shall present the Order of Business to the Convention for approval.

**Rule VII.** The President shall appoint a Chair of Elections and an Election Committee, including tellers to collect ballots and individuals to count the ballots.

**Rule VIII.** The President shall call on the Standing Committee President who shall announce the nomination of the persons whose names were submitted by the Search Committee, together with the names of nominees submitted by Petition. There shall be no speeches supporting specific nominees during the Convention.

**Rule IX.** The President shall call upon the Chancellor to present an overview of the Rules of Order and the election process, instructing the Electing Convention on how ballots are cast and collected.

**Rule X.** The President shall call upon the Committee on Credentials to determine and announce whether a constitutional quorum in both orders is present, and to identify the number of lay and clergy delegates present, in order to determine the number of votes in each order necessary to constitute a two-thirds majority.

#### Rule XI. Ballots

**Section 1.** The President shall call for a ballot by orders. The tellers shall collect the ballots by orders and submit them to the Elections Committee members for counting. The Chair of Elections shall report the results to the President, who shall announce the results.

**Section 2.** The President shall declare an election when a Nominee has received a two-thirds majority of the ballots cast in each order on the same ballot.

**Section 3.** If there is no election after a ballot is taken, the President shall declare time for prayerful reflection to be conducted in a manner determined by the Bishop.

**Section 4.** Prior to each subsequent ballot, the Committee on Credentials shall report to the President any changes in the number of clergy or lay delegates.

**Rule XII.** When there is an election, the President shall notify the Bishop-Elect, and the Chair of the Transition Committee shall notify the other nominees of the results of the election. The Secretary shall provide the Convention with the canonical testimonials of election. The President shall direct the Convention to remain in session until a constitutional majority of the Convention has signed the canonical testimonials.

**Rule XIII**. Except as provided in these rules, the most recent version of Roberts <u>Rules of Order</u> shall govern parliamentary procedure. The Convention officers, including the Parliamentarian, shall continue to serve in those capacities during the Electing Convention. The Electing Convention may suspend any of these rules by an affirmative vote of two-thirds of those present and eligible to vote.

**Rule XIV.** The use of pagers, cell phones, smart phones, texting devices, computers, or any other communication devices or equipment on the floor of the Electing Convention

is prohibited. The use of any such device may subject, upon majority vote of the Convention, the user to be expelled.

**Rule XV.** The date, time and place of consecration of the Bishop-Elect as the Bishop shall be designated by the Presiding Bishop in consultation with the Standing Committee and the Transition Committee. It is anticipated to occur on December 2, 2017 at the Church of the Ascension, Knoxville, Tennessee.

**Rule XVI.** The election and consecration of the Bishop-elect shall be subject to the satisfactory completion of the background and financial investigations and of the medical and psychiatric examinations required by the Constitution & Canons of the Episcopal Church and to the obtaining of the required consents to the election. The election shall be further subject to an agreement being made between the Diocese and the Bishop-elect concerning compensation and other financial matters.

**Rule XVII.** In the event the time provided for the Electing Convention expires without a nominee having been elected, the President of the Convention may recess the Convention to a date certain, anticipated to be July 29, 2017, and/or to a date to be set in the future, or, by vote of a simple majority of the Convention, the President may declare the election to be at an end.

**Rule XVIII**. The Rules of Order adopted at the Thirty-third Convention shall apply to the Electing Convention. However, these Special Convention Rules of Order shall govern any conflict in the Rules of Order and these Rules.

# Section 5

## Resolutions

To provide seat and voice to ordained clergy, not canonically resident, but licensed to officiate, or to lead congregations; invitation to be seated at convention to ordained ministers present during Convention as well as to postulants and candidates for holy orders.

Resolved, that all ordained ministers of this church who are not canonically resident in this diocese, but who officiate under license and/or who are in charge of congregations in the diocese, be given seats and voice in the deliberations of this 33<sup>rd</sup> Convention of the Diocese of East Tennessee; and

Resolved, that all ordained ministers of this church present in this city of Knoxville during the sessions of this convention, all postulants and candidates for holy orders in the diocese, and all ordained ministers of other communions present in Knoxville be cordially invited to seats upon the floor of convention.

To ratify Bishop and Council actions regarding the 2016 Budget

**PROPOSED BY:** Bishop and Council

WHEREAS, by its action, the Thirty-second first Annual Convention of The Diocese of East Tennessee convened in Knoxville on Friday, February 5, 2016, and approved a budget for The Diocese; and

WHEREAS, in the wisdom of the Bishop and Council, certain items of the Budget were exceeded but the total expenditures were less than the budgeted total; and

WHEREAS, by Canon 2, Sec. 2 (a), it is necessary for the Convention to approve budgets; and

WHEREAS, the budget as approved in its February 2016 Convention was \$1,838,716 and

WHEREAS, the actual budgeted disbursements were \$1,790,715; and

WHEREAS, the Treasurer's Financial Statements reflect all detailed records of disbursements over and under the budget recited herein by reference, reflect the best judgment and good offices of the Bishop and Council and Treasurer in performing under said budget;

**NOW THEREFORE BE IT RESOLVED**, that all of the acts and actions of the Bishop and Council in authorizing disbursements in excess of line items in the 2016 budget as approved by their various actions during 2016, be and are hereby ratified by this Convention as authorized and approved.

To authorize an examination of the desirability of entering into a formal companion relationship with the Missionary Diocese of Kondoa, Tanzania, East Africa

PROPOSED BY: Rev. J.W. (Cal) Calhoun

REPRESENTATIVE AT CONVENTION: The Rev. J.W. (Cal) Calhoun, Rector,

Good Samaritan, Knoxville

**RESOLVED,** That the 33rd Convention of the Diocese of East Tennessee asks Bishop Young to take all such necessary steps to establish a Committee to examine whether the Diocese of East Tennessee is called to enter into a formal Companion Relationship with the Missionary Diocese of Kondoa, Tanzania; and be it further

**RESOLVED,** That the Committee make a recommendation pursuant to this Companion Relationship to the 34<sup>th</sup> Annual Convention at its next meeting in 2018.

#### **RATIONALE:**

The Rt. Reverend Dr. Given Gaula and his wife the Reverend Lillian Gaula have been called by God through Christ to serve as missionaries to the peoples of Kondoa, an impoverished area in Central Tanzania, East Africa that is historically and predominantly unfamiliar with the Good News of Christ.

Bishop Gaula and Rev. Lillian Gaula have labored with the inspiration of the Holy Spirit to such good effect that the Anglican Church in Kondoa has grown from 9000 members in 2012 to 15,000 members in 2016.

During the past three years Bishop Gaula and Rev. Lillian Gaula have visited the Diocese of East Tennessee and preached the Good News of Christ at St Paul's, Chattanooga; The Church of the Ascension, Knoxville; The Church of the Good Samaritan, Knoxville; St James, Knoxville; The Church of the Good Shepherd, Knoxville and the Episcopal School of Knoxville and have also visited and met with leaders of All Saints, Morristown, All Saints Episcopal School Morristown, the Episcopal School of Knoxville and the Episcopal Church Women.

Members of St Paul's, Ascension, Good Samaritan, and Good Shepherd have journeyed to Kondoa in 2014 and 2015 to worship with the Anglican peoples of Kondoa and have returned spiritually refreshed and invigorated by the warmth and enthusiasm of our faithful brothers and sisters in Christ in Kondoa, Tanzania, East Africa.

A third group of ten members of this Diocese will visit Kondoa in April-May, 2017.

Our own Bishop, George. D. Young III, has met with Bishop Given Gaula on two previous occasions and has determined that the Christian friendships that have begun to grow between our Diocese and the Missionary Diocese of Kondoa are Spirit filled and worthy of support and recognition by the Diocese of East Tennessee.

In consequence Bishop Young has suggested that this Diocese should examine the establishment of an official relationship with the Diocese of Kondoa, Tanzania and to make a formal decision at the 34th Convention of this Diocese in 2018.

This resolution has no financial impact on the Diocese or its congregations.

To delete the reference to Area Commissions in the Table of Contents of the Constitution and Canons of the Diocese of East Tennessee and adjust the page numbers accordingly

**PROPOSED BY:** The Committee on Constitutions and Canons

**REPRESENTATIVE AT CONVENTION:** L. Marie Williams, Chair, Committee on Constitutions and Canons, St. Paul's, Chattanooga, TN

**RESOLVED**, That the Table of Contents of the Constitution and Canons of the Diocese of East Tennessee be amended to eliminate Title IV, Canon 4, and to renumber the Canons and Table of Contents and adjust the page numbers accordingly.

The following language shall be eliminated from the Constitution and Canons:

#### TITLE IV PLACES OF WORSHIP

#### **CANON 4: Area Commissions**

- **Sec. 1.** With consent of the Bishop, the Bishop and Council may create an Area Commission in any part of the Diocese. The resolution creating a Commission shall, at a minimum, prescribe:
  - (a). The geographical area to be included;
  - **(b).** The organizational structure of the Commission;
- **(c).** Planning for and acquisition of sites for future church expansion, in cooperation with the Bishop and the Department of Mission.
- **(d).** Operation and planning of programs and acquisition of sites for work in any other field of Christian concern, in cooperation with the Bishop and the appropriate Department of the Diocese.
- **(e).** In the creation of Area Commissions, due regard shall be taken of the existing Organizations formerly known as Area Planning Commissions, and insofar as practicable, their identity shall be preserved.
- **Sec. 2.** When a Commission has been duly formed, the program and activities of all Institutions and Organizations of the Diocese, and of all Departments within the geographical area served by the Commission, shall be coordinated by and with the Commission, insofar as the same have been committed to the Commission by virtue of

- Section 1, (c) and (d) of this Canon. Standard operating procedures to carry this Section 2 into effect shall be adopted by the Bishop and Council.
- **Sec. 3.** Unless otherwise directed by the Bishop and Council, an Area Commission may apply for a corporate Charter, provided the same has first received approval of the Chancellor. All real property acquired by a Commission shall be held in trust for the Diocese, although legal title may be vested in the Commission, but alienation or hypothecation of such property shall be governed by provisions of Title III, Canon 1.
- **Sec. 4.** An Area Commission may adopt Bylaws, provided that before they become effective, they must be submitted to and approved by the Bishop.
- **Sec. 5.** All Parishes in the geographical area of a Commission shall be constituent members thereof, and are expected and encouraged to contribute to its financial support according to their means. Other Institutions and Organizations, or individuals, may also become members, as may be set out in the Bylaws.
- **Sec. 6**. An Area Commission shall be deemed an administrative agency of the Diocese, under control of and responsible to the Bishop, but it shall have no power to enter into contracts or to incur obligations of any description on behalf of, or as agent for, in the name of the Diocese.
- **Sec. 7.** The Bishop and Council may, by resolution, amend or revoke the resolution adopted pursuant to Section 1 of this Canon. In the event the Bishop and Council terminates any Area Commission, title to all its property and assets, real and personal, shall vest in the Convention to be used for such purposes as the Convention shall direct.
- **Sec. 8.** It shall be the duty of each Commission to make such reports to the Convention, or to the Bishop and Council, or to the Bishop, as may be from time to time required by them or by any of them.
- **Sec. 9.** The Bishop shall be an ex-officio member of each Commission, and when present at a meeting of any Board, Committee, or membership meeting, the Bishop or the duly authorized representative of the Bishop shall have voice and vote.

#### **RATIONALE:**

Area Commissions are a vestige of the time when the Diocese of Tennessee encompassed the entire State of Tennessee. When the Diocese was split, the need for Area Commissions diminished and none are in existence currently. Therefore, all language pertaining to Area Commissions is superfluous.

To amend Title I, Canon 3, Secs. 7 & 10

**RESOLVED,** That Title I, Canon 3, Secs. 7 and 10 of the Canons of the Diocese of East Tennessee be amended as set out below:

#### TITLE I ORGANIZATION

#### **CANON 3: Meetings of the Convention**

**Sec. 7.** The Secretary, Treasurer, Chancellor, the Vice Chancellors, the Chair of the Committee on Constitution and Canons, the Registrar, the Lay Members of the Bishop and Council and the Standing Committee, three youth representatives of the Youth Action Council, the President of the Episcopal Endowment Corporation, the Vice Chancellor, the Dean of the School of Theology, and the Chaplain of the University of the South, and the Headmaster of St. Andrew's-Sewanee School, if not members of the Convention by virtue of being either a member of the Clergy canonically resident or a Lay Delegate representing a Parish of the Diocese, shall be ex-officio, admitted to seats upon the floor of the Convention, with all privileges except the right to vote.

**Sec. 10.** Any Delegate, Vestry, the Bishop and Council, the Chancellor, the Chair of the Committee on Constitution and Canons, and the Registrar of the Diocese may submit resolutions for consideration by the Convention by delivering them to the Secretary of the Convention at least thirty days prior to the date set for the Convention. They may also introduce resolutions at the Convention in accordance with the Rules of Order.

#### **RATIONALE:**

This Resolution is an edit of Title I, Canon 3, to eliminate language regarding Area Commissions.

To amend Title III, Canon 1. Sec. 3: Requirements for Transfer, Encumbrance and/or Assignment of Real Property consistent with the Canons of The Episcopal Church

**PROPOSED BY:** The Committee on Constitutions and Canons

**REPRESENTATIVE AT CONVENTION:** L. Marie Williams, Chair, Committee on Constitutions and Canons, St. Paul's, Chattanooga, TN

**<u>RESOLVED</u>**, That Title III, Canon 1, Sec. 3 of the Canons of the Diocese of East Tennessee be amended as set out below:

#### **CANON 1: Definitions**

Unless otherwise defined in these Canons, the terms used herein shall have the same definition as they have in the Constitution and Canons of The Church.

#### TITLE III ASSETS OF THE DIOCESE AND PARISHES

#### **CANON 1: Real and Personal Property**

- **Sec. 3.** Real Property may be transferred, encumbered, or assigned only as follows:
- **(a).** If title to real estate is held by the Diocese, the written consent of the Bishop and of the Standing Committee is required.
- **(b).** If title to real estate is held by any Parish, or by any Organization or Institution of the Diocese, approval of the Vestry, or Board of the Parish, Organization, or Institution and the written consent of the Bishop and of the Standing Committee is required.
- **(c).** If the property has been dedicated, consecrated, or used for services of Divine Worship, the consent of the Bishop and of the Standing Committee is required.
- **(d).** If for sufficient cause the Bishop determines that consent cannot await the next meeting of the Standing Committee, the Bishop may, with the advice of the Chancellor, give written notice to the Standing Committee of the proposed real estate transaction and seek consent to the proposed action. Upon receipt of the consent of at least 50% of the Standing Committee, the Bishop may give written consent to the proposed action but shall make report thereof to the next meeting of the Standing Committee.
- **(e).** No consecrated or dedicated Church or Chapel may be removed, taken down or otherwise disposed of for any worldly or common use without the previous consent of the Bishop, acting with the advice and consent of the Standing Committee.

#### **RATIONALE:**

This Diocese's requirements for the transfer, encumbrance, or assignment of real

property are inconsistent with the requirements of The Episcopal Church Canons. The purpose of this Resolution is to bring our Canon into compliance with the dictates of the Canons of The Episcopal Church.

To amend the Vestry Election/Selection Language

**RESOLVED,** That Title IV, Canon 1, Sections 4 and 5 of the Canons of the Diocese of East Tennessee be amended as set out below:

#### TITLE IV PLACES OF WORSHIP

**CANON 1: Parishes** 

**Sec. 4.** Each Parish shall hold an annual meeting within the times stated in Section 3 of this Canon. At such meeting the Rector and the Treasurer or principal financial officer shall report to the congregation. The agenda of the meeting shall also include such other matters as may be required by the corporation laws of the Parish's state of incorporation. Notice of the time and place for the Parish meeting and the election of **or selection of members** of the Vestry shall be given at a public service of the congregation at least two weeks prior to the date of such meeting or meetings.

**Sec. 5.** Qualified voters in such election **or selection** shall be all Adult Confirmed Communicants in Good Standing of the Church registered in the Parish.

#### **RATIONALE:**

This Canon was amended in the past after a thorough discussion in hearings at Convention to permit a Vestry to be "selected" or "elected." These amendments are clerical in nature and proposed to make the Canon internally consistent. No new concept is added.

To delete reference to Area Commissions in Title IV, Canon 2, Sec. 1

**RESOLVED**, That Title IV, Canon 2, Sec. 1 of the Canons of the Diocese of East Tennessee be amended as set out below:

TITLE IV PLACES OF WORSHIP

**CANON 2: New Parishes** 

**Sec. 1.** A group of at least 50 Adult Confirmed Communicants canonically entitled to vote may submit to the Bishop an application to form a Parish. Upon receipt of such application, the Bishop shall forward copies thereof for written comment to any existing Parish within a 10-mile radius of the proposed location of the new Parish. Such written comments shall be sent to the Bishop within sixty (60) days of receipt of the application. After the expiration of such sixty (60) day period, the Bishop shall send the application, together with the Bishop's comments and any written comments received from the existing Parishes, to the Standing Committee for its consideration and consent. If the Standing Committee consents and the Bishop concurs, Articles of Association, as set forth in Section 2 below, shall be signed and forwarded to the Convention and, upon the affirmative vote of the Convention, the Parish shall be established. For good cause, so stated, the Bishop may shorten the sixty (60) day period to no less than twenty (20) days.

#### **RATIONALE:**

This Resolution is an edit of Title IV, Canon 2, to eliminate language regarding Area Commissions.

# Bishop's Address to February Session of the 33rd Annual Convention of the Episcopal Church in East Tennessee February 10-11 and July 28, 2017

## LIVING LOCAL: JOINING GOD

#### **Opening Remarks**

Welcome to the 33rd annual convention of the Episcopal Church in East Tennessee!

Thank you – each and every one – for devoting the time, energy, and money to be here. I know how valuable all of those are, and all of us are grateful for your commitment! Thank you.

I want to say "thank you" to the incredible team of staff colleagues I work with.

These colleagues are: Pat Grace, Alex Haralson, Beverly Hurley Hill Brad Jones, Vikki Myers, Laura Nichols, Kirby Purjet, and Lisa Whitacre. These people are incredible, and they do a great deal for me and for you.

As they all stand, would you please join me in expressing gratitude for them?

A special thank you also to:

- St. Thomas, Elizabethton, and St. Mark's, Copperhill hosts for this convention
- Resurrection, Loudon host for the Commission on Ministry (COM) discernment retreats, and many others events
- St. Paul's, Chattanooga providing a Chattanooga office for me
- Many wonderful volunteers, helpers, and cheerleaders
- Many others hosting clergy gatherings and diocesan meetings THANK YOU!

We created a short mission statement a few years ago for all of our conventions, and it is: "celebrating, inspiring, and equipping."

So – all that we do over these next two days should connect with those. CELEBRATING, INSPIRING, EQUIPPING – doesn't that sound like a good way to spend this time together?

We have much to celebrate:

- our life together as followers of Jesus;
- the powerful ministries of our parishes, worshiping communities and college chaplaincies;
- the outreach and justice ministries that go beyond these individual communities;
- and much, much more!

There will be so much inspiring as we're together as well: Videos of:

- Grace House in Athens;
- a ministry at the Loudon County Jail;
- a ministry of presence in a local establishment in Knoxville;
- a reading camp put on by St. Stephen's, Oak Ridge;
- ChattEY the youth of all the parishes in the Chattanooga area;
- And, of course Grace Point!

There are exciting exhibitors, presentations by Alan Roxburgh, music by Fran McKendree, stories about justice ministry and licensed lay ministries, singing and praying, and tomorrow – our closing Eucharist with Dean Alexander of Sewanee preaching, and the ordination of 6 transitional deacons. Doesn't that sound inspiring??

Having spent time with Alan, I know that his time with us will equip us in our lives and ministries, as will our conversations with each other.

So – here we go!

#### **Address**

To be clear – this is not a "farewell address." We have lots left to do, and plenty of time later for that.

Why are you here?

Not an existential question – why do you exist – but, why are you here on a weekend at a hotel with a bunch of Episcopalians?

The clergy and seminarians have to be here, but what about the rest of you?

Gets you out of the house, off work for a couple of days?

You've heard the food is good and the banquet entertainment is awesome?

Your parish couldn't shame anyone else to come?

Your rector offered 10 million kingdom points and a rebate on your pledge?

You heard Alan Roxburgh is a rock star and you love Canadians?

I believe you are here because you love your parish and the Episcopal Church, you love God, and you

love each other.

Because somewhere along the way – you were loved and accepted for who you are at some church, somewhere.

Or you wouldn't be here.

Sound right? Don't you want that for all of God's people?

Now, would please you take a moment – close your eyes – and imagine what your parish will look like in 20 years.

What do you see – anything different? What feelings does this bring up in you? Excitement? Grief? Others?

Now – take another moment and imagine what you *hope and dream* your parish will look like in 20 years.

What does that feel like? Is it different from before?

Over the past several years, we've talked a lot about mission; about being missional or mission-ish; about 5 marks of mission, and much more.

We've had some powerful speakers, and we have yet another one in Alan Roxburgh. Our theme again reminds us that mission IS possible.

Without using that word very much, I want to invite you to focus on one specific aspect of that.

It is that we – the church, the followers of Jesus – are sent out.

Out.

Outside of our church buildings; outside of our secure and safe social groups; outside of our comfort zones.

Out.

Out into the world.

Out.

A significant part of our focus for this convention, and for the Living Local: Joining God initiative, is that we are sent out into the neighborhood.

The reason we're sent out into the neighborhood is because we believe that God has gone there before us, and is present and active in the neighborhood.

So we are joining God; joining God who is already there.

On Christmas day, or the first Sunday of Christmas, we always read the prologue to John's Gospel. You know – In the beginning ... and the Word became flesh and dwelt among us ...

Here's another translation – John 1:9-14 – The Message:

The Life-Light was the real thing: Every person entering Life he brings into Light. He was in the world, the world was there through him, and yet the world didn't even notice. He came to his own people, but they didn't want him. But whoever did want him, who believed he was who he claimed and would do what he said. He made to be their true selves, their child-of-God selves. These are the God-begotten, not blood-begotten, not flesh-begotten, not sex-begotten.

The Word became flesh and blood, and moved into the neighborhood. We saw the glory with our own eyes, the one-of-a-kind glory, like Father, like Son, Generous inside and out, true from start to finish.

The word became flesh and blood and moved into the neighborhood.

That is – God, in the person of Jesus – has become one of us – flesh and blood, a real person – and is here, with us – even now.

Noted author and speaker Joan Chittister, in one of her books about prayer, said that our primary challenge with prayer is that "We pray as if God were absent."

And we do – don't we?

We pray as if God were far away, up in the clouds or heavens – somewhere else besides here. Do we believe that? Do you believe that?

I think most of us would say we don't believe it, but we act like it, don't we?

Friends – God is present – right here, right now – always and forever – in our lives and families and neighborhoods.

I remember one time on retreat at the Society of St. John the Evangelist (SSJE), my spiritual director had me do two exercises of prayer. One was to take a walk, imagining Jesus walking beside me, and the other was to set up two chairs facing each other and sit down and have a conversation with Jesus.

Yes – it felt a little strange. But why should it – I do actually believe Jesus is ever present – always right here. I just don't act like it all the time.

When our children were in middle school we had a favorite TV show – Joan of Arcadia. Do any of you remember that? It was about a teenage girl and her family, and God regularly spoke to Joan – in the person of various kinds of people: a teacher, a handyman, a child on a swing at the park, a bus driver, a cute boy, the school lunch lady – ordinary people.

It was fun! The God portrayed was very accurate in my opinion. Do you know what the theme song was? Joan Osborne's "What if God was one of us?"

Hmm – what if God WAS one of us?

Being a good Episcopalian, I have to quote the BCP, right? I have already quoted the Bible. In the third Eucharistic Prayer – Prayer C – the presider prays on behalf of us:

Lord God of our Fathers and Mothers:

world in his name.

God of Abraham and Sarah, Isaac and Rebekah, Jacob and Leah and Rachel, Open our eyes to see your hand at work in the world about us.

Deliver us from the presumption of coming to this Table for solace only, and not for strength; for pardon only, and not for renewal.

Let the grace of this Holy Communion make us one body, one spirit in Christ, that we may worthily serve the

And the people respond: Risen Lord, be known to us in the breaking of the Bread.

Open our eyes to see your hand at work in the world about us.

I love that – we believe that God's hand is at work, but we need to pray for our eyes to be opened to see that happening.

Of course, there must be a short disclaimer to say that we have to be VERY careful how we describe God's work; we can't be claiming God's activity when something good happens to me, and something not so good happens to someone else. God is not some puppet master or Santa Claus pulling strings and rewarding the nice and punishing the naughty.

The point is – God has become one of us – flesh and blood, in our neighborhood, present, here and now.

One of the powerful ways I've seen God present over the past year is in a movement in Knoxville that has now officially been named Justice Knox.

Over the past two-plus years, clergy and lay leaders have been meeting, praying, studying scripture and discerning God's invitation to create a justice ministry organization.

An incredibly diverse group of people – black/white, women/men, young/old, rich/poor, Episcopalian, Lutheran, Presbyterian, Roman Catholic, Baptist, AME, AME Zion, Methodist, Pentecostal, Jewish – you name it – they've been around the table.

Our own John Mark Wiggers of St. James, Knoxville, is co-president along with Chris Battle, pastor of Tabernacle Baptist Church in East Knoxville, and Marjorie Thigpen Carter of Good Shepherd, Knoxville, has been called as the lead organizer. Several of our parishes are very active and involved.

This is incredible grassroots action by people of faith who care and are committed to working together for their community. I believe this is one of the most significant ways God's people can respond to the issues in their communities and neighborhoods.

Marjorie will have a few minutes tomorrow to share with you, and she will tell you more.

I heard a series recently on the TED radio hour called "Screen Time." As you might guess, it is about our devices – computers, phones, etc. – and how they impact our lives. Much of it wasn't actually about the devices, but about the ways we use them – especially social media.

As with many things in our lives, the things themselves are morally neutral, but the ways we use them are where the danger and opportunity come in. For instance, I was told this address may be on Facebook Live. Now that may be dangerous! And some of you are tweeting throughout the convention – hopefully being kind and respectful

The primary platform of social media I regularly use is Facebook. It helps me keep up with my children, family, and friends; it brings all of my sports sites right to me in one place; and, it brings me access to articles, blogs, books, and events posted by friends that I would never be able to keep up with on my own.

Then there are those other things ... I can scroll past the pictures of animals, food, and all those things, but – any of you who use FB know that there are posts, memes, and check-ins that express some pretty strong and raw emotions – about everything in the world – and these days, mostly politics.

Actually, the posts themselves are not necessarily always that bad, it's the comments. Can you believe some of the things people say – not just out there – but to a person?!!

I hope they would never speak face to face like that. Would they?

I wonder how many of us have "unfollowed" or "unfriended" "friends" over the past few months? I know I have. So — what kind of relationship do we have with our FB friends? How about our real live friends? How well do we know one another? How much do we really know about one another?

To make a small shift – how well, if at all, do we know the people who live closest to us? I wonder how many of us know the people who live near us, next door to us, down the street from us? How many of us even know their names? I'm betting not that many.

We can say, "Well, that's just the way the world is these days." We probably even have said that. Is that reasonable? Is it okay with us?

As Alan mentioned in his book, and I read in *The Vanishing Neighbor*, the word "neighborly" used to mean someone you could borrow a cup of sugar from, or someone who would watch your children while you ran to the store. Now, being "neighborly" – being a "good neighbor" means being quiet and keeping to yourself. Is that how we really want things? Is that the kind of relationship we want with the people who live close to us?

We used to sit on our front porches and interact with the neighborhood, but now we sit on our back decks with fences all around.

Do we really need that "safety" and security? I'm an introvert and appreciate my quiet, alone time as much as the next person, but that seems to me very isolating and lonely.

We have partnered with The Missional Network, a group founded by Alan Roxburgh which includes Dwight Zscheile (our contact), and they are working with the dioceses of East Tennessee, Southwest Virginia, Maine, and Connecticut in an initiative called Living Local: Joining God.

Robert Hartmans was on our staff and was the "point person" for this initiative, but he is now the Priest in Charge at St. Alban's, Hixson. Beverly Hurley Hill, our newly minted Canon for Mission and Lay Ministry is now the point person, and there are five parishes/groups actively engaged in the initiative. They are:

- St. Timothy, Signal Mountain
- Good Samaritan, Knoxville
- St. Raphael, Crossville
- St. Alban's, Hixson and
- Christ Church/Southside Abbey/Project Canterbury, Chattanooga

They have committed to a two year process of five practices:

- Discerning and deciding
- Deep listening
- Reflecting, discerning, and reporting
- Experimenting
- Reflecting and deciding.

You read about these practices in Alan's book – and one of the great things is that these practices can become ways of life for us, approaches to our everyday living.

There is a diocesan team, there are guiding teams for each parish/cluster – each having a trained coach to work with them, and there are learning communities made up of:

All the guiding teams

- All the clergy from those parishes
- All the coaches
- All the bishops

The idea is that the things learned in this process will be shared, reflected upon, and result in further learning about how we join in what God is up to in the neighborhoods.

The Bishop and Council, the Standing Committee, the diocesan staff – all will be invited to listen and learn from this process.

There is a great deal of training and meeting together around this initiative, and we are very fortunate to have Dwight Zscheile working closely with us, as well as Alan Roxburgh and another of their colleagues – Craig van Gelder.

As I said last year, the Bishop and Council awarded a grant for startup and the first two years, and another mission growth fund started explicitly for this kind of initiative will fund most of the rest of the expenses. The parishes participating will fund a small part of the expenses as well.

Please know that this is a lay-led process; the clergy's role is to listen and learn from what the teams have learned. Beverly is the primary guide. What better role for the Canon for Mission and Lay Ministry?

The hope of all this is that the lay leaders – who are, remember – the primary order of ministry in the church – will from the grassroots perspective discern what God is up to in their neighborhoods, and discern how to then be the church. And the ultimate hope is for transformation – for all of us!

I have said that besides all the regular, ongoing visitations, meetings, and events that I have coming up, my two primary focuses this year will be: encouraging and cheering for Living Local: Joining God, and Supporting Grace Point.

We have so much to be grateful for – to be inspired by and celebrate at Grace Point: One of the most beautiful pieces of property in all of God's creation. When the property was first acquired 15 or so years ago, there were a few usable buildings, and in a campaign at that time, several others were built – most notably St. Paul's Chapel and two beautiful Tree Houses (cabins).

Since then, a new art barn was built by Brad Jones and a group of volunteers, and we have a beautiful new pool and pavilion made possible by Roy Cockrum and the Woody family. The exterior of the retreat house is being renovated even as we speak.

Grace Point got a grant to do some renovation on one of the old barns, and it will serve as an outdoor education center, along with several bee hives with the assistance of John Dukes.

Brad Jones, our executive director of Grace Point, is an absolute godsend! His oversight of the staff and property, his building and construction experience, and most of all his tender heart and love for children and youth — and even adults — has transformed the spirit and mission of Grace Point. He has recruited and nurtured gifted summer staffs, and built up the summer camping program, along with outreach camps and even a new winter camp session. We are so, so fortunate to have Brad!

Here's the equipping part: the piece that is missing for Grace Point to be the total jewel it is destined to be, is comfortable and usable lodging for adults.

We have plans for a 22 bedroom lodge – with private baths and meeting and office space, as well as renovation and expansion of the Commons Building and kitchen – and I have begun a major gifts initiative to raise around \$3 million. Our plan is to open up the process later this spring to ask every parish and person in the diocese to participate. look forward to sharing more about this in the near future.

And it's not just about bricks and mortar; it's about providing a context for vestries and clergy and parish groups and outside groups to have a context to get away, to retreat, to have holy time and space to discern how and where God is calling us – in the neighborhood and in the church.

Grace Point – for those of us who have spent any time there – is already holy ground. Providing facilities for adults – in addition to those we already have for children and youth – to be there, to dwell there, to drink in that sacred ground – that's what we're after.

I shared this before, and I want to say it again: Hendree Harrison and the good people of St. Paul's in Athens say: The question we always try to have before us is: "are we offering a compelling vision of a way of life worth living?"

A way of life worth living. Wow!

Some of the most powerful, formational, spiritual years of my life were the years I spent as a summer camp counselor at Camp Weed in North Florida. In the context of an intense Christian community, we young adults – mostly college students – were taught to be Christian leaders – to welcome and support and encourage and accept and love every single child who came to us.

And, especially to keep watch for those on the margins, and invite them in. In that camp setting — and it's the same at Grace Point and every other church camp I know of — the Christian community is at its best — incorporating and nurturing people who often don't find acceptance anywhere else in their lives. I believe with all my heart that THAT is a way of life worth living. It's compelling to me, and I hope for you as well.

We who are followers of Jesus in this part of God's church in East Tennessee must continue to ask that question of ourselves and our churches, and strive to make it so.

God has given us all the gifts we need to do so.

I hope – for the sake of our children, and grandchildren that we use those gifts.

Speaking of children ... Hum the song ...

You know that song? One of the best known songs about neighbors by one of the great – and I mean GREAT - theologians of our time – Fred Rogers, or Mister Rogers to most of us.

Lest we trivialize his theology, hear from him:

"When I say it's you I like, I'm talking about that part of you that knows that life is far more than anything you can ever see or hear or touch. That deep part of you that allows you to stand for those things without which humankind cannot survive. Love that conquers hate, peace that rises triumphant over war, and justice that proves more powerful than greed." — Fred Rogers

That sounds like a beautiful day in the neighborhood!

Success. To laugh often and much; to win the respect of intelligent people and the affection of children; to earn the appreciation of honest critics and endure the betrayal of false friends; to appreciate beauty, to find the best in others; to leave the world a bit better, whether by a healthy child, a garden patch or a redeemed social condition; to know even one life has breathed easier because you have lived. This is to have succeeded. Inaccurately attributed to Ralph Waldo Emerson.

We sometimes say our ultimate goal is faithfulness more than success, but I think this kind of success is pretty faithful!

May God bless us with discomfort at easy answers, half-truths, and superficial relationships, so that we may live deep within our hearts.

May God bless us with anger at injustice, oppression, and exploitation of people, so that we may work for justice, freedom, and peace.

May God bless us with tears to shed for those who suffer from pain, rejection, hunger, and war, so that we may reach out our hands to comfort them and turn their pain into joy.

And may God bless us with enough foolishness to believe that we can make a difference in this world, so that we can do what others claim cannot be done, to bring justice and kindness to all our children and the poor.

We CAN make a difference in this world – you and I and our church. So – let's get OUT and do it!

So – here we go!

#### **Address**

To be clear – this is not a "farewell address." We have lots left to do, and plenty of time later for that.

Why are you here?

Not an existential question – why do you exist – but, why are you here on a weekend at a hotel with a bunch of Episcopalians?

The clergy and seminarians have to be here, but what about the rest of you?

Gets you out of the house, off work for a couple of days?

You've heard the food is good and the banquet entertainment is awesome?

Your parish couldn't shame anyone else to come?

Your rector offered 10 million kingdom points and a rebate on your pledge?

You heard Alan Roxburgh is a rock star and you love Canadians?

I believe you are here because you love your parish and the Episcopal Church, you love God, and you love each other.

Because somewhere along the way – you were loved and accepted for who you are at some church, somewhere.

Or you wouldn't be here.

Sound right? Don't you want that for all of God's people?

Now, would please you take a moment – close your eyes – and imagine what your parish will look like in 20 years.

What do you see – anything different? What feelings does this bring up in you? Excitement? Grief? Others?

Now – take another moment and imagine what you *hope and dream* your parish will look like in 20 years.

What does that feel like? Is it different from before?

Over the past several years, we've talked a lot about mission; about being missional or missionish; about 5 marks of mission, and much more.

We've had some powerful speakers, and we have yet another one in Alan Roxburgh. Our theme again reminds us that mission IS possible.

Without using that word very much, I want to invite you to focus on one specific aspect of that.

It is that we – the church, the followers of Jesus – are sent out.

Out.

Outside of our church buildings; outside of our secure and safe social groups; outside of our comfort zones.

Out.

Out into the world.

Out.

A significant part of our focus for this convention, and for the Living Local: Joining God initiative, is that we are sent out into the neighborhood.

The reason we're sent out into the neighborhood is because we believe that God has gone there before us, and is present and active in the neighborhood.

So we are joining God; joining God who is already there.

On Christmas day, or the first Sunday of Christmas, we always read the prologue to John's Gospel. You know – In the beginning ... and the Word became flesh and dwelt among us ...

Here's another translation – John 1:9-14 – The Message:

The Life-Light was the real thing:
 Every person entering Life
 he brings into Light.

He was in the world,
 the world was there through him,
 and yet the world didn't even notice.

He came to his own people,
 but they didn't want him.

But whoever did want him,
 who believed he was who he claimed
 and would do what he said,

He made to be their true selves,
 their child-of-God selves.

These are the God-begotten, not blood-begotten, not flesh-begotten, not sex-begotten.

The Word became flesh and blood, and moved into the neighborhood. We saw the glory with our own eyes, the one-of-a-kind glory, like Father, like Son, Generous inside and out, true from start to finish.

The word became flesh and blood and moved into the neighborhood.

That is – God, in the person of Jesus – has become one of us – flesh and blood, a real person – and is here, with us – even now.

Noted author and speaker Joan Chittister, in one of her books about prayer, said that our primary challenge with prayer is that "We pray as if God were absent."

And we do - don't we?

We pray as if God were far away, up in the clouds or heavens – somewhere else besides here. Do we believe that? Do you believe that?

I think most of us would say we don't believe it, but we act like it, don't we?

Friends – God is present – right here, right now – always and forever – in our lives and families and neighborhoods.

I remember one time on retreat at the Society of St. John the Evangelist (SSJE), my spiritual director had me do two exercises of prayer. One was to take a walk, imagining Jesus walking beside me, and the other was to set up two chairs facing each other and sit down and have a conversation with Jesus.

Yes – it felt a little strange. But why should it – I do actually believe Jesus is ever present – always right here. I just don't act like it all the time.

When our children were in middle school we had a favorite TV show – Joan of Arcadia. Do any of you remember that? It was about a teenage girl and her family, and God regularly spoke to Joan – in the person of various kinds of people: a teacher, a handyman, a child on a swing at the park, a bus driver, a cute boy, the school lunch lady – ordinary people.

It was fun! The God portrayed was very accurate in my opinion. Do you know what the theme

song was? Joan Osborne's "What if God was one of us?"

Hmm – what if God WAS one of us?

Being a good Episcopalian, I have to quote the BCP, right? I have already quoted the Bible. In the third Eucharistic Prayer – Prayer C – the presider prays on behalf of us:

Lord God of our Fathers and Mothers:

God of Abraham and Sarah, Isaac and Rebekah, Jacob and Leah and Rachel, Open our eyes to see your hand at work in the world about us.

Deliver us from the presumption of coming to this Table for solace only, and not for strength; for pardon only, and not for renewal.

Let the grace of this Holy Communion make us one body, one spirit in Christ, that we may worthily serve the world in his name.

And the people respond: Risen Lord, be known to us in the breaking of the Bread.

Open our eyes to see your hand at work in the world about us.

I love that – we believe that God's hand is at work, but we need to pray for our eyes to be opened to see that happening.

Of course, there must be a short disclaimer to say that we have to be VERY careful how we describe God's work; we can't be claiming God's activity when something good happens to me, and something not so good happens to someone else. God is not some puppet master or Santa Claus pulling strings and rewarding the nice and punishing the naughty.

The point is – God has become one of us – flesh and blood, in our neighborhood, present, here and now.

One of the powerful ways I've seen God present over the past year is in a movement in Knoxville that has now officially been named Justice Knox.

Over the past two-plus years, clergy and lay leaders have been meeting, praying, studying scripture and discerning God's invitation to create a justice ministry organization.

An incredibly diverse group of people – black/white, women/men, young/old, rich/poor, Episcopalian, Lutheran, Presbyterian, Roman Catholic, Baptist, AME, AME Zion, Methodist, Pentecostal, Jewish – you name it – they've been around the table.

Our own John Mark Wiggers of St. James, Knoxville, is co-president along with Chris Battle, pastor of Tabernacle Baptist Church in East Knoxville, and Marjorie Thigpen Carter of Good Shepherd, Knoxville, has been called as the lead organizer. Several of our parishes are very

active and involved.

This is incredible grassroots action by people of faith who care and are committed to working together for their community. I believe this is one of the most significant ways God's people can respond to the issues in their communities and neighborhoods.

Marjorie will have a few minutes tomorrow to share with you, and she will tell you more.

I heard a series recently on the TED radio hour called "Screen Time." As you might guess, it is about our devices – computers, phones, etc. – and how they impact our lives. Much of it wasn't actually about the devices, but about the ways we use them – especially social media.

As with many things in our lives, the things themselves are morally neutral, but the ways we use them are where the danger and opportunity come in. For instance, I was told this address may be on Facebook Live. Now that may be dangerous! And some of you are tweeting throughout the convention – hopefully being kind and respectful

The primary platform of social media I regularly use is Facebook. It helps me keep up with my children, family, and friends; it brings all of my sports sites right to me in one place; and, it brings me access to articles, blogs, books, and events posted by friends that I would never be able to keep up with on my own.

Then there are those other things ... I can scroll past the pictures of animals, food, and all those things, but – any of you who use FB know that there are posts, memes, and check-ins that express some pretty strong and raw emotions – about everything in the world – and these days, mostly politics.

Actually, the posts themselves are not necessarily always that bad, it's the comments. Can you believe some of the things people say – not just out there – but to a person?!! I hope they would never speak face to face like that. Would they?

I wonder how many of us have "unfollowed" or "unfriended" "friends" over the past few months? I know I have. So – what kind of relationship do we have with our FB friends? How about our real live friends? How well do we know one another? How much do we really know about one another?

To make a small shift – how well, if at all, do we know the people who live closest to us? I wonder how many of us know the people who live near us, next door to us, down the street from us? How many of us even know their names? I'm betting not that many.

We can say, "Well, that's just the way the world is these days." We probably even have said that. Is that reasonable? Is it okay with us?

As Alan mentioned in his book, and I read in *The Vanishing Neighbor*, the word "neighborly" used to mean someone you could borrow a cup of sugar from, or someone who would watch

your children while you ran to the store. Now, being "neighborly" – being a "good neighbor" means being quiet and keeping to yourself. Is that how we really want things? Is that the kind of relationship we want with the people who live close to us?

We used to sit on our front porches and interact with the neighborhood, but now we sit on our back decks with fences all around.

Do we really need that "safety" and security? I'm an introvert and appreciate my quiet, alone time as much as the next person, but that seems to me very isolating and lonely.

We have partnered with The Missional Network, a group founded by Alan Roxburgh which includes Dwight Zscheile (our contact), and they are working with the dioceses of East Tennessee, Southwest Virginia, Maine, and Connecticut in an initiative called Living Local: Joining God.

Robert Hartmans was on our staff and was the "point person" for this initiative, but he is now the Priest in Charge at St. Alban's, Hixson. Beverly Hurley Hill, our newly minted Canon for Mission and Lay Ministry is now the point person, and there are five parishes/groups actively engaged in the initiative. They are:

- St. Timothy, Signal Mountain
- Good Samaritan, Knoxville
- St. Raphael, Crossville
- St. Alban's, Hixson and
- Christ Church/Southside Abbey/Project Canterbury, Chattanooga

They have committed to a two year process of five practices:

- Discerning and deciding
- Deep listening
- Reflecting, discerning, and reporting
- Experimenting
- Reflecting and deciding.

You read about these practices in Alan's book – and one of the great things is that these practices can become ways of life for us, approaches to our everyday living.

There is a diocesan team, there are guiding teams for each parish/cluster – each having a

## Convention Reports

### Report of the Standing Committee of the Diocese of East Tennessee to The Thirty-Third Annual Convention of the Diocese

Each year it is the duty and the privilege of the Standing Committee to report to the Diocese. The Standing Committee serves, among other things, as a council of advice to the Bishop – advice which he may solicit or advice which we may offer on our own initiative. We are grateful for and have enjoyed the open and honest relationship we have with Bishop Young.

We had an extra and bittersweet duty this year: it is the Canonical duty of the Standing Committee, upon hearing the current Bishop's announcement of his plan to retire, to oversee the transition process. We contracted with the Rev. Dr. Diane Vie to serve as Consultant to us in this whole process. We recruited, appointed and charged the Search and Nominating Committee; we recruited and appointed the Transition Committee whose task is to see to the accomplishment of the "walkabouts", and the orderly transition (good bye to the retiring Bishop and family and welcome to the incoming Bishop and family). We set the date (April 28, 2017) for the SNC to give 3-5 names to the Standing Committee of persons who will stand for election (to be held at St. John's Cathedral on July 28, 2017); (nominations by Petition, if any, will be received from 4/28 until 5/12); and we set the date for the Ordination and Consecration of the 5<sup>th</sup> Bishop of East Tennessee for December 2, 2017.

The Standing Committee has several other canonical duties, among which are:

We must consider whether to consent to the ordination and consecration of any person elected Bishop anywhere in the Episcopal Church. We consented to several such requests this year.

We must meet with any postulant for Holy Orders in the Diocese and vote to affirm that each has met all requirements before the Bishop may declare that person is a Candidate for Holy Orders. We also must act to approve the ordination to the Diaconate and again to the Priesthood of any person seeking such ordination. We were privileged this year to meet and recommend many fine people (recommended to us through the good work of the Commission on Ministry) for Candidacy and then for Ordination.

All real property of any Church or Church agency in the Diocese is held in trust for the Diocese. Any proposed acquisition, sale or encumbrance of Church property in the Diocese must have the approval of the Standing Committee before it may occur. To any who are contemplating the acquisition, alienation or encumbrance of any Church property in the year 2017, please acquaint yourselves with the relevant Standing Committee Policies (available on the Diocesan Website) so that you and we may act expeditiously and timely. We took the following actions this year regarding property:

- ✓ Approved the sale of property held by Grace Church, Chattanooga.
- ✓ Affirmed the action taken by All Saints School, Morristown, to modify their loan.
- ✓ Affirmed the action taken by St. Christopher's Kingsport, to sell the right-of-way to the Colonial Heights Sanitary Sewer Extension Project.
- ✓ Approved the application from St. Paul's, Kingsport, to the Opportunity Fund for a loan.
- ✓ Approved the sale of the remaining property of St. Mathews, Dayton.
- ✓ Approved the request by St. Paul's, Seymour, to request a loan from the Opportunity Fund (contingent upon their having received a grant from that Fund.).

The Standing Committee schedules a monthly meeting, but we actually meet only in those months when there is business which requires our attention and action. There is also a formal procedure (now posted on the Diocesan Website) for meeting electronically when urgency requires it. This year we will have held eight face-to-face meetings and one by electronic means. Consult the Diocesan Website for the monthly meeting day.

Another duty of the Standing Committee is to devise a process by which our Committee, with the Bishop, may accomplish a review of the ministry of the Diocese over the past year. The task is to review our ministry as Diocese; it is NOT a job performance review of the Bishop.

I here want to acknowledge my great appreciation for the collegiality and good work this year of, and my affection for, the members (three lay and two other clerical) of the Standing Committee. #### Report of the Appalachian Ministry Resource Team January 2107

The goals of the AMRT are 1) to provide opportunities for mission work and 2), to connect individuals with community resources in the Appalachian region. The team currently consists of 10 members representing parishes from Harriman, Knoxville, Norris, Oak Ridge, Chattanooga and others. Many of our committee members have served over ten years, and we are seeking additional members, especially from the southern part of the Diocese.

Our project for 2015 was the successful establishment of a Reading Camp, held at the Episcopal School of Knoxville June 8-14. The reading camp is designed to provide positive learning experiences for struggling readers grades 3-5 to increase their attitudes towards and appreciation of reading.

While the goal of AMRT for 2016 was to continue the camp in Knoxville and to expand the camp to the Chattanooga area, the "champion" for the camp retired from the committee and we lost momentum. But the good news is that we have found two new champions, full of energy, one in Knoxville and one in Chattanooga. We are hopeful of conducting the camps in both cities this summer.

St. Stephens, Oak Ridge, conducted a reading camp last summer in Clairfield, TN. AMRT supported that camp with a donation of \$3,000.

AMRT conducts an annual "pilgrimage" with the Bishop, visiting selected outreach ministries in East Tennessee. In September our pilgrimage visited the Thankful Memorial's (Chattanooga) Reading Room, Southside Abbey (Chattanooga), and Grace House, an outreach of St. Paul's (Athens) providing residence for homeless men. Much was learned on these visit. Please note that anyone from the Diocese, not just committee members, are welcome to participate in the pilgrimages. We will announce this year's itinerary this spring. Watch for the announcement in your parish newsletter.

#### Report of the Commission on Ministry to the 2017 Convention

#### of the Diocese of East Tennessee

The Commission on Ministry (COM) consists of 15 people, lay ministers, priests, and deacons, who assist the bishop with "the determination of present and future opportunities and needs for the ministry of all baptized persons" in the Diocese of East Tennessee. A primary function of the COM is to facilitate the discernment process for East Tennessee Episcopalians who are discerning a call to ordained ministry.

The Commission on Ministry met 5 times in 2016 and facilitated a discernment retreat for aspirants in August in Loudon, Tennessee at the Episcopal Church of the Resurrection.

The COM seeks to continually encourage all Christ-followers to enter into discernment activity around call to ministry as all the baptized are indeed ministers!

The COM has developed a discernment calendar and handbook (on the web now) to help guide formal discernment conversation and activities. As you know, the bishop gives the "go-ahead" for aspirants to ordained ministry to begin COM-supported local discernment work beyond Clergy/Aspirant conversations. The diocesan discernment process is on hold right now as we move through the bishop transition, but we plan to open it back up in the fall. Stay tuned!

At present the Episcopal Diocese of East Tennessee has 14 people on the journey to ordination. We have 6 candidates for the priesthood, 5 priest postulants, 3 deacon postulants. Several of our folks in the process will be ordained at this convention.

The COM invites your prayers for these folks as they journey on.

## Report to the 33rd Annual Convention of the Diocese of East Tennessee February 2017



Du Bose Conference Center is the historic retreat and gathering-place of the Episcopal Church in Tennessee, and serves numerous other educational, religious, and arts groups through its hospitality and programming. Our programs include Camp Gailor-Maxon, a Tennessee summer camp for Episcopal youth, and Winterfest, the annual retreat between Christmas and New Years, for high school age youth. DuBose is also the home of the Episcopal Churchmen of Tennessee Annual Conference, the ECW, and many other church and secular groups.

DuBose is a 501(c)3 non-profit governed by an independent 19-member board of directors, and its property and assets are jointly owned by the three Episcopal dioceses of Tennessee. The three Tennessee bishops each serve as ex-officio members of the Board; the Diocese of Tennessee appoints two other board members while the Dioceses of East and West Tennessee each appoint one board member. BOD Officers in 2017 are Randy Schulte, President;, Connally Penley, Vice President; Elise Dugger, Secretary; and JP Hickey, Treasurer and Bob Sarratt, Past-President. East TN's Bishop-appointed representative on the board is Greg Champion of St. Martin's Chattanooga.

The DuBose staff is led by East Tennessee native David Ramsey, Executive Director, a communicant of St. Paul's Chattanooga. He and his wife Sarah have moved to the Mountain and live in Walker House. The leadership team includes Stephanie Kelley, Guest Services Manager; Lorrie Coutu, Office Manager; Angela Lanier, Kitchen Manager; and Justin Kilgore, Maintenance Manager. In 2017 Win Bassett will serve as Director of Camp Gailor-Maxon.

The DuBose Board has created a strategic plan for the organization which will help it double revenue by the end of 2020. Currently, with the help of Johnson, Johnson, and Crabtree Architects, we have completed a Master Plan for the buildings and grounds, underwritten by a grant from St. George's Nashville, to make the center sustainable into the future.

DuBose continues to improve its facilities and operations through the generous support of donors, friends, and volunteers. DuBose is preparing to launch a capital campaign called *Vision 20/20* to begin to address some of the most critical physical plan and capital needs and to begin down the path of Phase I of the Master Plan. the women of the Diocese of East Tennessee have been busy and productive during the past year. Following are a few highlights.

We had a great presence at the 2016 Diocesan Convention, where we told convention attendees and many others about our mission project for the year. In support of the Episcopal Diocese of Jerusalem, we had a table full of craft items from PalCraft Aid. The items purchased were not only beautiful and functional, but the funds raised directly support those persons living in that war torn Diocese.

The annual Tri-Diocesan retreat was hosted by East Tennessee, and held at DuBose Conference Center in April. The theme for Province IV has been Building Bridges of Peace and Reconciliation, with the first year's emphasis on self and family. Our keynote speaker, The Rev. Mary Catherine Akamatsu, kept us focused and engaged. Other activities included a tour of St. Mary's convent, plus the ever-popular "Conversation"

with the Bishops" after our Friday evening meal.

In June several women from East Tennessee attended the Province IV retreat held at Kanuga. Our own Pat Rutenberg is serving as President of the Province IV ECW, and she did a wonderful job as the coordinator of that event. The guest speaker was the Rev. Lindsey Hardin Freemen, author of <u>Bible Women</u>, *All Their Words and Why They Matter*.

The 32nd Annual Fall Gathering of the ECW was hosted by the women of St. Paul's, Athens on September 10. Bishop Young was the celebrant for the Eucharist, and Canon Grace was our preacher. She wove into her message the remarkable story of Constance and her Companions, brave Episcopal saints from Memphis, Tennessee.

After a short business meeting, we heard the very moving story of our speaker, Sonja DuBois, a holocaust survivor.

Our Mollie Tucker Memorial Scholarship was awarded to Mackenzie Mahan, a parishioner at St. Luke's, Cleveland. Mackenzie is currently attending Kennesaw State in Kennesaw, Georgia. She hopes to eventually work as a nurse in a neonatal intensive care unit. More information about Mackenzie can be found on the website. A fund-raising tea for the scholarship fund was held in the Great Hall of St. John's Cathedral on January 28, 2017.

## Father Matthew A. Jones School Report to the 33<sup>rd</sup> Annual Convention of the Diocese of East Tennessee February, 2017

In early 2015, Jay Secor, then Head of the Episcopal School of Knoxville, and others entered into conversations regarding the feasibility of starting a pre-K/elementary school in East Knoxville that could serve as a feeder to ESK. In addition to Mr. Secor, those involved in early discussions were Bishop George Young; Rev. Canon Pat Grace; Dr. Sylvia Peters, nationally-renowned educator; Rev. James Anderson, retired Rector of St. Luke's Knoxville; Rev. Josh Hill, Chaplain at ESK; Ms. Kerwin Frix, parent; Ms. Michelle Neal, parent; Dr. Kim Quigley, parent; Rev. Renee Kessler, Executive Director of the Beck Cultural Exchange Center; Ms. Kathy Mack, Director of the Phyllis Wheatley YWCA; and Rev. Dr. Jerry Askew, Deacon at St. Luke's Knoxville. Upon Mr. Secor's retirement, Jack Talmadge, new Head of ESK joined the group and has provided invaluable insight.

Initial discussions centered on the vision and mission of the proposed school and, early on, the group decided that, rather than define itself as a feeder for ESK, the school should seek to become an educational resource for the children and families of East Knoxville, based on an Episcopal School model, regardless of the potential for its graduates to transfer to ESK. The group also decided that the school would initially begin as a pre-K program and expand to higher grades, as appropriate, in future years. Despite hopes of an earlier start, the group determined that the earliest the school could feasibly open would be in fall of 2017.

Among the earliest considerations was the potential location for the school. All agreed that the facility needed to be located as centrally as possible and along a public transportation route. Consideration quickly focused on a building known as the Delaney House, owned by and adjacent to the Beck Cultural Exchange Center, and the Phyllis Wheatley YWCA building. Recent discussions have centered of the YWCA given that it is, for all intents and purposes, move-in ready.

Current activities include filing legal documents to become a 501(c)3 tax-exempt organization, developing an annual operating budget, identifying start-up funding, and developing a long-term, sustainable financial model, which will no doubt include significant fundraising throughout the Diocese and beyond. Among critical issues to be clarified are the relationship between the Father Jones School and the Diocese, as well as the school's relationship with ESK.

Special thanks are due to the Brotherhood of St. Andrew at The Church of the Ascension for their cleanup of the Delaney House, one of the two sites being considered for the school, and to the law firm of Anderson Busby, LLC for their pro bono legal work on our behalf.

We are currently in the fundraising stage and hope to begin construction in the very near future.

#### **Jubilee Ministries, 2016**

Serving and caring activities within our diocese of East Tennessee were abundant in 2016 at the "place where ... deep gladness and the world's deep hunger meets" (Buechner), although somewhat limited at the Diocesan level as the newly appointed Jubilee Officer learns how to serve. There are 13 Jubilee Ministries in the diocese; 6 in the South East Region, 4 Middle East Region, and 3 in the Upper East Region.

We can celebrate the presentation of Jubilee Ministry certification to Church of the Good Shepherd in Knoxville. Good Shepherd's Outreach Ministry was designated as a Jubilee center in 2015 but presentation was postponed until their new Rector, Dorothy Pratt was installed. Good Shepherd folks are engaged in numerous efforts to impact poverty and injustice including their Martha's Kitchen meals, temporarily housing the homeless with Family Promise, and FISH.

Nationally, Jubilee Ministry Grants totaling \$65,000 have been awarded to 29 centers in 22 dioceses. Several of our Centers applied for grants this year, but only one received an award. Family Cornerstones, sponsored by St Luke's in Cleveland, Tennessee, was awarded \$1500 to assist in their work towards strengthening family relationships and transitions through the "Starfish" and other programs.

The Holy Spirit moves through many parishes in our Diocese caring, defending, and attacking injustices. The Jubilee Ministry is one way that efforts can be highlighted and additional resource requested. We are not glory hounds but when we recognize God's action at the "ground level" we glorify Him who sends us.

#### Mission Report – 2017 Convention

Abraham struggled with his cultural identity so God called him out of Ur into the unknown to build a new covenant and identity. The Hebrew people struggled and labored under a Pharaoh who did not know Joseph, so God inspired Shiphrah and Puah to take a big risk leading to liberation. The Kingdom of Judah's very existence and uniqueness was being crushed by the Babylonian super power, so God traveled with the chosen into exile and into a new hard earned identity. God did these things to build a relationship that pushes the beloved into a new spiritual reality. In every instance God's people were called to practice their way into a new kind of believing.

Do we believe that God is doing that with us in this fractured and continuous time, as churches seem more interested in competing for members than in building Godly relationships? How do you listen to the new thing God is calling us into? Do we-the-church believe that God is still doing this work of building new identities and new relationships?

Five parishes: Good Samaritan, Knoxville; St. Raphael's, Crossville; St. Alban's, Hixson; St. Timothy's, Signal Mountain, Christ Church, Chattanooga along with South Side Abbey and Project Canterbury; have embarked on a process of discovery with this key question: "How do we go on a shared journey in discerning what the Spirit is doing ahead of us in our neighborhoods and communities in order to join God in those places?" They are taking this journey alongside four other dioceses: Southwest Virginia, Newark, Maine, and Connecticut. Guiding Teams for these parishes have received training to do intensive listening practices among their members and out in their communities. They will spend six months doing that work, listening, and wondering together what God is doing, all before a second training in June.

The Living Local: Joining God initiative presents five practices of listening, discerning, experimenting, reflecting, and reengaging that allow a group of lay people to become inspired by what God is up to in their surroundings. These practices are based in the belief that God is already doing something and wants us to participate in that. The Diocesan staff provides resources including coaches that help lead teams through proven practices of having holy conversations, engaging neighbors, and building community relationships.

This initiative forms numerous learning communities that all practice listening, discerning, experimenting, reflecting, and reimagining. The learning communities are networked for the benefit of learning from each other. In addition to Guiding Teams in five parishes made up of laity, we a learning community of clergy involved wonder "What are the skills and capacities I need to assist my Guiding Team and congregation in taking a journey to discern what God is doing in their local context and joining with God there?" Additionally, we've formed a learning team made up of clergy and laity from across the diocese that will exercise these practices with diocesan leaders and imagine on behalf of the Episcopal Church in East Tennessee. The Diocesan Team ponders this key question: "What are the implications of the learning taking place among congregations and clergy in this journey for the role and work of the diocese?"

### DIOCESAN YOUTH MINISTRY Report to Convention 2017

Building from efforts in 2015, the Diocesan Council on Youth Ministry (DCYM) formally launched New Beginnings, a spiritual retreat for grades 6-8, in April, 2016. This was the culmination of two years' effort, working with support from the Diocese of East Carolina. New Beginnings #1 took place at Grace Point April 8-10. East Carolina provided support with two youth and one adult, who flew in to East TN to assist us with the retreat. 16 youth and three adult participants joined us, along with a leadership team of 8 youth and 7 adults. New Beginnings #2 is scheduled to take place March 31-April 2, 2016, at Grace Point.

The Senior High Sabbath, scheduled for December 16-18 at Grace Point, shifted gears in response to the wildfires that destroyed parts of Sevier County. After some discussion leading up the event, a decision was made to relocate the retreat to Gatlinburg for a two-fold mission opportunity. First, all youth and adults were registered with Volunteer East Tennessee to work a 4-hour shift on Saturday, December 17, at the Boyd's Bears disaster relief distribution center. Second, by maintaining the original 3-day/2-night format and moving to a rental cabin just outside of downtown Gatlinburg, we were able to utilize the bulk of our budget by playing our small part in economic contribution to the Gatlinburg tourism industry.

Happening, as always, continues to offer an intimate and life-changing faith experience for high-school youth. Happening #s 70 and 71 took place in March and November, respectively, at Grace Point. It is our hope that the addition of New Beginnings will give middle-school youth a foundation on which they may continue their exploration through Happening once in high-school.

Outside of our regular diocesan youth programming, a concerted effort was made in the Chattanooga area to create a local cooperative youth ministry effort. Building from the idea of Knoxville Episcopal Youth (KEY), Chattanooga Episcopal Youth (ChattEY) brings area youth groups together once a month for common fellowship through games, meals, and worship, at a different host parish each time. ChattEY was launched following several formative meetings of Chattanooga-area youth leaders, supported by the Diocesan Youth Coordinator, to create a sense of community among parish youth leaders and to create a common vision for the beginnings of the youth gatherings. Monthly youth leaders' meetings continue, typically a week in advance of the ChattEY youth gathering. Efforts to enhance and strengthen KEY are under way.

Looking forward to 2017, we have assembled a team of youth and adults to represent East TN at the triennial Episcopal Youth Event (EYE), to be held July 10-14 in Edmond, OK. This team was selected by application to represent the diocese in as broad a sense as possible.

#### INDEPENDENT AUDITOR'S REPORT

To the Bishop and Council of the Diocese of East Tennessee Knoxville, Tennessee

#### **Report on the Financial Statements**

We have audited the accompanying financial statements of the Diocese of East Tennessee (a non-profit organization) which comprise the statement of financial position as of December 31, 2016, and the related statements of activities, and cash flows for the year then ended, and the related notes to the financial statements.

#### Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

#### **Auditor's Responsibility**

Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement.

## NOTES TO FINANCIAL STATEMENT

Year Ended December 31, 2016

## NOTE 1 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

## A. Organization

The Diocese of East Tennessee (Diocese) is a not-for-profit corporation, chartered by the State of Tennessee. Its purpose is to promote the cause of religion and to establish order and advancement for the Church in the East Tennessee geographical region.

## B. Method of Accounting

The Diocese's books and records are maintained on the accrual basis of accounting. Under this method, revenues are recognized when earned regardless of when received, and expenses are recognized when incurred, regardless of when paid.

## C. Property and Equipment

Property and equipment are carried at cost. Depreciation is computed using the straight-line method over the estimated useful lives of the assets. When assets are retired or otherwise disposed of, the cost and related gain or loss is reflected in income for the period. The cost of maintenance and repairs is charged to expense as incurred; significant renewals and betterments are capitalized. Deduction is made for retirements resulting from renewals and betterments.

## D. Financial Statement Presentation

The Diocese uses Statement of Financial Accounting Standards (SFAS) No. 117, *Financial Statements of Not-For-Profit Organizations*. Under SFAS No. 117, the Diocese reports information regarding its financial position and activities according to three classes of net assets: unrestricted net assets, temporarily restricted net assets, and permanently restricted net assets.

## E. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

## F. Contributions

The Diocese uses SFAS No. 116, Accounting for Contributions Received and Contributions Made. In accordance with SFAS No. 116, such contributions are reported as temporarily restricted support and are then reclassified to unrestricted net assets upon expiration of the time restriction. Contributions whose restrictions expire in the period donated are considered unrestricted support.

## G. Restrictions on Cash

Cash received from members and other donors for a specified purpose is designated as temporarily restricted or permanently restricted until it is used for the specified purpose.

## NOTE 1 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

## H. <u>Cash Equivalents</u>

The Diocese considers all highly-liquid investments with an original maturity of three months or less when purchased to be cash equivalents.

## I. Compensated Absences

The Diocese's policy is to pay for compensated absences when they are taken.

## J. Donated Services

The Diocese receives donated services from a variety of unpaid volunteers. No amounts have been recognized in the accompanying statement of activities because the criteria for recognition of such volunteer effort under SFAS No. 116 have not been satisfied.

## K. Concentrations of Credit Risk Arising from Cash Deposits in Excess of Insured Limits

The Diocese maintains several bank accounts with three financial institutions. These accounts are insured by the Federal Deposit Insurance Corporation up to \$250,000 at each institution. During the year and at year end, cash balances exceeded the \$250,000 FDIC coverage.

## **NOTE 2 – RETIREMENT PLANS**

## A) DEFINED BENEFIT PLAN

The Diocese participates in a defined benefit plan established and administered by the Church Pension Fund of the Protestant Episcopal Church of the United States of America. This fund is available nationally to all eligible clergy and full-time lay employees. The Church Pension Fund, a corporation chartered under the laws of the State of New York, has a board of twenty-five Trustees to oversee its operations. Twelve Trustees are elected at each General Convention to serve six-year terms. The Church Pension Fund maintains records, collects assessments, establishes investment policies, provides benefit estimates, advises clergy on their participation and benefit rights, controls expenses and provides for the payment of benefits. The Church Pension Fund has voluntarily placed itself under the supervision of the New York State Insurance Department which makes periodic reviews. Contributions are essentially eighteen (18) percent for clergy and nine (9) percent for lay staff of eligible salaries, and pension expense charged against income for the year ended December 31, 2016, was \$24,282.

## B) DEFINED CONTRIBUTION PLAN

The Diocese participates in a defined contribution plan established and administered by the Church Pension Fund. The assets of the Plan are held by the trustee, Fidelity Management Trust Company. Funding requirements are 5% for the employer, and an additional match up to 4% of the employee contributions. Pension expense charged against income for the year ended December 31, 2016 amounted to \$43,580.

## **NOTE 3 – CONTINGENT LIABILITIES**

In previous years, the Diocese has, to a limited extent, provided land on which congregations have constructed churches. Title to such land remains with the Diocese. On some occasions, third party financing is secured with the land included as collateral. Should the congregation become unable to make the mortgage payments, the Diocese could be held responsible. The extent of these third party loans is not known.

## **NOTE 5 – FAIR VALUE MEASUREMENTS**

The Emergency Fund is a broad base of investments administered and monitored by SunTrust Bank. During 1999, the Diocese's management decided to set up an operating contingency fund and invest excess monies. A separate account has been established to which monies are being deposited and withdrawn periodically as needed to fund operations.

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

## **NOTE 5 – FAIR VALUE MEASUREMENTS (Continued)**

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 1 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The Diocese's investments are held by The Episcopal Endowment Corporation (EEC). The following table presents the fair value of investments which separately represent 31 percent or more of the Diocese's net assets.

## **NOTE 6 – ENDOWMENT FUNDS**

The Diocese participates in several endowment funds, none of which have been included in the Diocese's financial statements. Income is recognized when distributions are made from these funds to the Diocese and contributions/transfers are recorded as expense when paid.

<u>The Episcopal Endowment Corporation</u> was established to handle trust funds of the Diocese, its parishes, missions, organizations, and institutions. It is shared by the Diocese of Tennessee and the Diocese of East Tennessee. The investments are directed by a board appointed by the two bishops. These funds are administered by SunTrust Bank of Chattanooga. In August 2014, SunTrust bank notified the Diocese that it would no longer administer the Opportunity and Mission Growth Funds. The funds were turned over to the Diocese and are now administered under the direction of the Diocese and are held at Pinnacle Bank.

The Opportunity Fund and The Mission Growth Fund were established by the Bishop and Council to provide for low interest loans to parishes and missions for expansion and improvements to property. The corpus is used for loans and the income is used to make grants for social ministry and church expansion. Loans and grants are recommended to the Bishop and Council by the Opportunity Fund Committee approximately twice annually.


## **NOTE 8 – PRIOR PERIOD ADJUSTMENT**

## DIOCESE OF EAST TENNESSEE SPECIAL RULES OF ORDER FOR THE ELECTION OF A BISHOP

WHEREAS, The Right Reverend George Dibrell Young, III, Bishop of the Diocese of East Tennessee, has announced his intention to resign and has called for the election of a Bishop, said election to be held beginning July 28, 2017, the third day of the Thirty-third Annual Convention of the Diocese of East Tennessee, said third day referred to herein as the "Electing Convention;" and

WHEREAS, Article XI of the Constitution of the Diocese of East Tennessee provides that the election of a Bishop of this Diocese shall be by concurrent vote of the clergy and laity in Convention assembled. The vote shall be taken by orders and a two-thirds vote on the same ballot in each order shall be necessary for the election of a Bishop; and

WHEREAS, the election of a person to be a Bishop in a Diocese shall be held in accordance with the Rules prescribed by the Convention of the Diocese and pursuant to the provisions of the Constitution & Canons of this Church (Canon III.11.1(a)) and of this Diocese (Canon VIII.4).

NOW, THEREFORE, be it resolved by the Thirty-third Annual Convention of the Diocese of East Tennessee, that the following Special Rules of Order for the Election of a Bishop shall be adopted for the guidance of the Electing Convention:

- **Rule I**. Only properly registered clergy members of the Convention and duly elected lay delegates to Convention, all of whom are defined in Diocesan Canon I.3, may cast a ballot, make any motion, or raise any point of order at the Electing Convention. All delegates must register on the day of the Election at the Electing Convention, even if registered on the prior day of Convention. No proxy voting or voting by absentee ballot is permitted. All delegates shall be seated in their assigned pews in order to vote.
- **Rule II.** The person shall be elected from among the Nominees and the Nominees-by-Petition. Nominations shall not be allowed from the floor. A Nominee or Nominee-by-Petition may withdraw from the election at any time by telephone, fax, email or other electronic communication, or by designated representative or other authorized representative.
- **Rule III**. Persons other than those specified in Rule I may be authorized privileges of the Convention, except vote, as set forth in Diocesan Canon I.3. In addition, non-clergy and non-delegate members of the Diocesan Search and Transition Committees are entitled to seat and voice.
- **Rule IV**. The President of the Convention is the Diocesan Bishop. In the event the Bishop is unable to preside, the Standing Committee shall select a clergy member of the Convention to preside until Convention elects a President *pro tempore*.
- **Rule V.** The President shall call the Convention to order.

**Rule VI.** The President shall present the Order of Business to the Convention for approval.

**Rule VII.** The President shall appoint a Chair of Elections and an Election Committee, including tellers to collect ballots and individuals to count the ballots.

**Rule VIII.** The President shall call on the Standing Committee President who shall announce the nomination of the persons whose names were submitted by the Search Committee, together with the names of nominees submitted by Petition. There shall be no speeches supporting specific nominees during the Convention.

**Rule IX.** The President shall call upon the Chancellor to present an overview of the Rules of Order and the election process, instructing the Electing Convention on how ballots are cast and collected.

**Rule X.** The President shall call upon the Committee on Credentials to determine and announce whether a constitutional quorum in both orders is present, and to identify the number of lay and clergy delegates present, in order to determine the number of votes in each order necessary to constitute a two-thirds majority.

## Rule XI. Ballots

**Section 1.** The President shall call for a ballot by orders. The tellers shall collect the ballots by orders and submit them to the Elections Committee members for counting. The Chair of Elections shall report the results to the President, who shall announce the results.

**Section 2.** The President shall declare an election when a Nominee has received a two-thirds majority of the ballots cast in each order on the same ballot.

**Section 3.** If there is no election after a ballot is taken, the President shall declare time for prayerful reflection to be conducted in a manner determined by the Bishop.

**Section 4.** Prior to each subsequent ballot, the Committee on Credentials shall report to the President any changes in the number of clergy or lay delegates.

**Rule XII.** When there is an election, the President shall notify the Bishop-Elect, and the Chair of the Transition Committee shall notify the other nominees of the results of the election. The Secretary shall provide the Convention with the canonical testimonials of election. The President shall direct the Convention to remain in session until a constitutional majority of the Convention has signed the canonical testimonials.

**Rule XIII**. Except as provided in these rules, the most recent version of Roberts <u>Rules of Order</u> shall govern parliamentary procedure. The Convention officers, including the Parliamentarian, shall continue to serve in those capacities during the Electing Convention. The Electing Convention may suspend any of these rules by an affirmative vote of two-thirds of those present and eligible to vote.

**Rule XIV.** The use of pagers, cell phones, smart phones, texting devices, computers, or any other communication devices or equipment on the floor of the Electing Convention

is prohibited. The use of any such device may subject, upon majority vote of the Convention, the user to be expelled.

**Rule XV.** The date, time and place of consecration of the Bishop-Elect as the Bishop shall be designated by the Presiding Bishop in consultation with the Standing Committee and the Transition Committee. It is anticipated to occur on December 2, 2017 at the Church of the Ascension, Knoxville, Tennessee.

**Rule XVI.** The election and consecration of the Bishop-elect shall be subject to the satisfactory completion of the background and financial investigations and of the medical and psychiatric examinations required by the Constitution & Canons of the Episcopal Church and to the obtaining of the required consents to the election. The election shall be further subject to an agreement being made between the Diocese and the Bishop-elect concerning compensation and other financial matters.

**Rule XVII.** In the event the time provided for the Electing Convention expires without a nominee having been elected, the President of the Convention may recess the Convention to a date certain, anticipated to be July 29, 2017, and/or to a date to be set in the future, or, by vote of a simple majority of the Convention, the President may declare the election to be at an end.

**Rule XVIII**. The Rules of Order adopted at the Thirty-third Convention shall apply to the Electing Convention. However, these Special Convention Rules of Order shall govern any conflict in the Rules of Order and these Rules.

## Minutes

Friday, July 28, 2017 Bishop Election - Convention 2017

## Call to Order

Right Reverend George Dibrell Young, III reconvened the 33<sup>rd</sup> Convention of the Diocese of East Tennessee to order at 9:00 AM on Friday, July 28, 2017 with an opening hymn and prayer.

He thanked Dean Ross, Canon Hackett, Paul Ruff, Patty Dunlap, Molly Davis and all the volunteers from the Cathedral for making this election possible and providing hospitality, expertise and space.

Bishop George asked everyone to turn off their cell phones and remind folks of the rules in regard to electronic or other communication about the election, based on Rule XIV of the Rules of Order:

The use of pagers, cell phones, smart phones, texting devices, computers, or any other communication devices or equipment on the floor of the Electing Convention is prohibited. The use of any such device may subject, upon majority vote of the Convention, the user to be expelled.

Bishop George announced that Vikki Myers would be keeping up with social media and releasing information about the voting after the nominees and the Convention had been notified after each ballot.

## **OVERVIEW OF RULES OF ORDER**

The Bishop called forward Ms. Sarah Sheppeard, Diocesan Chancellor, to review the day's Rules of Order of which all delegates and clergy received a copy. She reminded the delegates that the voting would be by orders, with different color ballots (blue for clergy; green for delegates). Ms. Sheppeard announced that once the balloting began, no one would be admitted into the voting chamber until that ballot was completed. She noted that a  $2/3^{\rm rd}$  majority in both orders was required to elect and voting would continue until that number was reached for both orders in the same ballot.

Ms. Sheppeard reminded the Convention that we do not applaud when the results of the ballots are reported.

## REPORT OF THE COMMITTEE ON CREDENTIALS

Bishop George invited George Arrants and Chris Cone to come forward to the microphone. They reported the number registered as follows:

The Rev. Jay Mills, President, Standing Committee, presented the five nominees for the fifth Bishop of East Tennessee.

## **VOTING INSTRUCTIONS**

Ms. Sheppeard reviewed how to complete the ballots. Bishop George gave an overview of the procedure to be used for each ballot. Each ballot would be followed by a meditation and short prayer led by people of the diocese and then a hymn.

Mr. Chris Cone updated the credentials report. There were now 86 clergy and 142 lay delegates in attendance.

Ms. Sinead Doherty, Church of the Good Samaritan, offered the first meditation.

## REPORT OF THE ELECTIONS COMMITTEE

The results of the first ballot were announced (see tally below). There was no election. Mr. Chris Cone reported that there were now 86 clergy and 142 lay delegates present. The second ballot was cast.

Mr. Sean McEwen, Grace Church, Chattanooga, was called on to give the second meditation.

## REPORT OF THE ELECTIONS COMMITTEE – CONTINUED

Ms. Sheppeard reported that several ballots were incorrectly completed, and therefore, this ballot needed to be recast. The second ballot was recast.

Ms. Beverly Hurley Hill, Diocesan staff person and St. Timothy's, Signal Mountain, then gave the third meditation.

## REPORT OF THE ELECTIONS COMMITTEE - CONTINUED

The bishop announced the results of the corrected second ballot (see tally below). Again, there was no election. Mr. George Arrants reported that there were now 85 clergy and 142 lay delegates present. The third ballot was cast.

The bishop called on the Rev. Jerry Askew, St. Luke's Knoxville, to give the fourth meditation.

## REPORT OF THE ELECTIONS COMMITTEE – CONTINUED

Bishop Young reported on the results of the third ballot ((see tally below). There was not yet an election. Mr. Cone reported that there were now 86 clergy and 142 lay delegates present. Bishop Young reported that The Rev. Canon Frank Ousley had withdrawn his name from consideration. The fourth ballot was cast.

The Rev. Sarai Wender, Church of the Ascension, was called on for fifth meditation.

## REPORT OF THE ELECTIONS COMMITTEE - CONTINUED

Bishop Young reported on the results of the fourth ballot ((see tally below). The bishop again announced that there was not yet an election. Mr. Cone reported that there were now 85 clergy and 141 lay delegates present. Bishop Young reported that The Rev. Canon Frank Logue had withdrawn his name from consideration. The fifth ballot was cast.

Mr. Gordon Davis, of St. Raphael's, Crossville, was called upon for the sixth meditation. As there was ample time, while the Convention waited for results, Ms. Ellon Hilizah, Church of the Good Samaritan, was invited to share the seventh meditation.

## **BREAK**

Bishop George adjourned the session for lunch directing the Delegates to return to the voting chamber by 1:15 PM.

## **CONVENTION RECONVENED**

Bishop George reconvened the election session at :30 PM.

## REPORT OF THE ELECTIONS COMMITTEE – CONTINUED

With the results of the fifth ballot, Bishop Young reported that an election had been achieved. The Rev. Brian Cole was elected as the fifth bishop of the Diocese of East Tennessee and had accepted the invitation to serve. Bishop Young invited the Convention to raise a cheer. A photo was taken of the entire Convention to send to Bishop-elect Brian Cole. Rev. Cole sent a written note of thanks to the Convention for the process and the outcome of the election. The tellers passed out and then collected testimonials signed by the voting delegates.

## **Bio – Kate Campbell**

Singer-songwriter Kate Campbell took up piano at age seven before switching to the guitar as a teenager during the folk-rock heyday of the 70s. Since then, over the course of thirteen albums, she has written, recorded and performed almost exclusively on the acoustic guitar. On 1000 Pound Machine Campbell returns to the instrument of her childhood and enlists Will Kimbrough to produce the eleven-song disc. Campbell's subtle piano and clear vocals are complimented by sparse arrangements featuring Kimbrough's consummate guitar playing and soulful sounds from the legendary Spooner Oldham. Muscle Shoals ace David Hood (electric bass) and Americana stalwarts John Deaderick (keyboards), Dave Jacques (string bass), David Henry (strings), and Paul Griffith (percussion) add to the mix. Emmylou Harris lends haunting harmony on a true narrative about death-row prisoners who find peace through meditation ("Alabama Department of Corrections Meditation Blues") while Sloan Wainwright adds background vocals to "Wait for Another Day." Campbell's southern-flavored tunes weave throughout the album and include a gem that imagines Rosa Parks and George Wallace sitting side by side on a bus ride ("Montgomery to Mobile"), a paean to the Alabama landscape ("Red Clay After Rain"), a tribute to Rock & Roll Hall of Fame inductee Spooner Oldham ("Spoonerville"), and a beloved civil rights anthem ("Walk with Me"). 1000 Pound Machine is Kate Campbell's note of gratitude to piano teachers everywhere who believe that "a simple pair of hands" can inspire and carry the listener to "the music of the spheres."

Since making her recording debut in 1995 with the heart-rending *Songs From The Levee*, singer/songwriter Kate Campbell has since put together a body of work matched only (perhaps) by Emmylou in consistency, Lucinda Williams in terms of pure, wrenching, honest self-examination and self-revelation and no one for its sheer display of broad-based, intimate artfulness. While doing so, she has managed to include the likes of Guy Clark, Emmylou Harris, John Prine, Nanci Griffith, Maura O'Connell, Buddy Miller and the heart of the Muscle Shoals classic soul and R&B hit-making machine as both admirers and collaborators in her distinctly literate musical vision.

Her endearing, clear-water vocal delivery, eloquent gift for storytelling (which has drawn repeated comparisons to such bastions of the Southern writing tradition as Flannery O'Connor, Eudora Welty and William Faulkner) and easy command of a full-range of American music styles, have combined to earn Campbell recognition as a formidable talent by critics, musicians and a discerning public. Kate's sublime *Moonpie Dreams* (1997) and *Visions Of Plenty* (1998) each garnered "Folk Album Of The Year" nominations from the Nashville Music Awards (as well as enthusiastic airplay by folk and Americana stations), while the southern-folk tinged *Rosaryville* (1999) and the gospel flavored *Wandering Strange* (2001) extended the upward-bound arc.

On *Monuments* (2003), Kate's musical vision combined and extended these influences into a sound that is both rootsy and contemporary. *Twang On A Wire* (2003) followed close behind and paid homage to the 1970's Nashville female country singer-songwriters who inspired Kate as a teenager when she began writing songs and playing the guitar. The *Portable Kate Campbell* (2004) and *Sing Me Out* (2004) offered new renditions of Kate's earlier songs albeit with fresh and innovative arrangements. *Blues And Lamentations* (2005) encapsulates the musical under-story heard in all of Kate's music – a form of blues that mines the veins of country, folk, gospel and pop. Campbell returned to Muscle shoals to record the social-gospel tinged *For the Living of These Days* (2006) with Spooner Oldham and followed up with *Save the Day* (2008), a folk-rock styled album produced by Walt Aldridge that was inspired by a Frederick Buechner quote. Kate's long-awaited live album *Two Nights in Texas* (2011) is a collection of crowd favorites that was recorded at Blue Rock Ranch and Studio in Wimberley,

Texas and features Sally Van Meter on dobro, Scott Ainslie on guitar, and Don Porterfield on Bass. Each of Kate's albums is a singular, distinctive and incomparable slice of music from one of the most unique artists recording today.

Campbell has played the prestigious Cambridge Folk Festival (England), Merlefest, Philadelphia Folk Festival, and Port Fairy Folk Festival (Australia), been featured on National Public Radio's Morning Edition, All Things Considered, Live From Mountain Stage, The Bob Edwards Show, and had her story (and haunting song "When Panthers Roamed In Arkansas") included in the debut issue of The Oxford American's ultra-hip Southern Music series. An interview with Kate (along with Mary Chapin-Carpenter, Shawn Colvin, Nanci Griffith and others) also appeared in the fascinating book Solo: Women Singer- Songwriters In Their Own Words.

As the daughter of a Baptist preacher from Sledge, Mississippi, Kate's formative years were spent in the very core of the civil rights movement of the 1960's, and the indelible experiences of those years have shaped her heart, character and convictions ever since. As a child of the South, her musical tastes were forged in the dampered, smoky fires of soul, R&B, Southern rock, country, and folk music. Kate Campbell's music continues to inspire and enthuse a growing audience. Ballet Memphis featured songs from each of Campbell's six CDs as well as a live performance by Kate and band at a ballet entitled South Of Everywhere. Campbell continues to impress audiences across the US and overseas and tours extensively in support of her CDs including tours to the United Kingdom and Ireland.

## ALAN ROXBURGH, BIOGRAPHY

Alan Roxburgh is a pastor, teacher, writer and consultant with more than 30 years experience in church leadership, consulting and seminary education. Alan has pastored congregations in a small town, the suburbs, the re-development of a downtown urban church and the planting of other congregations. He has directed an urban training center and served as a seminary professor and the director of a center for mission and evangelism. Alan teaches as an adjunct professor in seminaries in the USA, Australia and Europe.

Alan consults with these groups in the areas of leadership for missional transformation and innovating missional change across denominational systems. Along with the team at TMN, he provides practical tools and resources for leaders of church systems and local congregations.

When not traveling or writing, Alan enjoys mountain biking, hiking, cooking and hanging out with Jane and their five grandchildren as well as drinking great coffee in the Pacific North West.

## Fran McKendree, Biography

Fran McKendree grew up in rural Connecticut where he began to play guitar and, very reluctantly, sing. In high school, a trio he'd joined won a talent contest, first prize being a slot on a folk music radio show, and he was hooked. He began his professional career playing at coffee houses in and around Syracuse University. Moving to the Glens Falls area of NY he formed "McKendree Spring," a four-piece folk-rock ensemble that the legendary promoter/manager Bill Graham dubbed "one of the best unknown bands in the world." The band recorded seven albums and toured with some of the most exciting artists of the 70's, beginning early in their career with several weeks at NY's famous 'Bitter End.' where they shared the bill with an amazing array of talent - from the Everly Brothers to James Taylor.

McKendree Spring developed a loyal following, spending the next several years touring the US, the UK and Canada, sharing the stage with everyone from the Average White Band to Frank Zappa and the Mothers of Invention. The band played many memorable venues as well, including Carnegie Hall, the Fillmore East, and with the late Billy Preston, the first ever rock concert at Radio City Music Hall. With the [tiny, but hey, nice to be included!] McKendree Spring exhibit in the Rock & Roll Hall of Fame Museum in Cleveland, Ohio is an attribution that says: "Experimental and innovative, McKendree Spring mixed blues, folk and country with a progressive musical vision." The group eventually disbanded in 1975, and each of the members went on to pursue varied careers.

Fran's 'varied career' began by signing the next year to Arista Records and recording with some of the finest session players in the NY/Toronto music scene. He wasn't touring during this time but did play a few memorable events, foremost among them a gig in NY's Central Park with Jimmy Cliff headlining [yes, a bit of a stylistic mismatch, but it sure was fun!]. Fran was, however, finding this an increasingly challenging time in his life.

While walking around his New York City neighborhood one day, looking for inspiration, Fran discovered a small Episcopal church. The next Sunday he and his wife, Diana, went to see what it was all about....finding an engaging, faithful, outreach minded and artistic gathering of seekers. It was a breakthrough for Fran, opening a new spiritual path which led him to heed the call to to take some time for reflection. He and Diana moved to a small town on Cape Cod, where, setting aside his music, he began to work with youth, build houses, and make furniture [remember the 'varied career?'], eventually feeling a deep longing to make music again. Emerging from this soul searching period he began to work under the aegis of the Episcopal church. He has continued to develop and explore his calling; doing concerts, as music leader and coordinator for conferences, keynote presenter, mentor, and workshop leader.

He has released several CDs, as well as producing recordings for other artists at his Teerivane Studios in Hendersonville, NC, where he and Diana now live. Fran continues to be awed by the journey that has unfolded, writing; "My hope is to remain thankful for and receptive to the movement of God in my life, and to do this in a humble, energetic

manner, celebrating our differences and similarities as creatures of God, and remembering always that we are called to actualize our faith in the world around us."

## WORKSHOPS/WORSHIP

Fran's workshops are designed to be engaging, productive, and fun. In the music workshop he covers a wealth of material; finding songs, presenting new material, group dynamics, space considerations, screen projection, and more. They typically begin with a few interactive exercises to help folks get comfortable and to discern what it is the group would most like to spend time doing. The format consists usually of a morning session, with a break for lunch, followed by and afternoon session. Often, if the workshop is on a Saturday, Fran will work with the group to plan and participate in the music for a worship service the next day.

Fran also works more specifically with groups to improve their performance and song leading skills. This process usually will involve some recording of the group. Please contact Nancy Clark for references.

## WORSHIP/LITURGY

Fran has recently designed an evening worship program. The mood, overall, is contemplative; beginning with a few songs sung in community, followed by prayer, readings from Holy Scripture, poems and interspersed with some periods of silence. Images and prayers are projected. Ideally the evening service is either proceeded by or followed with a common meal. Fran typically weaves in a few songs that he performs by himself, but most of the music is sung in community. Whenever possible he enlists the help of a few of the assembly for the poems and readings.
